

RESOLUTION NO. 02-25

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH REP SERVICES INC., FOR PARK EQUIPMENT AND PARTS UTILIZING PALM BEACH COUNTY RFQ #21056/LP; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (the “City”) is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the City requires park equipment and parts; and

WHEREAS, Palm Beach County issued RPQ #21-056/LP to obtain park equipment and parts; and

WHEREAS, in accordance with RPQ #21-056/LP, Palm Beach County entered into an agreement with Rep Services Inc., (“Contractor”); and

WHEREAS, the City desires to obtain these aforementioned goods by utilizing an existing Agreement with Contractor pursuant to Palm Beach County issued RPQ #21-056/LP; and

WHEREAS, in accordance with Section 25 of the City’s Purchasing Policies and Procedures Manual, Piggybacking on State, County, other municipalities, and other government entity bids is permitted within the approval thresholds of the City Manager or City Commission, as applicable in accordance with the purchasing criteria set forth hererin.

WHEREAS, the City desires to enter into an agreement with Contractor, as a Piggyback, to obtain park equipment and parts; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are hereby affirmed and ratified.

Section 2. The City Commission of the City of Delray Beach has reviewed and hereby approves the Agreement between the City and the Contractor, attached hereto and incorporated herein as Exhibit “A”.

Section 3. The City Commission authorizes the City Manager to execute any amendments and take any action necessary to effectuate the intent of this Resolution.

Section 4. This Resolution shall become effective immediately upon adoption.
