THIS AMENDMENT NO. 1 to the Sodium Hypochlorite Purchase & Delivery Term Contract Water / Sewer Agreement dated May 29, 2014 by and between City of Delray Beach, a municipal corporation of the State of Florida (City), and The Dumont Company. WITNESSETH:

**WHEREAS**, on May 29, 2014, City entered into an agreement with Contractor for Sodium Hypochlorite Purchase & Delivery Term Contract Water / Sewer in response to Bid No. 2014-24 ("Agreement"). The term of the Agreement is three (3) years, with the option to renew for two (2) consecutive terms of one (1) year; and

**WHEREAS**, the parties desire to exercise the first option to renew the Agreement for one year; and

**WHEREAS**, the City determines that it is in the best interest of the City to approve this Amendment No. 1 to renew this Agreement to May 28, 2018.

**NOW, THEREFORE**, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.
2. This Amendment No. 1 renews the Agreement, under the same terms and conditions, for the period of May 29, 2017 through May 28, 2018.
3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.

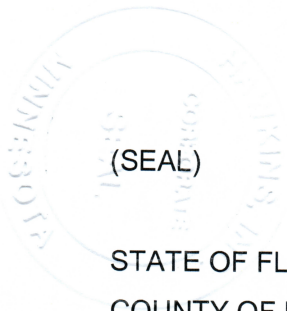
