

**AGREEMENT BETWEEN THE CITY AND ARTIST FOR THE CREATIVE ART  
DELRAY BEACH ARTIST IN RESIDENCY PROJECT**

**THIS AGREEMENT** made this \_\_\_\_ day of \_\_\_\_\_, 20\_\_, by and between the **CITY OF DELRAY BEACH** (hereinafter called **CITY**) and **AGATA REN** (hereinafter called **ARTIST**).

**WITNESSETH:**

WHEREAS, the City, through the Delray Beach Public Art Advisory Board, is sponsoring a city-wide art project known as “Creative Art Delray Beach” (“Project”), the purpose of which is to create signs that feature the word “ART” (“Work”) at locations approved by the City as permanent public artwork; and

WHEREAS, the Delray Beach Public Art Advisory Board issued a Call to Artists on February 2, 2016 for an artist in residence who will work with the City to create the Work. A copy of the Call to Artists is attached hereto as Exhibit “A”; and

WHEREAS, at a public meeting on April 28, 2016, the Delray Beach Public Art Advisory Board selected an artist team of Mark Fuller and Agata Ren to be artist in residence for the Project; and

WHEREAS, a copy of artist team’s proposal, as approved by the Delray Beach Public Art Advisory Board (“Project Proposal”), is attached hereto as Exhibit “B”; and

WHEREAS, the City has determined that the Work is in the best interests of the City and serves a valid public purpose.

**NOW, THEREFORE**, in consideration of the mutual covenants hereinafter set forth, agree as follows:

1. The recitations set forth above are hereby incorporated into this Agreement as if fully set forth herein.

2. The **ARTIST**, as evidenced by the execution of this Agreement, acknowledges that he/she has examined all specifications and requirements of the Call to Artists, attached as Exhibit A. **ARTIST** hereby agrees to create the Work depicted in the Project Proposal, attached as Exhibit B, as further enumerated herein.

3. In accordance with the Call for Artists, City shall pay an Artists Fee to the Artist team of Mark Fuller and Agata Ren in the amount of Twenty Thousand Dollars (\$20,000.00) for artistic services. Payment by the City pursuant to this Agreement shall be made in four installments of Five Thousand Dollars (\$5,000.00), with each payment to be made upon completion of four (4) chairs and upon City’s receipt of an invoice from the **ARTIST** for same, with **ARTIST** to submit the final invoice after the fifteenth and final chair is completed. Payment shall be due within thirty (30) days of receipt of invoice from **ARTIST** for same.

4. In accordance with the Call for Artists, City shall reimburse the **ARTIST** for materials and installation costs in an amount not to exceed \$10,000 (Material Fees). To obtain payment for reimbursement, **ARTIST** shall submit to the **CITY** an original invoice plus one copy together with any other information or documentation which may be reasonably required by City to review and confirm the adequacy of the payment reimbursement request no later than sixty (60) days after the Project has been completed and accepted by the **CITY**. Invoices shall designate the materials obtained. **CITY** shall pay **ARTIST** within thirty (30) calendar days of receipt of **ARTIST'S** proper invoice, and as required by the Florida Prompt Payment Law. To be deemed proper, all invoices must comply with the requirements set forth in this Agreement. Payment may be withheld for failure of **ARTIST** to comply with a term, condition, or requirement of this Agreement.

5. The **ARTIST** shall complete construction of the Work within one year of receiving a written notice to proceed from the **CITY**, unless extended by written agreement.

6. All notices, requests, demands, and other, if given, must be personally delivered or mailed, certified mail, return receipt requested, to the following addresses:

7. The **ARTISTS** shall not, without prior written consent of the **CITY**, assign any portion of its interest under this Agreement and, specifically, the **ARTIST** shall not assign any moneys due or to become due without the prior written consent of the **CITY**.

8. The **CITY** and the **ARTIST** each binds itself, its partners, successors, assigns and legal representatives to the other party hereto in respect to all covenants, conditions and obligations contained in the Agreement.

9. **ARTIST** shall at all times hereafter indemnify, hold harmless and, at the City Attorney's option, defend or pay for an attorney selected by the City Attorney to defend the City, its officers, agents, servants, and employees from and against any and all causes of action, demands, claims, losses, liabilities and expenditures of any kind, including attorney fees, court costs, and expenses, caused or alleged to be caused by any



intentional, negligent, or reckless act of, or omission of, **ARTIST**, its employees, agents, servants, or officers, or accruing, resulting from, or related to the subject matter of this Agreement including, without limitation, any and all claims, losses, liabilities, expenditures, demands or causes of action of any nature whatsoever resulting from injuries or damages sustained by any person or property. In the event any lawsuit or other proceeding is brought against City by reason of any such claim, cause of action, or demand, **ARTIST** shall, upon written notice from City, resist and defend such lawsuit or proceeding by counsel satisfactory to City or, at City's option, pay for an attorney selected by City Attorney to defend the City. The obligations of this section shall survive the expiration or earlier termination of this Agreement. To the extent considered necessary by the Contract Administrator and the City Attorney, any sums due Artist under this Agreement may be retained by City until all of City's claims for indemnification pursuant to this Agreement have been settled or otherwise resolved. Any amount withheld shall not be subject to payment of interest by City.

10. The **CITY** may, in its sole discretion, terminate this Agreement upon 10 days written notice to the **ARTIST**. Upon termination the **ARTIST** shall only retain such funds that have been expended to date. The remaining funds, if any, shall be returned to the **CITY** within 30 days of the termination.

11. **ARTIST** shall provide the **CITY** with a written Bill of Sale conveying title to the **CITY**, and a sworn statement of no liens, claims or other encumbrances. Such documents shall be in a form substantially similar to the form attached as Exhibit "C".

12. The **ARTIST** warrants that the Work shall be free of defects in material and workmanship and that the **ARTIST** shall correct at his/her expense any such defects which appear for a period of one (1) year from delivery of the Bill of Sale for the Work.

13. The **ARTIST** warrants that the Work is an original and that the Work does not infringe upon any copyright.

14. Title to the Work shall vest in the **CITY** upon completion of the Work. The **CITY** may reproduce images of the Work, for non-commercial use, including but not limited to public information, educational and promotional purposes without written consent of the **ARTIST**.

15. The **ARTIST** retains (1) copyright of designs created (2) all rights to the Artists Rights Act of 1990, and any successor act, except that the **ARTIST** hereby waives the rights under 17 U.S.C. 106A, and (3) all rights expressly granted in this Agreement.

16. The **ARTIST** hereby acknowledges that the Work will become an integral part to the streetscape and that installation and integration of the artwork may subject the artwork to future removal, destruction, or other modifications by reason of its removal from the structure or the renovation, destruction or redevelopment of the structure. Notwithstanding the foregoing, the **ARTIST** hereby consents to the incorporation of the

artwork into the streetscape and waives any rights in the artwork granted by 17 U.S.C. 106A, Visual Artists Rights Act of 1990.

17. **ARTIST's** rights, including but not limited to all copyrights, if applicable, under this Agreement are not assignable and shall cease with **ARTIST's** death and do not extend to **ARTIST's** heirs, successors or assigns. **CITY's** rights and obligations under this Agreement may be assigned without the consent of **ARTIST** at any time, without prior notice to **ARTIST**.

18. **ARTIST** shall notify the **CITY** of any permanent change of address from that stated in Paragraph 6 hereof, and the failure of **ARTIST** to do so shall be deemed a waiver by **ARTIST** of **ARTIST's** rights to enforce those provisions of this Agreement that require the express approval of **ARTIST**.

19. **ARTIST** shall provide certificates of insurance to the City evidencing its insurance coverage and naming the City as an additional insured. Such insurance shall be in an amount and form that is acceptable to the City and shall be delivered to the City prior to execution of this Agreement. If **ARTIST** fails to provide the certificates of insurances in a form acceptable to the City, the City may immediately terminate this Agreement.

20. This Agreement shall be considered null and void unless signed by both the **ARTIST** and the **CITY**.

21. This Agreement shall be governed by the laws of the State of Florida as now and thereafter in force. The venue for actions arising out of this agreement shall be Palm Beach County, Florida.

22. This Agreement and the documents attached hereto constitute the entire agreement between the **CITY** and the **ARTIST** and may only be altered, amended or repealed by a duly executed written instrument.

23. Force Majeure. **CITY** shall not be responsible for its failure to make the premises available or to provide the facilities and services described herein, where such performance is rendered impossible and impractical due to strikes, walk-outs, acts of God, inability to obtain labor, materials or services, government restriction (other than City), enemy action, civil commotion, fire, unavoidable casualty, utility disruptions or blackouts, or similar causes or any other causes beyond the control of **CITY**.

24. Inspector General. **ARTIST** is aware that the Inspector General of Palm Beach County has the authority to investigate and audit matters relating to the negotiation and performance of this contract, and may demand and obtain records and testimony from **ARTIST** and its subcontractors and lower tier subcontractors. **ARTIST** understands and agrees that in addition to all other remedies and consequences provided by law, the failure of **ARTIST** or its subcontractor or lower tier subcontractors to fully



cooperate with the Inspector General when requested may be deemed by the City to be a material breach of this Agreement justifying its termination.

25. Public Records. **ARTIST** shall comply with all public records laws in accordance with Chapter 119, Florida Statutes. In accordance with state law, **ARTIST** agrees to:

- a. Keep and maintain all records that ordinarily and necessarily would be required by the City.
- b. Provide the public with access to public records on the same terms and conditions that the City would provide for the records and at a cost that does not exceed the costs provided in Chapter 119, Florida Statutes, or as otherwise provided by law.
- c. Ensure that public records that are exempt or confidential and exempt from public records disclosure are not disclosed except as authorized by law.
- d. Meet all requirements for retaining public records and transfer, at no cost, to the City all records in possession of Artist at the termination of the contract and destroy any public records that are exempt or confidential and exempt from public records disclosure requirements. All records stored electronically must be provided to the City in a format that is compatible with the information technology systems of the City. All records shall be transferred to the City prior to final payment being made to Artist.
- e. If Artist does not comply with this section, the City shall enforce the contract provisions in accordance with the contract and may unilaterally cancel this contract in accordance with state law.

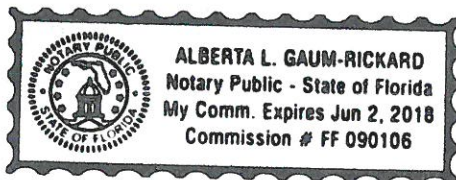

## Creative ART Delray Beach Project Proposal

### Artist Team Mark Fuller and Agata Ren

#### Letter of interest

The basis of my interest for this project is to create 15 signs of art, each one unique and inspired by a different city stakeholder but all of those signs with a cohesive design. And my interest is to engage the public about public art.

The design for the signs I'm proposing would look like a chair. All the chairs would have the same form but yet various designs since each one would be inspired by a different Delray Beach city stakeholder and what the city stakeholder loves about Delray Beach and in general. For example: color/form/beach/dogs/kids/palm trees/birds/parks/pineapples/Atlantic Avenue.

#### The public is supposed to be engaged about public art.

The idea is basically for people to be attracted by the tall and colorful design, to sit on the chair and take selfie's or photos. Placed on the chairs would be hashtags like #DelrayBeachPublicArt for people to tag those art sign photos on social media. Each chair would be numbered, for example 1/15, so people could do something like a scavenger hunt throughout the city making photos with each one of those signs.

#### Specifications

The form of the chair could be either straight (2.5 ft wide) or wavy (2 ft wide) which would be inspired by the wavy form of the Gateway sculptures in Delray Beach. The word ART would be cut out on the top of the sign to add the environment into the art piece and to help with occurring windflow in Florida.

The production of the chairs would be done by Mark Fuller. The Art-Sign-Chairs would be 8 feet tall and 2 feet wide. 0.125" or 0.375" aluminum back panel, 2"x2" aluminum posts, .375" aluminum seat; polyester powdercoat finish. They would be painted by me with durable high-quality outdoor paint. Some could be printed digitally by Mark Fuller after supplying him design creation for the chair.

The city of Delray Beach would be responsible for installation and lighting if desired.

## *Mark Fuller / MTFuller*

---

Mark Fuller (MTFuller) is an environmental graphic and industrial designer, and has been participating in the Public Art forum since 1992. He is a creator of dynamic site specific exterior public art installations for a wide variety of projects, and has been established in West Palm Beach, Florida since 1986. In his early years as a professional designer he served as Director of Graphics for a large urban planning firm before relocating to New York City as Senior Project Designer for world-renowned Lance Wyman of Lance Wyman, Ltd. ([lancewyman.com](http://lancewyman.com)) where he honed his design skills to a world-class level and gained invaluable experiences with top-shelf national and international clients and projects. His industrial design experience includes wayfinding systems, urban street furniture such as seating elements, bollards, lighting fixtures, tree grates, and information kiosks.

While the style of Mark's work is not characterized by a specific 'look'; it is highly stylized by his research into the unique function, architecture, environmental and cultural aspects that surround each project. As a result, the visual characteristics of Fuller's installations flex and change with an appropriate sensitivity for the project at hand. His works are site-specific, and typically laced with symbolic or abstract references that link the art solidly to its environment.

His projects have been referenced by a spokesperson for the National Endowment For The Arts as "a perfect example of what public art can be". His Art In Public Places installations have included kinetic constructions, compression-tension cable structures, and static free-standing elements. Recent works have explored the use of cutting edge high-technology and dichroic coatings. His installations have included solar-generated electric power, LED luminaries, and the recycling of various glass waste materials. With an interest to promote "green" and low carbon footprint ideology, Mark continues to move forward developing appropriate eco-conscious fabrication methods and techniques .

His immediate accessibility to, and experience with high-tech fabrication methods and finishing technology allow him to effectively determine appropriate production methods to accommodate budget, schedule, and function requirements. His projects often incorporate diverse fabrication methods, specialized epoxy-polyester hybrid coatings, and aero-space quality precision metal fabrications. With a 68,000 square foot production facility to provide him with state-of-the-art industrial lasers, water-jet cutting, CNC computerized machining, robotic welding, robotic brakes, Amada punch presses, powdercoating, and large format image reproduction, his ability to streamline the creative process from concept to reality is unequalled.

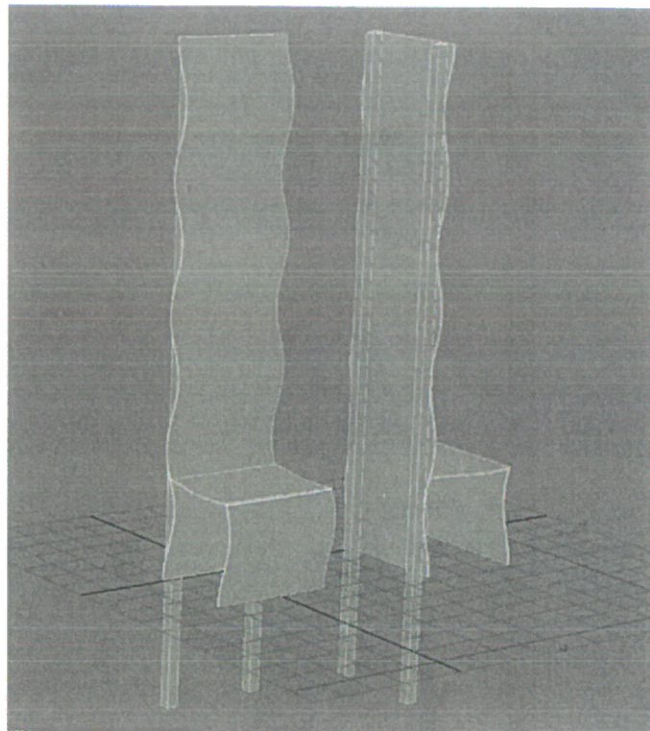


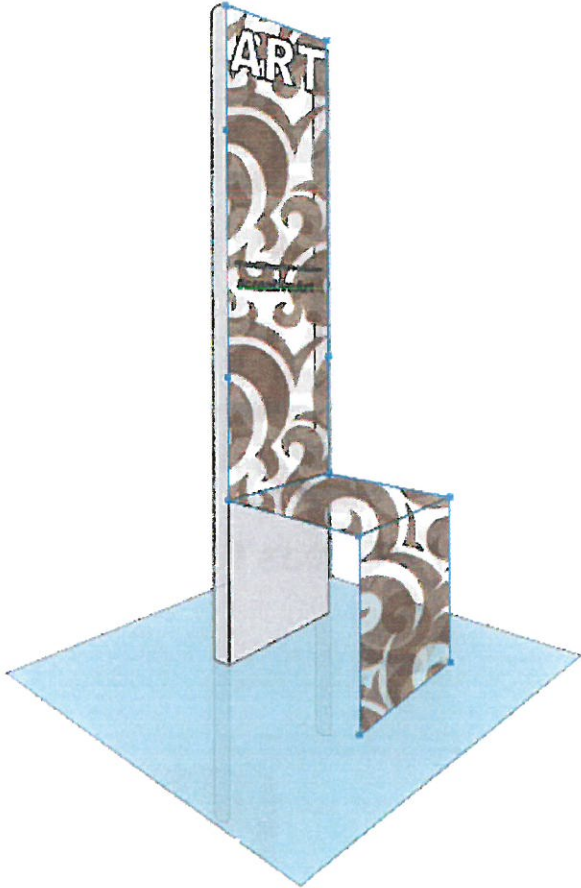
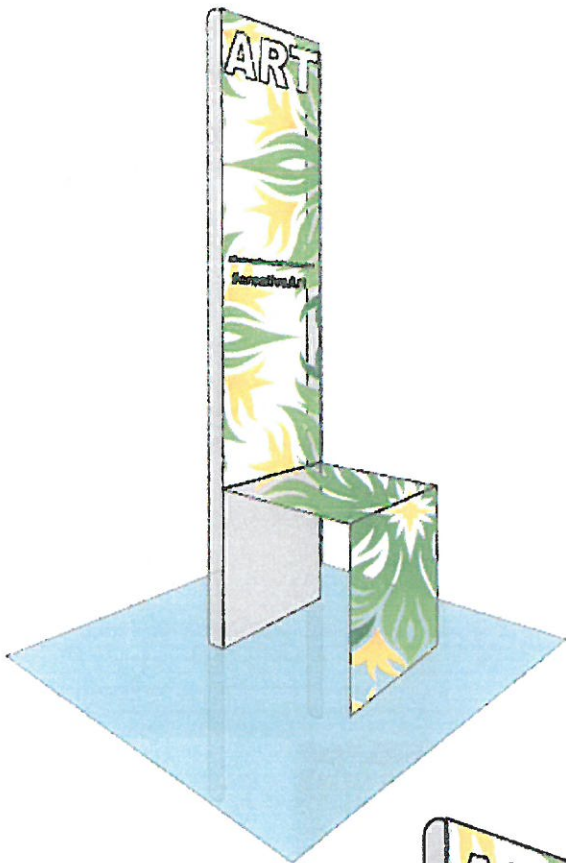
