# TITLE: Veterans Park Renovations Delray Beach, Florida

This Service Authorization, when executed, shall be incorporated in and shall become an integral part of the Contract, dated March, 2012 between the City of Delray Beach and Walters Zackria Associates, PLLC

## I. PROJECT DESCRIPTION

City of Delray Beach would like to renovate or replace the Existing Community Center Building located at the City of Delray Veterans Park, 802 NE 1st St, Delray Beach, FL 33483. Scope of work will include:

- 1. Partial or full building demolition
- 2. New Community Center or an addition

# II. SCOPE OF SERVICES

The following scope of services is developed in accordance with the Standard Agreement for Architectural Services.

#### Task 1 - Material Review and Needs Assessment

WZA shall review available material provided by City, including site survey(s), previous studies and technical and environmental reports, existing building plans, community center current and future staffing plans, programs, classes, and growth projections.

Consultant will interview the appropriate City staff to gather current and future needs regarding the Facility. Consultant will provide to the City a draft Needs Assessment Summary to City staff reporting findings and present the analysis, opportunities, constraints and potential program. The City will review and provide comments on the draft Needs Assessment Summary, and the Consultant shall address City comments and produce a final Needs Assessment Summary.

Deliverables: The Consultant shall provide a draft Needs Assessment Summary and a final Needs Assessment Summary.

## **Task 2 - Building Program**

Based on the Needs Assessment Summary, the Consultant will prepare a building program. Program will convert the City's needs into building areas with approximate spatial size, adjacency relationships, equipment requirements, occupancy requirements, and programmatic considerations,

etc. The Consultant shall provide a draft building program report to the City. The City will review and provide comments on the draft report, and the Consultant shall address City comments and produce a final building program report.

Deliverables: The Consultant shall provide a draft building program report and a final building program report.

## Task 3 – Conceptual Building Plan

Based on the final building program report, Consultant will prepare a draft conceptual building plan illustrating a layout for the proposed Facility. WZA will present the conceptual layout to City staff for discussion. The City will review and provide comments on the draft conceptual building plan, and the Consultant shall address City comments and produce a final a final conceptual building plan.

Deliverables: The Consultant shall provide a (1) draft conceptual building plan and (1) final conceptual building plan.

## Task 4 – Conceptual Site Plan

In conjunction with the conceptual building plan, Consultant will prepare a conceptual site plan illustrating a layout for the proposed buildings and circulation walkways. WZA will present the conceptual site plan to City staff for discussion. The City will review and provide comments on the draft conceptual site plan, and the Consultant shall address City comments and produce final site conceptual plan.

Deliverables: The Consultant shall provide (1) draft conceptual site plan and (1) final conceptual site plan.

## Task 5 – Colored Building and Site Plan, Renderings

Consultant will provide colored floor plans, site plan, and renderings in preparation for the Commission Presentation.

## Task 6 - Commission Presentation

Consultant will prepare a PowerPoint presentation and present the project to the City Commission.

### Task 7 – Statement of Probable Cost

Consultant shall prepare an estimate of probable cost for the project and submit with the conceptual plan set. Cost estimate will be based on internal firm database. Services of outside cost estimating consultant are not included in the scope.

### **Design Exclusions:**

Design Development Document Preparation, Construction Document Preparation, Permitting, Bidding, and Construction Phase Services are excluded from the scope of this Service Authorization.

Evaluation of the existing seawall is being perform by the City and is excluded from the scope. The existing lift station has already been upgraded and any required future upgrades are excluded from the scope.

- 2. Provide any available existing building and site utility drawings.
- 3. City will pay for all permit fees.

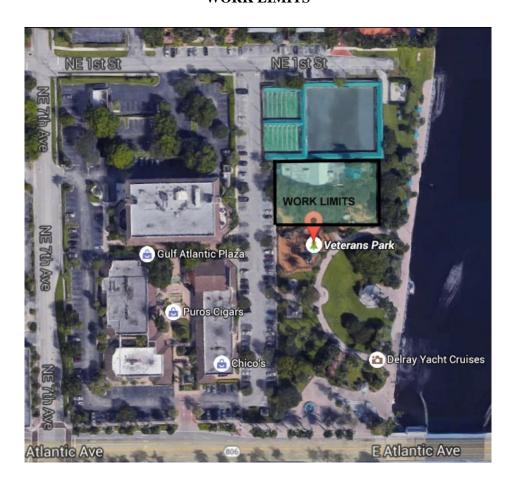
