

RESOLUTION NO. 60-25

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH SBL FREIGHTLINER, LLC DBA LOU BACHRODT FREIGHTLINER, AS AN APPROVED SOLE SOURCE, TO PURCHASE FREIGHTLINER ORIGINAL EQUIPMENT MANUFACTURER PARTS AND RELATED SERVICES; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (the “City”) is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the City utilizes vehicles manufactured by Daimler Trucks North America, LLC (“Daimler”); and

WHEREAS, Daimler qualifies and designates specific dealers within different regions throughout the United States for the sale of factory-authorized services and parts; and

WHEREAS, Freightliner original equipment manufacturer (“OEM”) parts related services are provided exclusively in Florida through SBL Freightliner, LLC. dba Lou Bachrodt Freightliner (“Contractor”); and

WHEREAS, in order to preserve the warranties on the Freightliner vehicles, the City must use Freightliner OEM parts and related services to maintain and service its Freightliner vehicles; and

WHEREAS, on March 11, 2025, in accordance with Section 38 of the City’s Purchasing Policies and Procedures Manual, the Contractor was approved as a Sole Source pursuant to the Memorandum attached hereto and incorporated herein as Exhibit “A”; and

WHEREAS, the City desires to enter into an agreement with the Contractor, as a Sole Source, to obtain Freightliner OEM parts and related services; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are hereby affirmed and ratified.

Section 2. The City Commission of the City of Delray Beach has reviewed and hereby approves the Agreement between the City and Contractor, attached hereto and incorporated herein as Exhibit “B”.

Section 3. The City Commission authorizes the City Manager to execute any amendments thereto and take any and all actions necessary to effectuate the intent of this Resolution.

Section 4. This Resolution shall become effective immediately upon adoption.
