Mr. Michaels Confirmed he has been sworn in.

Steven Michael, Property owner, introduced himself to the Board. Mr. Michael shared a slide presentation of the industrial mural locations and designs enclosures for the Andrea Design District referring some of the designs to the Wynwood Art Design District wishing to bring Cultural inspiration to the public area.

Ms. Howald presented additional details on the five (5) existing murals. The mural (Façade 2A, 2B,2C,2D,2E) west of building 1876 located at 1876 Dr. Andre's Way. Ms. Howald gave a brief overview of the history of the Design District to the PAAB, indicating that the current owner purchased the building, and murals were painted without primer approvals. At the current time of purchase, murals were not permitted in the MROC Zoning District. In the year 2022, there was an active code violation that required all murals to go through the process to get approvals from the Public Art Advisory Board, and LDR amendment to expand the zoning districts to allow murals with the MROC. In April of 2024, the first set of 36 murals that are onsite, came before the Board, approving (2) murals on building 1876 and one (1) mural on1874.
