A RESOLUTION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH W.W. GRAINGER, INC., FOR THE PURCHASE OF MAINTENANCE, REPAIR, AND OPERATIONS SUPPLIES, PARTS, EQUIPMENT, AND MATERIALS UTILIZING CITY OF TUCSON, AZ REQUEST FOR PROPOSAL 240078; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS AND/OR RENEWALS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THIS AGREEMENT; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach ("City") is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the City requires maintenance, repair, and operations supplies, parts, equipment, and materials for the City; and

WHEREAS, the City of Tucson, AZ, in partnership with OMNIA Partners' Cooperative Purchasing Program to allow the solicitation to be available to other public agencies, issued Request for Proposal 240078 to obtain maintenance repair and operations supplies, parts, equipment and materials; and

WHEREAS, in accordance with Request for Proposal 240078, City of Tucson, AZ entered into an agreement with W. W. Grainger, Inc. ("Contractor"); and

WHEREAS, as a member of OMNIA Partners' Cooperative Purchasing Program, the City desires to obtain these aforementioned goods by utilizing an existing Agreement with the City of Tucson, AZ and Contractor pursuant to Request for Proposal 240078; and

WHEREAS, in accordance with Section 46 of the City's Purchasing Policies and Procedures Manual, the City shall have the authority to join with other units of government in cooperative purchasing plans when the best interests of the City would be serve

WHEREAS, the City desires to enter into an agreement with Contractor, through a cooperative purchasing agreement,to obtain maintenance, repair, and operations supplies, parts, equipment and materials; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.
