

RESOLUTION NO. 01-18

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, PROVIDING FOR THE ABANDONMENT OF AN APPROXIMATELY FORTY-FIVE (45') FOOT WIDE PORTION OF NW 1ST STREET RIGHT-OF-WAY ADJACENT TO THE PALM-TRAN SATELLITE FACILITY, AS DEEDED TO CITY OF DELRAY BEACH BY RIGHT-OF-WAY COUNTY DEED AT OFFICIAL RECORDS BOOK ("ORB") 10044, PAGE 585 AND CORRECTIVE QUITCLAIM DEED RECORDED AT ORB 8891, PAGE 570, BOTH DEEDS BEING RECORDED IN THE PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA, AND AS MORE PARTICULARLY DESCRIBED IN EXHIBIT "A"; PROVIDING FOR CONFORMANCE WITH ABANDONMENT PROCEDURES SET FORTH IN THE CITY OF DELRAY BEACH CODE OF ORDINANCES; FURTHER PROVIDING FOR APPROVAL OF THE EXECUTION BY THE MAYOR OF A QUIT CLAIM DEED FOR PURPOSES OF CONVEYING TO PALM BEACH COUNTY THE PORTION OF ABANDONED RIGHT-OF-WAY IN ORDER TO INCLUDE THE ABANDONED RIGHT-OF-WAY AREA WITHIN A PROPOSED PLAT FOR THE EXPANSION AND REDEVELOPMENT OF THE PALM-TRAN SITE; PROVIDING DIRECTIONS TO THE CLERK; PROVIDING FOR EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach, Florida received an application for abandonment of a portion of right-of-way reservation lying with the proposed plat of the redeveloped Palm-Tran facility (the "Plat") and as more particularly described in Exhibit "A"; and

WHEREAS, certain portions of right-of-way requested for abandonment are owned by City of Delray Beach by way of a *County Deed* recorded at ORB 10044, Page 585 along with a Corrective Quitclaim Deed recorded at 8891, page 570, both in the Public Records of Palm Beach County; and the City of Delray Beach has determined that there is not now, nor will be in the future, any use of this right-of-way for public purposes, with such finding being required by the City's Comprehensive Plan at Policy A-6.3 of the Transportation Element and Sec. 2.4.6(M) of the Land Development Regulations of the City of Delray Beach; and

WHEREAS, the subject portion of right-of-way will be included within the area platted for the redeveloped Palm-Tran facility which proposes to incorporate a northern and southern parcel into one platted area such that a right-of-way will no longer separate the two parcels after approval of the abandonment of the City's interest in this portion of right-of-way; and

WHEREAS, the City Commission of the City of Delray Beach supports the abandonment of right-of-way by the City, thus enabling the return of these lands entirely to Palm Beach County for public purposes,

other than for a use as a right-of-way, in order that this portion of right-of-way may be incorporated into their Palm-Tran facility site.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the forgoing recitals are hereby incorporated herein by this reference and are approved and adopted.

Section 2. That pursuant to Policy A-6.3 of the Transportation Element and Sec. 2.4.6(M) of the Land Development Regulations of the City of Delray Beach, the City hereby determines that said lands are not being used now, nor will be used in the future, for Public Purposes of the City and thus agrees to vacate and abandon such rights and interests it might hold, if any, to the following portion of right-of way lying adjacent to the Palm Beach County Palm-Tran Satellite Facility, as more particularly described as follows:

See Exhibit "A" attached hereto

Section 3. The City Clerk, or designee, is directed to send a certified copy of this Resolution to Ben Williamson, Project Manager, Facilities Development & Operations Dept., Property & Real Estate Management Division, 2633 Vista Parkway, WPB, FL 33411-5605; and to ensure that a certified copy of this Resolution is recorded in the Public Records for Palm Beach County, Florida.

Section 4. The City Commission also approves the conveyance of this abandonment area to Palm Beach County via a Quit Claim deed; and hereby authorizes the Mayor to execute the Quit Claim deed, a copy of which is attached to this resolution as Exhibit "B", and directs the City Clerk to effectuate this conveyance as is deemed necessary in order to accomplish this purpose.

Section 5. This Resolution shall be effective immediately upon adoption.




