I am nominating DETECTIVE GARY FERRERI for the city employee of the month. Detective Ferreri is currently assigned to the Criminal Investigations Division at the police department. He is assigned crime against person cases (i.e. robbery, homicide, sexual assault, death investigations, etc.). This assignment alone keeps him busy throughout his daily shift. Outside the scope of his normal duties, Detective Ferreri demonstrates on a daily basis how caring and giving he is to his community. He never hesitates to assist a city employee or local family when the opportunity arises.

Over the past month Detective Ferreri coordinated plans for a "field trip" with Ms. Clemmons, who is the director of the Boys and Girls club, to visit the police department with the children that are members of this facility. When Ms. Clemmons heard of this proposal, without hesitation, she jumped at the opportunity for her kids to be involved with the police department.

On April 13, 2016, Detective Ferreri facilitated a tour of the police department with approximately 70 children from the Boys and Girls club. The children/students from Village Academy ranged from ages 8-17 enjoyed several hours learning about the police department and the things that we do every day. The children began their day in the police department training room where they met Chief Jeffrey Goldman and other members of his staff. Detective Ferreri enlisted the assistance of over 20 policed officers, with different ranks and assignments to assist with the tour. After being greeted, they were promptly "sworn in" and issued a decal badge as honorary members of the agency. The class was broken up into smaller groups and escorted through the building including the dispatch center, holding facility and special areas of the station. They went outside where they could explore, see and touch the equipment, vehicles and specialty items our police officers use each day. The children particularly enjoyed the SWAT truck and the dive equipment which they were able to put some of this equipment on. As they went from station to station, they were eventually treated to Snow cones! The energy and delight the children displayed was wonderful. They had an eye opening experience which connected to their local police department. Although this was learning experience, by design, it was fun experience that each child could make special in their own way.

I believe that Detective Ferreri should be considered for this monthly award for his enthusiasm and dedication toward his community. He touched the hearts and minds of the children that are an integral part of our community both now and in the future.
