A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH INTERNATIONAL DATA BASE CORP. DBA BIDNET, UTILIZING AN APPROVED CITY STANDARD FOR E-PROCUREMENT SOFTWARE SERVICES; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS AND/OR RENEWALS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach ("City") is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the City requires e-procurement software services; and

WHEREAS, the City performed research regarding the ease of use and reliability of International Data Base Corp.'s dba Bidnet ("Contractor") services and other similar services from different vendors, and, based on that research, approved Contractor's products as the City Standard; and

WHEREAS, in 2024, Contractor acquired Periscope S2G which the City had been utilizing since 2017 and contains the City's current vendor database; and

WHEREAS, on October 9, 2025, in accordance with Section 38 of the City's Purchasing Policies and Procedures Manual, the Contractor was approved as a City Standard for a period of five (5) years pursuant to the Memorandum attached hereto and incorporated herein as Exhibit "A"; and

WHEREAS, the City desires to procure the aforementioned services from Contractor utilizing the City Standard procurement method; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

- Section 1. The foregoing recitals are hereby affirmed and ratified.
- <u>Section 2.</u> The City Commission of the City of Delray Beach has reviewed and hereby approves this Agreement between the City and Contractor, which is attached to this Resolution as Exhibit "A".
- <u>Section 3.</u> The City Commission authorizes the City Manager to execute any amendments and/or renewals and take any and all actions necessary to effectuate this Resolution.
