Alexia Howald, Senior Planner, read application (File Nos. 2025-121, 2025-122, 2025-123, 2025-124, 2025-125, 2025-126, 2025-127, 2025-128, 2025-129, 2025-130, 2025-131, 2025-132, 2025-133) into the record.

Steve Michael (Presenter) on behalf of JMS Boynton Beach, LLC., 909 McCleary Street, Delray Beach, FL 33483. Mr. Michael confirmed he had been sworn in.

Mr. Michael introduced himself to the Board. Mr. Michael shared a slide presentation regarding the 13 murals on Building 1878.
