RESOLUTION NO. 191-23

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AUTHORIZING A SPECIAL EVENT SPONSORSHIP IN AN AMOUNT NOT TO EXCEED \$3,000 FOR THE SPECIAL EVENT KNOWN AS THE DELRAY BEACH BED RACE; AUTHORIZING THE CITY MANAGER TO TAKE ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE, AND FOR OTHER PURPOSES.

WHEREAS, the City Commission desires to sponsor special events in the City of Delray Beach that provide a public purpose in alignment with the City's Special Events Policy; and

WHEREAS, the City of Delray Beach, Florida received a Special Event Sponsorship Request from Delray Concours Foundation (the "Applicant") requesting the City to sponsor the Delray Beach Bed Race (the "Special Event") to be held on October 7, 2023 on SE 2nd Ave between SE 1st and SE 2nd Streets; and

WHEREAS, the Applicant has requested a waiver of all costs related to the provision of City services for the event minus any direct costs to the City, currently estimated at \$2,325.10; and

WHEREAS, the Applicant provided a Statement of Public Purpose, attached hereto and incorporated herein as Exhibit "A", which anticipates a profit in the amount of a \$2,922 to be donated to the Achievement Center and \$2,922 to be donated to the Delray Fire Benevolent, Delray Beach-based, non-profit organizations; and

WHEREAS, the City Commission has reviewed the submitted Special Event Sponsorship Request application and considered whether the Special Event will provide a public purpose that is in alignment with the Special Events Policy.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> The above recitals are incorporated as if fully set forth herein.

Section 2. The City Commission has considered the request for sponsorship and finds that the Delray Beach Bed Race to be held on October 7, 2023, provides a public benefit consistent with the City's Special Event Policy.

<u>Section 3.</u> The City Commission approves the request for sponsorship submitted by Delray Concours Foundation in an amount not to exceed \$3,000.

<u>Section 4.</u> The City Commission authorizes the City Manager to execute an agreement consistent with the approval herein and to take any and all actions necessary to effectuate the intent of this Resolution.

<u>Section 5.</u> This Resolution shall take effect immediately upon its adoption.
