Laura Simon, Executive Director of the Downtown Development Authority (DDA), and Suzanne Boyd, Marketing Director, presented their recommendations for new logos to rebrand the Old School Square Complex.

During the presentation, Ms. Simon emphasized the importance of a public voting campaign, allowing the community to play a vital role in selecting a design that reflects the shared history of the communities' vibrant culture and vision for the future. She stated their goal was to create a branded house that honors the past while establishing a foundation for the next 100

years. Once the submissions are collected, the public would have the opportunity to vote on the final logo, promoting community engagement. The artist whose design received the most votes would be selected as the winner. Ms. Simon also mentioned the proposed timeline was expected to be 18-20 weeks from the reveal.

The Commission expressed their excitement and support for the new concepts introduced by the DDA.

Kent Edwards, Sustainability Officer, introduced Evan Orellana, Chairman of the Green Implementation Advancement Board.

Mr. Orellana presented the year in review for 2024 and explained the ongoing and future priorities of the City's Climate Action Plan (CAP) that the Commission approved on July 20, 2023 and March 27, 2025.

Jim Chard, member of the "Delray Beach Consortium," provided an update on the status of Florida's coral reefs, and discussed potential plans/strategies to prevent further deterioration of these vital ecosystems through the modular artificial reef systems.

Mr. Chard asked for the Commission's support with regulatory organizations, permitting, and communication through public relations. The Commission discussed involving the City as a leader in this initiative.

Vice Mayor Casale recognized the program's significance, as the beach serves as an economic driver for the city. She proposed that a grant from the Sustainability Department could support some of the program's initiatives.

Deputy Vice Mayor Long mentioned collaborating with the County on this matter.

Mayor Carney advised the County had rejected this project twice due to the type of materials that were being utilized. He suggested putting the outplantings on a future agenda.

Jason Bregman, Singer Studios, Art and Design in Delray, discussed the financial advantages of using funds from the Beach Renourishment Fund, to construct a regenerative coastal barrier that would protect the beach from storms.

Leneita Fix, Reef Institute in Delray, highlighted the Institute's achievements in reef restoration to date.

The Commission expressed their gratitude to Jim Chard, Leneita Fix, and Jason Bregman for their hard work and dedication to this important cause.

Requested additional assistance from Code Enforcement for her neighborhood and more paved roads.

John Kazanjian, President, South Florida Police Benevolent Association and the Palm Beach County Benevolent Association.

Expressed his frustration regarding delays in contract negotiations with the

City. He pointed out that Delray Beach ranks second lowest in pension benefits for police officers. He stated if Delray Beach continues to offer the lowest benefits, the City will keep losing police officers to other cities.

Faye Weisberg, 870 Bond Way, Delray Beach

Discussed the big box homes being built around her property and how they obstruct her privacy in the modest home she has lived in for 19 years.

Pamela Williams, 245 NW 8 Avenue, Delray Beach

Discussed the violence occurring in the city and suggested it may be due to the lack of a fully staffed Police Department.

Laura Simon, Executive Director of the Downtown Development Authority, Expressed her gratitude to Marissa Delgado, Cultural Arts Director for DDA, for bringing talented artists to Old School Square. She also thanked City staff for their hard work behind the scenes.

Andrea Bruton, 703 Place Tavant, Delray Beach

Expressed her concern about the proper compensation for the Police department's work. Additionally, she mentioned the 2025 Let's Move Initiative.

Debra Walker, 1312 NW 2 Street, Delray Beach

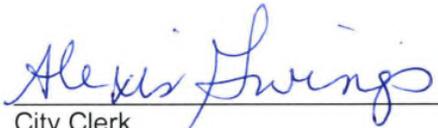
