

RESOLUTION NO. 59-25

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH DOBBS EQUIPMENT, LLC, AS AN APPROVED SOLE SOURCE, TO PURCHASE JOHN DEERE CONSTRUCTION & FORESTRY COMPANY ORIGINAL EQUIPMENT MANUFACTURER PARTS AND REPAIR SERVICES; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (the “City”) is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the City utilizes construction equipment manufactured by John Deere Construction & Forestry Company (“John Deere”); and

WHEREAS, John Deere qualifies and designates specific dealers within different regions throughout the United States for the sale of factory-authorized services and parts; and

WHEREAS, in order to preserve any warranties on the construction equipment, the City must use original equipment manufacturer (“OEM”) parts to maintain and service its Construction equipment; and

WHEREAS, OEM parts and repair services are provided exclusively in Florida through Dobbs Equipment, LLC (“Contractor”); and

WHEREAS, on March 11, 2025, in accordance with Section 38 of the City’s Purchasing Policies and Procedures Manual the Contractor was approved as a Sole Source pursuant to the Memorandum attached hereto and incorporated herein as Exhibit “A”; and

WHEREAS, the City desires to enter into an agreement with the Contractor, as a Sole Source, to obtain OEM parts and repair services (the “Agreement”); and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are hereby affirmed and ratified.

Section 2. The City Commission of the City of Delray Beach has reviewed and hereby approves the Agreement between the City and Contractor, attached hereto and incorporated herein as Exhibit “B”.

Section 3. The City Commission authorizes the City Manager to execute any amendments thereto and take any and all actions necessary to effectuate the intent of this Resolution.

Section 4. This Resolution shall become effective immediately upon adoption.
