

RESOLUTION NO. 13-25

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH ADVANCE STORES COMPANY, INC., DBA ADVANCE AUTO PARTS FOR AUTOMOTIVE PARTS, FLUIDS, EQUIPMENT, AND MAINTENANCE SERVICES UTILIZING BUYBOARD PROPOSAL NO. 715-23; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (the "City") is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the City requires automotive parts, fluids, equipment, and maintenance services; and

WHEREAS, Buyboard administers a Cooperative Purchasing Program wherein it issues a solicitation for a multitude of products and services and enables its members to review available contracts and make purchases of awarded commodities and services; and

WHEREAS, contracts solicited by Buyboard are accessible to local government entities that are members of the Cooperative and eligible to purchase through a government purchasing cooperative or interlocal contract; and

WHEREAS, the City is a member of the Buyboard Cooperative and authorized to enter agreements pursuant to Buyboard solicitations; and

WHEREAS, Buyboard issued Proposal No. 715-23 to procure vendor price discounts for automotive parts, fluids, equipment, and maintenance services; and

WHEREAAS, the City desires to obtain automotive parts, fluids, equipment, and maintenance services from Contractor utilizing the terms and conditions of Buyboard Proposal No. 715-23; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are hereby affirmed and ratified.

Section 2. The City Commission of the City of Delray Beach has reviewed and hereby approves the Agreement between the City and the Contractor, attached hereto and incorporated herein as Exhibit "A".

Section 3. The City Commission authorizes the City Manager to execute any amendments and/or renewals and take any and all actions necessary to effectuate the intent of this Resolution.

Section 4. This Resolution shall become effective immediately upon adoption.
