# FISCAL YEAR 2024-2025 FUNDING INCENTIVE PROGRAMS SUMMARY

At the September 24, 2024, CRA Board meeting, the CRA Board approved the budget for Fiscal Year 2024-2025 that included \$500,000 for CRA Grant Funding Assistance and \$600,000 for the Curb Appeal Residential Improvement Program.

# Site Development Funding Assistance Program

 Jerk & Lime at Nicole's House, LLC (doing business as Nicole's House) (182 NW 5 Avenue, CRA Sub-Area #3)

A <u>\$68,416</u> award was approved on January 24, 2023. Reimbursements totaling \$51,312 have been made (\$17,104 is withheld until project completion). The grantee was granted an extension due to delays in delivery of certain materials to February 29, 2024. At the time of the grant termination date, a CO was not received and the \$17,104 was not disbursed. This tenant is currently in breach of the Lease for failure to tender rental payments in a timely manner. As of January 1, 2025, the sum of \$18,338.11 is past due. At the January 28, 2025 CRA Board meeting we are requesting approval to terminate the lease.

On September 24, 2024, CRA Board approved an extension to the termination date to October 31, 2024, and increased the award amount to \$39,671.25. A ribbon cutting was held on December 11, 2024.
