The City of Delray Beach, Florida ("City") is seeking Proposals from qualified firms for professional engineering and architectural design services relating to construction of a **New Police Department Headquarters**, including a multi-level parking structure, in accordance with the terms, conditions, and specifications contained in this Request for Qualifications.

All Proposers are advised to closely examine the solicitation package. The City of Delray Beach is exempt from Federal and State Taxes for tangible personal property tax.

The City of Delray Beach reserves the right to accept or reject any or all Proposals, in whole or in part, with or without cause, to waive any irregularities and/or technicalities, and to award the contract on such coverage and terms it deems will best serve the interests of the City.

SECTION 1: PROJECT OVERVIEW

- 1.1.** The City of Delray Beach (“City”) is soliciting Proposals from qualified firms for the provision of professional services relating to the design of a **New Police Department Headquarters**, including a multi-level parking structure. This project will be funded by a Public Safety General Obligation Bond, approved in a referendum by voters during the March 2023 municipal elections.

The services required may include, but not be limited to, the development of space needs, full construction documents and specifications including a full site development plan, permitting, and demolition of all existing structures (the radio tower may have the possibility of remaining at its present location or need to be redesigned to another area on the site). The City intends to utilize a Construction Manager at Risk (CMAR) as the delivery method of construction. A CMAR firm will be engaged for both Pre-Construction Services (Phase 1) and Construction Services (Phase 2).

- 1.2.** The Method of Award for this Solicitation will be to the Proposer with the highest ranking or scores with whom the City is able to negotiate an acceptable Agreement. The City will enter negotiations with the firm receiving the highest-ranking proposal score. Should negotiations fail then the City will enter negotiations with the next highest-ranking firm.
- 1.3.** The City intends to contract with a single firm for the project listed in this procurement. The Proposer will provide the following services: (1) updates to a 2018 Needs Assessment (2) field survey & geotechnical services; (3) preparation of plans and specifications; (4) public outreach; (5) bid & award services; and (6) post-design services.

SECTION 2: SPECIAL TERMS AND CONDITIONS

2.1. PURPOSE

The purpose of this Request for Qualifications (RFQ) is to solicit Proposals from qualified firms and consultants who can provide professional engineering and architectural design of a **New Police Department Headquarters**, including a multi-level parking structure.

The City expects each Proposer to clearly outline its best and most comprehensive resources in its response, because all services and responsibilities identified in this Solicitation may be awarded to the selected Proposer.

2.2. ELIGIBILITY

To be eligible to respond to this RFQ and be considered for award, the Proposer must demonstrate to the satisfaction of the City that it or the principals assigned to the project has successfully provided services, similar in scope and complexity, to a municipality, quasi-governmental organization, or a private organization.

2.3. SEPARATION OF SERVICES

The entity(ies) performing design and construction engineering services and/or owner's representative services may not be the same entity for this Project. Vendors, solely providing geotechnical and/or surveying services for the design are exempt from this provision.

2.4. RECORDS, ACCOUNTS, AND STATEMENTS

The successful Proposer shall keep on its premises, or such other place approved by the City, current true, accurate, and complete records and accounts of all services provided to the City and shall give the City or City's representative access during reasonable business hours and upon three (3) business days' notice to examine and audit such records and accounts. Such records shall be maintained at such standard to allow a certified auditor the ability to properly examine the records in order to certify a statement of the successful Proposer's business with the City.

2.5. GENERAL STANDARDS

The successful Proposer shall at all times comply with all rules, regulations, and other governmental agencies having jurisdiction. The successful proposal shall further take all precautions and extreme care to conduct its activities in a safe, professional, and prudent manner with respect to its agents, employees, members, visitors, and participants.

2.6. DEFAULT

In the event the successful Proposer defaults in the performance of the contract, the city shall have the following options:

- 2.6.1. The City Manager will give the successful Proposer thirty (30) days' written notice of default. If the problem is not resolved within the thirty (30) days, the City may immediately terminate the contract upon providing written notice of the Proposer's failure to timely cure the default and obtain the services elsewhere.

2.6.2. The City may recover at law any all claims that may be due to the City from the successful Proposer.

2.6.3. The City may perform such work as it deems necessary to cure the default or subsequent default and charge the successful Proposer for the full cost of labor and materials expended, plus thirty percent (30%) of the cost for administrative overhead.

The acceptance of all or part of monies due for any period after a default shall not deemed as a waiver of any of these options, or a waiver of the default or subsequent default of the same or any other term, covenant, and condition.

The successful Proposer agrees that the City shall not be responsible or have any liability whatsoever for any alleged damages, claim of lost profits, or otherwise in the event the City declares the successful Proposer in default hereunder.

2.7. INSURANCE

The selected Proposer shall not commence any performance pursuant to the terms of this RFQ until certification or proof of insurance has been received and approved by the City's Risk Coordinator or designee.

The required insurance coverage is to be issued by an insurance company authorized, licensed, and registered to do business in the State of Florida, with the minimum rating of A- VII or better, in accordance with the latest edition of A.M. Best's Insurance Guide. This insurance shall be documented in certificates of insurance which provides that the City of Delray Beach shall be notified at least thirty (30) days in advance of cancellation, non-renewal, or adverse change. The receipt of certificates or other documentation of insurance or policies or copies of policies by the City or by any of its representatives, which indicate less coverage than is required, does not constitute a waiver of the selected Proposer's obligation to fulfill the insurance requirements herein. Deductibles must be acceptable to the City of Delray Beach.

The selected Proposer must submit a current Certificate of Insurance, naming the City of Delray Beach, their employees and officers as additional insured and listed as such on the insurance certificate, no later than ten (10) days after award and prior to commencement of any work. New certificates of insurance are to be provided to the City upon expiration. All renewal or replacement certificates of insurance shall be forwarded to the City Purchasing and Contract Administration Division located at 100 NW 1st Ave., Delray Beach, FL 33444.

The selected Proposer shall provide insurance coverage as follows:

2.7.1. **WORKERS COMPENSATION** – With statutory limits, the City reserves the right not to accept exemptions to the Workers Compensation requirements of this Solicitation.

2.7.2. **EMPLOYER'S LIABILITY** – With a limit of not less than One Hundred Thousand Dollars (\$100,000) for each accident, One Hundred Thousand Dollars (\$100,000) for each occurrence, and Five Hundred Thousand Dollars (\$500,000) for the aggregate.

- 2.7.3. **COMPREHENSIVE GENERAL LIABILITY** – With limits of not less than One Million Dollars (\$1,000,000) per occurrence and Two Million Dollars (\$2,000,000) in the aggregate for Bodily Injury and Property Damage.

NOTE – If Comprehensive General Liability limits are less than One Million Dollars (\$1,000,000), the sum of Comprehensive General Liability limits and Excess Liability limits must equal no less than One Million Dollars (\$1,000,000).

The Comprehensive General Liability insurance policy must include coverage that is not more restrictive than the latest edition of the Comprehensive General Liability Policy, without restrictive endorsements, as filed by the Insurance Services Offices, and the policy must include coverage's for premises and/or operations, independent contractors, products and/or completed operations for contracts, contractual liability, broad form contractual coverage, broad form property damage, products, completed operations, and personal injury. Personal injury coverage shall include coverage that has the Employee and Contractual Exclusions removed.

- 2.7.4. **AUTOMOBILE LIABILITY** – Covering all vehicles associated with Proposer's operations to include all owned, non-owned and hired vehicles. The coverage will be written on an occurrence basis with limits of liability not less than One Million Dollars (\$1,000,000) combined single limit per each occurrence.

- 2.7.5. **PROFESSIONAL LIABILITY** – With limits of not less than One Million Dollars (\$1,000,000) per occurrence.

2.8. PERFORMANCE BOND/LETTER OF CREDIT

2.9. LICENSES AND CERTIFICATIONS

Any Proposer which submits an offer in response to this Solicitation shall, at the time of such offer, hold all the required licenses, permits, and certifications issued by the State or County Examining Board qualifying the Proposer to perform the services described in this Solicitation.

The City may at its option, and in its best interest, allow the Proposer to supply any missing information on certification and licensing during the Proposal Evaluation period.

Proposer must be licensed by the Florida Department of Business & Professions Regulation as an engineering firm. Provide a screenshot or copy of Proposer's license from the Florida Department of Business & Professions Regulation that confirms Proposer has a current license in the category type of engineering.

Proposer should be pre-qualified by FDOT to perform professional service at the time of submittal as outline in section 5.2.3. Minimum Qualifications.

2.10. METHOD OF PAYMENT – MONTHLY INVOICES

The selected Proposer shall submit an invoice to the City, each month, after the services have been performed and have been received and accepted by the City. The amount charged shall not be in excess of the rates and fees agreed to in the Agreement.

The date of the invoices shall not exceed thirty (30) calendar days from the performance of the work. Under no circumstances shall the invoice be submitted to the City in advance of the performance of the work.

The invoice shall contain the following basic information: the selected Proposer's name and address, invoice number, date of invoice, description of the service performed, the contract number, purchase order number, and any discounts.

The City prides itself on paying its vendors promptly and efficiently, and as such requires that vendors accept payment via wire transfer, ACH (direct deposit), or an appropriate electronic payment method. The City is averse to issuing paper checks and seeks to discontinue this practice. All payments shall be made in accordance with the Florida Prompt Payment Act, Section 218.74, Florida Statutes, upon presentation of a proper invoice by the awarded Proposer.

2.11. SUBCONTRACTING

As part of its Proposal, the Proposer must identify any and all subcontractors that will be used in the performance of the proposed work, their capabilities and experience, and the portion of the work to be done by the subcontractor. The competency of the subcontractor(s) with respect to experience, skill, responsibility, and business standing shall be considered by the City when making the award in the best interest of the City. If the Proposer fails to identify any and all subcontractors in the Proposal, the Proposer may be allowed to submit this documentation if such action is in the best interest of the City.

2.12. OTHER FORMS OR DOCUMENTS

If the City is required by the selected Proposer to complete and execute any other forms or documents in relation to this Solicitation, the terms, conditions, and requirements in this Solicitation shall take precedence to any and all conflicting or modifying terms, conditions or requirements of the selected Proposer's forms or documents.

2.13. MODIFICATION OF SERVICES

The City reserves the right to delete or modify any portion of the contracted services at any time without cause, and if such right is exercised by the City, the rates and fees shall be reduced at the same ratio as the estimated costs of the services deleted relates to the estimated costs of the service originally contracted. If service has already been provided on the portion of the work to be deleted, the selected Proposer will be paid for the deleted portion based on the estimated percentage of the completion of such portion.

If the selected Proposer and the City agree on modifications or revisions to the service elements, after the City has approved performance of a particular task or project, and a budget has been established for that task or project, the selected Proposer shall submit a revised budget to the City for approval prior to proceeding with the task or project.

SECTION 3: SCOPE OF SERVICES

3.1. PROJECT HISTORY AND BACKGROUND

The current Delray Beach Police Department Headquarters is located at 300 West Atlantic Avenue in the City of Delray Beach Florida 33444. Construction of the facility was completed in 1987 and currently houses most of the police staff and activities. The existing 41,100 square feet facility at 300 West Atlantic Avenue was constructed on approximately 4.1 acres with 187 parking spaces. The City's population was approximately 48,000 when the facility was constructed and today the City's population is approximately 68,000 with 233 police personnel. There is another facility located at 2350 Seacrest Boulevard that is leased from the Palm Beach County School Board and is used for training purposes.

On March 14, 2023, the citizens of the City of Delray Beach approved a \$100 million-dollar bond referendum to build a new state-of-the-art Police Headquarters and multi-level parking structure.

The new Police Department Headquarters should consider a 20-year future needs assessment and is anticipated to be approximately 110,000 square feet in total size, with a multi-level parking structure for approximately 365 vehicles. This new facility will be constructed on the same site as the existing facility and the current police headquarters **must** remain in use throughout construction. Demolition of the current police headquarters is part of this project scope.

The new facility must be CAT 5 hurricane rated and include all features including (but not limited to): dispatch, office space, gun range, interview/polygraph booths, training rooms, community room, property and evidence storage, quartermaster, Real Time Crime Center (RTCC), holding cells equipped with a processing area (including a sally port), administration, gym / physical agility, roll call, full kitchen, conference space, all associated support areas such as IT, Maintenance, etc.; a multi-level parking structure equipped with a high first floor (including electrical power outlets to store and charge larger vehicles), flagpoles, an officer memorial at the front entrance, glass cases to display historical artifacts, fueling station (detached structure), fleet maintenance (detached structure), and a public safety radio tower.

3.2. SUMMARY OF WORK

The selected Proposer (hereinafter in this Scope referred to as Consultant) shall provide civil engineering and architectural design services to design a **New Police Department Headquarters**, including a multi-level parking structure. The Consultant will prepare project implementation documents including plans, specifications, permits, and project cost estimates in accordance with Florida Department of Transportation (FDOT) and Palm Beach County Health Department (PBCHD) requirements and City policies, procedures, standards, and requirements for the construction of a new police department headquarters, including a multi-level parking structure.

The services required may include, but not be limited to, the development of space needs, full construction documents and specifications including a full site development plan, permitting, and demolition of all existing structures (the radio tower may have the possibility of remaining at its present location or need to be redesigned to another area on the site).

A preliminary construction cost for the project is estimated to be between 80 and 85 million dollars (inclusive of furniture, fixtures, and equipment). The final construction cost may differ due to actual program requirements, other project costs and/or circumstances.

3.3. ENGINEERING & ARCHITECTURAL DESIGN SERVICES

The Consultant shall provide engineering and architectural design services including all necessary documents, conferences, presentations and presentation materials required by the City. A detailed scope of work will be developed during negotiation of the professional services agreement between the City and the selected Consultant.

The selected Consultant will be required to inspect the building sites, test for soil bearing capability, and advise the City on the most effective way to implement the overall project in terms of time and budget requirement.

In addition, the Consultant will need to develop a detailed project schedule, detailed cost estimate at each phase of design, and provide value engineering to ensure that the project budget is maintained at each phase.

The City is anticipating that the overall project schedule would not exceed:

- Design Phase – Approximately 15 to 18 months
- Construction Phase – Approximately 24 months

The City intends to utilize Construction Manager at Risk (CMAR) as the delivery method of construction. A CMAR contractor will be engaged for both Pre-Construction Services (Phase 1) and Construction Services (Phase 2). The selected Consultant, working with the CMAR during their Phase 1 (Pre-Construction Services), will also develop work plans, schedules and budgets, coordinate project design, provide value engineering when required, attend and address meetings with city officials, neighborhood groups, and private citizens concerning the project, maintain conventional and electronic files (database) of all documentation and correspondence relating to the project. If required by the project schedule, the selected Consultant as part of this solicitation may be requested to work with the CMAR contractor to develop early construction release packages.

- 3.3.1. Anticipated services may consist of, but are not limited to the following:
- 3.3.1.1. Coordinate the preparation of construction documents, including, but not limited to, spacing needs, engineering calculations, drawings, and plans for mechanical details such as plumbing, ventilation, fire suppression, IT infrastructure, and lighting features.
 - 3.3.1.2. Review of existing Palm Beach County, City of Delray Beach pertinent Codes, Resolutions and Ordinances and State of Florida Building Codes, and incorporating the above data into complete construction documents including final construction plans, technical specifications, construction estimates, and related documents necessary for the construction of the project.
 - 3.3.1.3. Obtaining all Federal, State, and local permits or approvals (including Palm Beach County water, sewer and environmental approvals) and all Building permits necessary for the construction of the project. The Consultant team may also be required to provide consulting services to the City on various matters which do not result in drawings, specifications or construction documents.
 - 3.3.1.4. Prepare and submit signed and sealed construction drawings to the City of Delray Beach Development Services Department, Building Division, and any other applicable agencies for review, and make any revisions required for the issuance of building and/or site development permits.
 - 3.3.1.5. Subconsultants' scopes may include, but are not limited to, Structural Engineering, Civil Engineering, Geotechnical Engineering, Landscape Architecture, Site Lighting and Survey Services, Planning, Plat, MEP Engineering and Low Voltage design including A/V, CCTV, access management, voice/data, emergency and cell phone in building signal boosters.
 - 3.3.1.6. Inspect project site and test for soil bearing capacity.
 - 3.3.1.7. Prepare all design and specifications with sustainability and long-term life cycle analysis practices and guidelines. LEED certification will not be a requirement of the project; however, the city will require that a LEED scorecard at each phase of design be submitted to be used as a guide on implementation of sustainable elements.
 - 3.3.1.8. Provide coordination, oversight and review of CMAR contractor's pre-construction services and subsequent Guaranteed Maximum Price (GMP) for construction.
 - 3.3.1.9. Provide a detailed final cost estimate for the aspects of the project for which the Consultant team is responsible. This will be used to reconcile the design professional cost estimate and the CMAR cost estimate.
 - 3.3.1.10. Provide public outreach including a website and other public information activities.
 - 3.3.1.11. The Consultant team must be able to start this project immediately upon a "Notice

to Proceed” by the City and prioritize this project throughout its entirety.

3.3.1.12. Value engineering shall be performed to ensure that the project budget is maintained at each phase.

3.3.1.13. Develop options for relocation of the radio tower.

3.3.1.14. The Police Headquarters and multi-level parking structure must be CAT 5 Hurricane rated and the level of security must meet Commission for Florida Law Enforcement Accreditation Inc. (CFA), Criminal Justice Information Services (CJIS), and Florida Department of Law Enforcement (FDLE) standards for accreditation.

3.3.1.15. Lead Consultants interested in the Request for Qualifications (RFQ) must indicate any subconsultants which would be part of their team.

3.3.1.16. The selected Consultant team may also need to confer with City staff, during the planning and design phases, in the preparation of structural plans for the building and parking structure, make recommendations and suggestions as to the materials, construction, and necessary adjustments in architectural design to fit structural requirements.

3.4. PROJECT DESIGN

Consultant shall provide services for the preparation of design and Proposal documents for construction of this project as part of the Capital Improvement Plan (CIP). Design services are for the development of design drawings for redevelopment of the entire site located at 300 West Atlantic Avenue which will include a new Police Department Headquarters and associated parking structure, communication facilities, roadway, utility, ADA accessibility, landscape and lighting improvements.

Professional Services and design drawings shall account for the following, but are not limited to:

- 3.4.1. The City is seeking a Consultant team to undertake the design, engineering, architecture, and coordinate with a CMAR contractor for a new Police Department Headquarters and associated parking structure.
- 3.4.2. **The existing facility must be kept operational throughout construction of the new facility.** The Consultant may need to include design criteria for some off-site rental facilities during redevelopment of the property.
- 3.4.3. The 2018 Needs Assessment study determined that the Police Department requires approximately three times the square footage currently available within the existing building to accommodate everyone at one facility for the next 20 years. One major challenge with the future design includes the accommodation of an existing communications tower and design/development of new communications facilities within the new facility and parking structure.
- 3.4.4. All systems and structures (including any new communications facilities) shall be designed to the Essential Facility Florida Building Code Standards (latest edition) and shall meet or exceed all hurricane hazard safety criteria as set forth by Florida Building Code (Latest Edition).
- 3.4.5. The design must be consistent with the architectural style of the surrounding neighborhood (approved by Planning and Zoning Department) and meet sustainability standards established for LEED certification (Certification NOT Required).
- 3.4.6. This is a unique facility and requires careful design and safety considerations in utilizing the existing spaces during the construction phase of the project as well as the prospect of utilizing temporary parking facilities with Palm Beach County South County Judicial Center (200 West Atlantic Avenue).
- 3.4.7. In the design of a new multi-level parking structure, there shall be a minimum of 365 secure parking spaces. Access controls to the secured parking spaces is a critical site planning consideration. The parking structure design shall consider future shared use with the City's

Fire Department and their large vehicles.

- 3.4.8. Emergency generator and fuel storage shall be incorporated into the design to accommodate a seven-day operation under full load.
- 3.4.9. Consultant shall investigate if the existing utilities need to be upgraded for the new facility: water, sewer, fiber optic communications, solar electric, and reuse for the site. Stormwater management will also be required. The Consultant shall work with South Florida Water Management District to determine the best approach for stormwater management. The cost for all system improvements will be part of the overall project.
- 3.4.10. The Consultant will be continuously responsible for project safety and quality control, as well as other activities necessary to construct the project. The Consultant shall employ an independent Community Engagement Specialist or Firm to assist with communication between the project team, City Staff, City Commission, and the community. Communications shall include coordination and information transfer via public meetings, live surveys, telephone, email, newsprints, and pamphlets. The Consultant shall provide the project with a dedicated telephone number and email address. The Community Engagement Specialist or Firm shall update the City's Website accounts as required and shall coordinate updates with the City's Public Information Office.

3.5. ADDITIONAL GENERAL PROJECT TASKS

- 3.5.1. **Community Outreach** – Throughout the duration of the project, the Consultant shall be responsible for notifying all property owners, schools, tenants, and residents about potential impacts associated with the project.
- 3.5.2. **Notifications** – Consultant shall prepare and mail flyers, and/or letters and door hangers to the residents, tenants, and owners. Information to be provided shall include the proposed project scope, limits, schedule, and the anticipated impacts of the construction to residents (e.g. detours, street closures, utility interruptions, etc.). Contact information shall also be included with the notification. Notifications shall be in accordance with City policies.
- 3.5.3. **Mailing List Preparation** – The Consultant shall identify all impacted property and commercial owners and residents. The Consultant shall prepare a mailing list of all such entities and shall update the mailing list as needed throughout the duration of the project.
- 3.5.4. **Public Input Records** – The Consultant shall maintain a database of comments and concerns brought forth by the public and keep records of responses made by Consultant and/or City staff.
- 3.5.5. **Inter-Agency Coordination** – The Consultant shall directly coordinate with outside agencies and municipalities for all permits necessary during design. The Consultant shall coordinate the project design, with outside municipalities and agencies, including, but not limited to, the South Florida Water Management District (SFWMD), Lake Worth Drainage District (LWDD), FPL and FDOT.

- 3.5.6. **Website** – The Consultant shall establish an independent webpage to be from the City’s website for continual public outreach, including updates and questions up to award of a construction contract.
- 3.5.7. **Recordkeeping** – The Consultant shall keep a record of all correspondence between the Consultant and the City, private utility companies, other governmental agencies, residents, etc. The Consultant shall provide meeting minutes or notes to the City no later than seven (7) business days after a meeting.

6.4 ORAL PRESENTATIONS/INTERVIEWS

Upon initial completion of the criteria evaluation indicated above, rating and ranking, the Evaluation Committee may choose to conduct an oral presentation with the Proposers which the Evaluation Committee deems to warrant further consideration based on, among other considerations, scores in clusters and/or maintaining competition. Upon completion of the oral presentation(s), the Evaluation/ Selection Committee will perform a final evaluation, rating, and ranking of the Proposals.

In such circumstances, the initial ranking of the Proposers shall be considered a preliminary ranking only.

6.5 NEGOTIATIONS

If the City and the Proposer(s) cannot reach an agreement on a contract, the City reserves the right to terminate negotiations and may, at the City Manager's or designee's discretion, begin negotiations with the next highest-ranked Proposer(s). This process may continue until a contract acceptable to the City has been executed or all Proposals are rejected. No Proposer shall have any rights against the City arising from such negotiations or termination thereof.

1. DEFINITIONS

- a. *Proposal: any offer(s) submitted in response to this Request for Qualifications.*
- b. *Proposer: person or firm submitting a response to this Request for Qualifications.*
- c. *Solicitation or Request for Qualifications: this Solicitation documentation, including any and all addenda.*
- d. *Proposal Submittal forms: describes the goods or services to be purchased and must be completed and submitted with the Proposal.*
- e. *City: shall refer to the City of Delray Beach, Florida.*
- f. *Contract or Agreement: Request for Qualifications, all addenda issued thereto, all affidavits, the signed agreement, and all related documents that comprise the totality of the contract or agreement between the City and the Proposer.*
- g. *Contractor: selected Proposer that is awarded a contract to provide the goods or services to the City.*
- h. *Purchasing and Contract Administration Division: Purchasing and Contract Administration Division of the City of Delray Beach, Florida.*
- i. *Responsible Proposer: Proposer that has the capability in all respects to perform in full the contract requirements, as stated in the Request for Qualifications, and the integrity and reliability that will assure good-faith performance.*
- j. *Responsive Proposer: Proposer whose Proposal conforms in all material respects to the terms and conditions included in the Request for Qualifications.*

2. CONE OF SILENCE

Pursuant to Section 2-355 of the Palm Beach County Ordinance No. 2011-039, and the purchasing policies of the City of Delray Beach, all Solicitations, once advertised and until the appropriate authority has approved an award recommendation, are under the "Cone of Silence". This limits and requires documentation of

communications between potential Proposers and/or Proposers on City Solicitations, the City's professional staff, and the City Council members.

3. ADDENDUM

The Purchasing and Contract Administration Division may issue an addendum in response to any inquiry received, prior to the due date for Proposals, which changes, adds, or clarifies the terms, provisions, or requirements of the Solicitation. The Proposer should not rely on any representation, statement, or explanation, whether written or verbal, other than those made in the Solicitation document or in the addenda issued. Where there appears to be a conflict between the Solicitation and any addenda, the last addendum issued shall prevail. It is the Proposer's responsibility to ensure receipt of all addenda and any accompanying documentation. The Proposer is required to submit with its Proposal a signed "Acknowledgment of Addenda" form, when any addenda have been issued.

4. LEGAL REQUIREMENTS

This Solicitation is subject to all legal requirements contained in the applicable City Ordinances and Resolutions, as well as all applicable City, State, and Federal Statutes. Where conflict exists between this Solicitation and these legal requirements, the authority shall prevail in the following order: Federal, State, and local.

5. CHANGE OF PROPOSAL

Prior to the scheduled due date for Proposals, a Proposer may change its Proposal by submitting a new Proposal (as indicated on the cover page) with a letter on the firm's letterhead, signed by an authorized agent stating that the new Proposal replaces the original Proposal. The new submittal shall contain the letter and all information as required for submitting the original Proposal. No changes to a Proposal will be accepted after Proposals have been opened.

6. **WITHDRAWAL OF PROPOSAL**

A Proposal shall be irrevocable unless the Proposal is withdrawn as provided herein. The City shall be the sole judge of its best interest.*

No guarantee is expressed or implied as to quantities or dollars that will be used during the contract period. 16. **NON-EXCLUSIVITY**

It is the intent of the City to enter into an agreement with the selected Proposer that will satisfy its needs as described herein. However, the City reserves the right as deemed in its best interest to perform, or cause to be performed, the work and services, or any portion thereof, herein

17. CONTINUATION OF WORK

Any work that commences prior to and will extend beyond the expiration date of the current contract period shall, unless terminated by mutual written agreement between the City and the selected Proposer, continue until completion at the same prices, terms, and conditions.

18. PROTEST

a. A recommendation for contract award or rejection of award may be protested by a Proposer. The Proposer may file a written protest with the City Clerk's office. The Proposer shall file its written protest with the City Clerk, Monday through Friday, between the hours of 8:00 a.m. and 5:00 p.m., excluding legal holidays. c. The letter of protest shall be accompanied by a non-refundable protest application fee in an amount equal to one percent (1%) of the

A Proposer recommended for award as the result of a competitive Solicitation for any City purchase of supplies, materials, and services (including professional services, other than professional architectural, engineering, and other services subject to Sec. 287.055 Florida Stats.), purchase, lease, permit, concession, or management agreement shall, within five (5) business days of the filing of such recommendation, submit an affidavit under the penalty of perjury, on a form provided by the City stating either that the contractor is not related to any of the other parties proposing in the competitive Solicitation or identifying all related parties; and attesting that the Proposal is genuine and not a sham or collusive or made in the interest or on behalf of any person not therein named, and that the Proposer has not, directly or indirectly, induced or solicited any other Proposer to put in a sham Proposal, or any other person, firm, or

corporation to refrain from proposing, and that the Proposer has not in any manner sought by collusion to secure to the Proposer an advantage over any other Proposer. The City, at its sole discretion, reserves the right to terminate any contract entered into pursuant to this Request for Qualifications (RFQ) with or without cause immediately upon providing written notice to the selected Proposer. Upon receipt of such notice, the selected Proposer shall not incur any additional costs under the contract. The City shall be liable only for reasonable costs incurred by the selected Proposer prior to the date of the notice of termination. The City shall be the sole judge of "reasonable costs."

29. **TERMINATION FOR DEFAULT**

The City reserves the right to terminate this contract, in part or in whole, or place the vendor on probation in the event the selected Proposer fails to perform in accordance with the terms and conditions stated herein by providing written notice of such failure or default and by specifying a reasonable time period within which the selected Proposer must cure any such failure to perform or default. If the selected Proposer fails to cure the default within the time specified, the City may then terminate the subject contract by providing written notice to the selected Proposer. The City further reserves the right to suspend or debar the

selected Proposer in accordance with the appropriate City ordinances, resolutions, and/or policies. The vendor will be notified by letter of the City's intent to terminate. In the event of termination for default, the City may procure the required goods and/or services from any source and use any method deemed in its best interest. All re-procurement costs shall be borne by the incumbent Proposer

30. **FRAUD AND MISREPRESENTATION**

Any individual, corporation, or other entity that attempts to meet its contractual obligations with the City through fraud, misrepresentation, or material misstatement, may be debarred for up to five (5) years. The City, as a further sanction, may terminate or cancel any other contracts with such individual, corporation, or entity. Such individual or entity shall be responsible for all direct or indirect costs associated with termination or cancellation, including attorney's fees.

31. **ACCESS AND AUDIT OF RECORDS**

The City reserves the right to require the selected Proposer to submit to an audit by an auditor of the City's choosing at the selected Proposer's expense. The selected Proposer shall provide access to all of its records, which relate directly or indirectly to this contract, at its place of business during regular business hours. The selected Proposer shall retain all records pertaining to this contract, and upon request, make them available to the City for three (3) years following expiration of the contract. The selected Proposer agrees to provide such assistance as may be necessary to facilitate the review or audit by the City to ensure compliance with applicable accounting and financial standards.

32. **OFFICE OF THE INSPECTOR GENERAL**

Palm Beach County has established the Office of the Inspector General, which is authorized and empowered to review past, present, and proposed County programs, contracts, transactions, accounts and records. The Inspector General (IG) has the power to subpoena witnesses, administer

oaths, require the production of records, and monitor existing projects and programs. The Inspector General may, on a random basis, perform audits on all City contracts.

33. **PRE-AWARD INSPECTION**

The City may conduct a pre-award inspection of the Proposer's premises or hold a pre-award qualification hearing to determine if the Proposer is capable of performing the requirements of this Solicitation.

34. **PROPRIETARY/CONFIDENTIAL INFORMATION**

Proposers are hereby notified that all information submitted as part of, or in support of, Proposal submittals will be available for public inspection after the opening of Proposals in compliance with Chapter 119 of the Florida Statutes; popularly known as the "Public Record Law." The Proposer shall not submit any information in response to this Solicitation that Proposer considers a trade secret, proprietary, or confidential. The submission of any information to the City in connection with this Solicitation shall be deemed conclusively to be a waiver of any trade secret or other protection that would otherwise be available to the Proposer. In the event that the Proposer submits information to the City in violation of this restriction, either inadvertently or intentionally, and clearly identifies that information in the Proposal as protected or confidential, the City may, in its sole discretion, either (a) communicate with the Proposer in writing in an effort to obtain the Proposer's withdrawal of the confidentiality restriction, or (b) endeavor to redact and return that information to the Proposer as quickly as possible, and if appropriate, evaluate the balance of the Proposal. The redaction or return of information pursuant to this clause may render a Proposal non-responsive.

35. **HEALTH INSURANCE PORTABILITY AND ACCOUNTABILITY ACT (HIPAA)**

Any person or entity that performs or assists the City of Delray Beach with a function or activity involving the use or disclosure of "individually

identifiable health information (IIHI) and/or Protected Health Information (PHI) shall comply with the Health Insurance Portability and Accountability Act (HIPAA) of 1996. HIPAA mandates for privacy, security, and electronic transfer standards include, but are not limited to:

- a. Use of information only for performing services required by the contract or as required by law;*
- b. Use of appropriate safeguards to prevent non-permitted disclosures;*
- c. Reporting to the City of Delray Beach any non-permitted use or disclosure;*
- d. Assurances that any agents and subcontractors agree to the same restrictions and conditions that apply to the Proposer and reasonable assurances that IIHI/PHI will be held confidential;*
- e. Making Protected Health Information (PHI) available to the customer;*
- f. Making PHI available to the customer for review and amendment, and incorporating any amendments requested by the customer;*
- g. Making PHI available to the City of Delray Beach for an accounting of disclosures; and*
- h. Making internal practices, books, and records related to PHI available to the City of Delray Beach for compliance audits.*

PHI shall maintain its protected status regardless of the form and method of transmission (paper records and/or electronic transfer of data). The selected Proposer must give its customers written notice of its privacy information practices, including specifically, a description of the types of uses and disclosures that would be made with protected health information.

36. **ADDITIONAL FEES AND SURCHARGES**

Unless provided for in the contract/agreement, the City will not make any additional payments such as fuel surcharges, demurrage fees, or delay-in-delivery charges.

37. **COMPLIANCE WITH FEDERAL STANDARDS**

All items to be purchased under this contract shall be in accordance with all governmental standards, to include, but not be limited to, those issued by the Occupational Safety and Health Administration (OSHA), the National Institute of Occupational Safety Hazards (NIOSH), and the National Fire Protection Association (NFPA).

38. **COMPLIANCE WITH FEDERAL REGULATIONS DUE TO USE OF FEDERAL FUNDING**

If the goods or services to be acquired under this Solicitation are to be purchased, in part or in whole, with Federal funding, it is hereby agreed and understood that Section 60-250.4, Section 60-250.5, and Section 60-741.4 of Title 41 of the United States Code, which addresses Affirmative Action requirements for disabled workers, is incorporated into this Solicitation and resultant contract by reference.

39. **BINDING EFFECT**

All of the terms and provisions of this contract/agreement, whether so expressed or not, shall be binding upon, inure to the benefit of, and be enforceable by the parties and their respective legal representatives, successors, and permitted assigns.

40. **SEVERABILITY**

In the event any term or provision of any contract or agreement entered into pursuant to this Solicitation is found by a court of competent jurisdiction to be invalid, the remaining terms and provisions shall continue to be effective and shall be interpreted and given meaning to the greatest possible extent in the absence of any severed terms or provisions.

41. **GOVERNING LAW AND VENUE**

This contract and all transactions contemplated by this agreement shall be governed by and construed and enforced in accordance with the laws of the State of Florida without regard to any contrary conflicts of law principle. Venue of all proceedings in connection herewith shall lie exclusively in Palm Beach County, Florida, and each party hereby waives whatever its respective rights may have been in the selection of venue.

42. **ATTORNEY'S FEES**

It is hereby understood and agreed that in the event any lawsuit in the judicial system, federal or state, is brought to enforce compliance with this contract or interpret same, or if any administrative proceeding is brought for the same purposes, each party shall pay their own attorney's fees and costs, including appellate fees and costs.

43. **EQUAL OPPORTUNITY AND ANTI-DISCRIMINATION**

The City of Delray Beach complies with all laws prohibiting discrimination on the basis of age, race, gender, religion, creed, political affiliation, sexual orientation, physical or mental disability, color or national origin, and therefore is committed to assuring equal opportunity in the award of contracts and encourages small, local, minority, and female-owned businesses to participate.

During the performance of this contract, the selected Proposer agrees it will not discriminate or permit discrimination in its hiring practices or in its performance of the contract. The selected Proposer shall strictly adhere to the equal employment opportunity requirements and any applicable requirements established by the State of Florida, Palm Beach County, and the federal government.

The selected Proposer further acknowledges and agrees to provide the City with all information and documentation that may be requested by the City from time to time regarding the Solicitation,

selection, treatment, and payment of subcontractors, suppliers, and Proposers in connection with this contract.

44. AVAILABILITY OF CONTRACT TO OTHER CITY DEPARTMENTS

It is agreed and understood that any City department or agency may access this contract and purchase the goods or services successful herein. Each City department will issue a separate purchase order to the selected Proposer for the department's specific purchases.

45. CRIMINAL HISTORY BACKGROUND CHECKS

Prior to hiring a contract employee or contracting with a Proposer, the City may conduct a comprehensive criminal background check by accessing any Federal, State, or local law enforcement database available. The contract employee or Proposer will be required to sign an authorization for the City to access criminal background information. The costs for the background checks shall be borne by the City.

46. LABOR, MATERIALS, AND EQUIPMENT

Unless specified elsewhere in the Solicitation or resultant contract, all labor, materials, and equipment required for the performance of the requirements of the contract shall be supplied by the selected Proposer.

47. MINIMUM WAGE REQUIREMENTS

The selected Proposer shall comply with all minimum wage requirements, such as Living Wage requirements, minimum wages based on Federal Law, minimum wages based on the Davis-Bacon Act, and the provisions of any other employment laws, as may be applicable to this contract.

48. PACKING SLIP AND DELIVERY TICKET

When such requirements are identified, the City may request a price quote from the selected Proposer on the contract. The City, at its sole discretion, will determine if the prices offered are reasonable, and may choose to purchase the goods or services from the selected Proposer, another contract Proposer, or a non-contract Proposer.

50. PUBLIC RECORDS

Florida law provides that municipal records shall at all times be available to the public for inspection. Chapter 119, Florida Statutes, the Public Records Law, requires that all material submitted in connection with a Proposal response shall be deemed to be public record subject to public inspection upon award, recommendation for award, or thirty (30) days after Proposal opening, whichever occurs first. Certain exemptions to public disclosure are statutorily provided for in Section 119.07, Florida Statutes. If the Proposer believes any of the information contained in his/her/its Proposal is considered confidential and/or proprietary, inclusive of trade secrets as defined in Section 812.081, Florida Statutes, and is exempt from the Public Records Law, then the Proposer must, in its response, specifically identify the material which is deemed to be exempt and state the legal authority for the exemption. All materials that qualify for exemption from Chapter 119, Florida Statutes or other applicable law must be submitted in a separate envelope, clearly identified as "EXEMPT FROM PUBLIC DISCLOSURE" with the firm's name and the Proposal number clearly marked on the outside. The City will not accept Proposals when the entire Proposal is labeled as exempt from disclosure. The City's determination of whether an exemption applies shall be final, and the Proposer agrees to defend, indemnify, and hold harmless the City and the City's officers, employees, and agents against any loss or damages incurred by any person or entity

as a result of the City's treatment of records as public records.

The selected Proposer(s) shall keep and maintain public records and fully comply with the requirements set forth at Section 119.0701, Florida Statutes, as applicable; failure to do so shall constitute a material breach of any and all agreements awarded pursuant to this Solicitation.

51. CONFLICTS OF INTEREST

All Proposers must disclose with their Proposal the name of any officer, director, or agent who is also an employee of the City of Delray Beach. Further, all Proposers must disclose the name of any City employee who has any interest, financial or otherwise, direct or indirect, of five percent (5%) or more in the Proposers' firm or any of its branches. Failure to disclose any such affiliation will result in disqualification of the Proposer from this Solicitation and may be grounds for further disqualification from participating in any future Solicitations with the City.

52. PUBLIC ENTITY CRIMES

As provided in Section 287.133(2) (a), Florida Statutes, a person or affiliate who has been placed on the convicted Proposers list following a conviction for a public entity crime may not submit a Proposal on a contract to provide any goods or services to a public entity; may not submit a Proposal on a contract with a public entity for the construction or repair of a public building or public work; may not submit Proposals on leases of real property to a public entity; may not be successful or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity.

53. OTHER GOVERNMENTAL AGENCIES

If a Proposer is successfully awarded a contract as a result of this Solicitation, the Proposer shall allow other governmental agencies to access this contract and purchase the goods and services under the terms and conditions at the prices awarded.

54. COMPLETION OF WORK AND DELIVERY

All work shall be performed and all deliveries made in accordance with good commercial practice. The work schedule and completion dates shall be adhered to by the selected Proposer, except in such cases where the completion date will be delayed due to acts of nature, force majeure, strikes, or other causes beyond the control of the selected Proposer. In these cases, the selected Proposer shall notify the City of the delays in advance of the original completion so that a revised delivery schedule can be appropriately considered by the City.

55. FAILURE TO DELIVER OR COMPLETE WORK

Should the selected Proposer fail to deliver or complete the work within the time stated in the contract, it is hereby agreed and understood that the City reserves the authority to cancel the contract with the selected Proposer and secure the services of another Proposer to purchase the items or complete the work. If the City exercises this authority, the City shall be responsible for reimbursing the selected Proposer for work that was completed and items delivered and accepted by the City in accordance with the contract specifications. The City may, at its option, demand payment from the selected Proposer, through an invoice or credit memo, for any additional costs over and beyond the original contract price that were incurred by the City as a result of having to secure the services of another Proposer.

56. CORRECTING DEFECTS

The selected Proposer shall be responsible for promptly correcting any deficiency, at no cost to the City, within three (3) calendar days after the City notifies the selected Proposer of such deficiency in writing. If the selected Proposer fails to correct the defect, the City may (a) place the selected Proposer in default of its contract; and/or (b) procure the products or services from another source and charge the selected Proposer for any additional costs that are incurred by the City for this work or items, either through a credit memorandum or through invoicing.

57. **ACCIDENT PREVENTION AND BARRICADES**
Precautions shall be exercised at all times for the protection of persons and property. All selected Proposers performing services or delivering goods under this contract shall conform to all relevant OSHA, State, and County regulations during the course of such effort. Any fines levied by the above-mentioned authorities for failure to comply with these requirements shall be borne solely by the selected Proposer. Barricades shall be provided by the selected Proposer when work is performed in areas traversed by persons, or when deemed necessary by the City.

58. **OMISSIONS IN SPECIFICATIONS**
The scope of services or description of items contained within this Solicitation describes the various functions and classes of work required as necessary for the completion of the project. Any omissions of inherent technical functions or classes of work within the specifications and/or statement of work shall not relieve the Proposer from furnishing, installing, or performing such work where required to the satisfactory completion of the project.

59. **MATERIALS SHALL BE NEW AND WARRANTED AGAINST DEFECTS**
The selected Proposer hereby acknowledges and agrees that all materials, except where recycled content is specifically requested, supplied by the selected Proposer in conjunction with this Solicitation and resultant contract shall be new, warranted for their merchantability, and fit for a particular purpose. In the event any of the materials supplied to the City by the selected Proposer are found to be defective or do not conform to specifications, (1) the materials may be returned to the selected Proposer at the Proposer's expense and the contract cancelled; or (2) the City may require the selected Proposer to replace the materials at the selected Proposer's expense.

60. **TOXIC SUBSTANCES/FEDERAL "RIGHT TO KNOW" REGULATIONS**

The Federal "Right to Know" Regulation implemented by the Occupational Safety and Health Administration (OSHA) requires employers to inform their employees of any toxic substances to which they may be exposed in the workplace, and to provide training in safe handling practices and emergency procedures. It also requires notification to local fire departments of the location and characteristics of all toxic substances regularly present in the workplace.

Accordingly, the selected Proposer performing under this contract is required to provide two (2) complete sets of Material Safety Data Sheets to each City department utilizing any products that are subject to these regulations. This information shall be provided at the time when the initial delivery is made, on a department-by-department basis.

61. **TAXES**

The City of Delray Beach is exempt from Federal and State taxes for tangible personal property.

62. **PROPOSER'S COSTS**

The City shall not be liable for any costs incurred by Proposers in responding to this Request for Qualifications.

63. **SUBSTITUTION OF PERSONNEL**

It is the intention of the City that the selected Proposer's personnel proposed for the contract shall be available for the initial contract term. In the event the selected Proposer wishes to substitute personnel, the selected Proposer shall propose personnel of equal or higher qualifications, and all replacement personnel are subject to the City's approval. In the event the substitute personnel are not satisfactory to the City, and the matter cannot be resolved to the satisfaction of the City, the City reserves the right to cancel the contract for cause.

64. FORCE MAJEURE

The City and the selected Proposer are excused from the performance of their respective obligations under the contract when and to the extent that their performance is delayed or prevented by any circumstances beyond their control, including fire, flood, explosion, strikes or other labor disputes, natural disasters, public emergency, war, riot, civil commotion, malicious damage, act or omission of any governmental authority, delay or failure or shortage of any type of transportation, equipment, or service from a public utility needed for their performance provided that:

- a. The non-performing party gives the other party prompt written notice describing the particulars of the force majeure, including, but not limited to, the nature of the occurrence and its expected duration, and continues to furnish timely reports with respect thereto during the period of the force majeure.*
- b. The excuse of performance is of no greater scope and of no longer duration than is required by the force majeure.*
- c. No obligations of either party that arose before the force majeure causing the excuse of performance are excused as a result of the force majeure.*
- d. The non-performing party uses its best efforts to remedy its inability to perform.*

Notwithstanding the above, performance shall not be excused under this section for a period in excess of two (2) months, provided that in extenuating circumstances, the City may excuse performance for a longer term. Economic hardship of the selected Proposer shall not constitute a force majeure. The term of the contract shall be extended by a period equal to that during which either party's performance is suspended under this section.

65. NOTICES

Notices shall be effective when received at the addresses specified in the contract/agreement. Changes in respective addresses to which such notices are to be directed may be made from time to time by either party by written notice to the other party. Facsimile and email transmissions are acceptable notice effective when received; however, facsimile and email transmissions received after 5:00 p.m. or on weekends or holidays will be deemed received on the next business day. The original of the notice must also be mailed to the receiving party.

Nothing contained in this section shall be construed to restrict the transmission of routine communications between representatives of the selected Proposer and the City of Delray Beach.

66. POOL CONTRACTS

During the term of contracts and agreements that are executed as vendor pools, awarding vendors in prequalified pools of vendors, either as a general pool or by categories, sub-categories, or groups, the City reserves the right to add new vendors to these contracts for goods or services not awarded for the original Solicitation or as part of the general pool category, sub-category or group. To be eligible to be added to these pool contracts, a vendor must meet the same eligibility requirements established in the original Solicitation.

67. FISCAL FUNDING OUT

The City's obligation pursuant to any contract or agreement entered into in accordance with this Solicitation is specifically contingent upon the lawful appropriation of funds. Failure to lawfully appropriate funds for any contract or agreement awarded shall result in automatic termination of the contract or agreement. A non-appropriation event shall not constitute a default or breach of said contract or agreement by the City.

68. *DEBARRED OR SUSPENDED BIDDERS OR PROPOSERS*

The bidder or proposer certifies, by submission of a response to this solicitation, that neither it nor its

principals and subcontractors are presently debarred or suspended by any Federal department or agency.

The City will only accept electronic Proposals for this RFQ.

The City will not hold a non-mandatory Pre-Proposal Conference. It is the responsibility of the Proposer to ensure all pages are included in the submission. All Proposers are advised to closely examine the solicitation package. The City of Delray Beach is exempt from Federal and State Taxes for tangible personal property tax.

The City of Delray Beach reserves the right to accept or reject any or all Proposals, in whole or in part, with or without cause, to waive any irregularities and/or technicalities, and to award the contract on such coverage and terms it deems will best serve the interests of the City.

SECTION 1: PROJECT OVERVIEW

- 1.1.** The City of Delray Beach (“City”) is soliciting Proposals from qualified firms for the provision of professional services relating to the design of a **New Police Department Headquarters**, including a multi-level parking structure. This project will be funded by a Public Safety General Obligation Bond, approved in a referendum by voters during the March 2023 municipal elections.

The services required may include, but not be limited to, the development of space needs, full construction documents and specifications including a full site development plan, permitting, and demolition of all existing structures (the radio tower may have the possibility of remaining at its present location or need to be redesigned to another area on the site). The City intends to utilize a Construction Manager at Risk (CMAR) as the delivery method of construction. A CMAR firm will be engaged for both Pre-Construction Services (Phase 1) and Construction Services (Phase 2).

- 1.2.** The Method of Award for this Solicitation will be to the Proposer with the highest ranking or scores with whom the City is able to negotiate an acceptable Agreement. The City will enter negotiations with the firm receiving the highest-ranking proposal score. Should negotiations fail then the City will enter negotiations with the next highest-ranking firm.
- 1.3.** The City intends to contract with a single firm for the project listed in this procurement. The Proposer will provide the following services: (1) updates to a 2018 Needs Assessment (2) field survey & geotechnical services; (3) preparation of plans and specifications; (4) public outreach; (5) bid & award services; and (6) post-design services.

SECTION 2: SPECIAL TERMS AND CONDITIONS

2.1. PURPOSE

The purpose of this Request for Qualifications (RFQ) is to solicit Proposals from qualified firms and consultants who can provide professional engineering and architectural design of a **New Police Department Headquarters**, including a multi-level parking structure.

The City expects each Proposer to clearly outline its best and most comprehensive resources in its response, because all services and responsibilities identified in this Solicitation may be awarded to the selected Proposer.

2.2. ELIGIBILITY

To be eligible to respond to this RFQ and be considered for award, the Proposer must demonstrate to the satisfaction of the City that it or the principals assigned to the project has successfully provided services, similar in scope and complexity, to a municipality, quasi-governmental organization, or a private organization.

2.3. SEPARATION OF SERVICES

The entity(ies) performing design and construction engineering services and/or owner's representative services may not be the same entity for this Project. Vendors, solely providing geotechnical and/or surveying services for the design are exempt from this provision.

2.4. RECORDS, ACCOUNTS, AND STATEMENTS

The successful Proposer shall keep on its premises, or such other place approved by the City, current true, accurate, and complete records and accounts of all services provided to the City and shall give the City or City's representative access during reasonable business hours and upon three (3) business days' notice to examine and audit such records and accounts. Such records shall be maintained at such standard to allow a certified auditor the ability to properly examine the records in order to certify a statement of the successful Proposer's business with the City.

2.5. GENERAL STANDARDS

The successful Proposer shall at all times comply with all rules, regulations, and other governmental agencies having jurisdiction. The successful proposal shall further take all precautions and extreme care to conduct its activities in a safe, professional, and prudent manner with respect to its agents, employees, members, visitors, and participants.

2.6. DEFAULT

In the event the successful Proposer defaults in the performance of the contract, the city shall have the following options:

- 2.6.1. The City Manager will give the successful Proposer thirty (30) days' written notice of default. If the problem is not resolved within the thirty (30) days, the City may immediately terminate the contract upon providing written notice of the Proposer's failure to timely cure the default and obtain the services elsewhere.

2.6.2. The City may recover at law any all claims that may be due to the City from the successful Proposer.

2.6.3. The City may perform such work as it deems necessary to cure the default or subsequent default and charge the successful Proposer for the full cost of labor and materials expended, plus thirty percent (30%) of the cost for administrative overhead.

The acceptance of all or part of monies due for any period after a default shall not deemed as a waiver of any of these options, or a waiver of the default or subsequent default of the same or any other term, covenant, and condition.

The successful Proposer agrees that the City shall not be responsible or have any liability whatsoever for any alleged damages, claim of lost profits, or otherwise in the event the City declares the successful Proposer in default hereunder.

2.7. INSURANCE

The selected Proposer shall not commence any performance pursuant to the terms of this RFQ until certification or proof of insurance has been received and approved by the City's Risk Coordinator or designee.

The required insurance coverage is to be issued by an insurance company authorized, licensed, and registered to do business in the State of Florida, with the minimum rating of A- VII or better, in accordance with the latest edition of A.M. Best's Insurance Guide. This insurance shall be documented in certificates of insurance which provides that the City of Delray Beach shall be notified at least thirty (30) days in advance of cancellation, non-renewal, or adverse change. The receipt of certificates or other documentation of insurance or policies or copies of policies by the City or by any of its representatives, which indicate less coverage than is required, does not constitute a waiver of the selected Proposer's obligation to fulfill the insurance requirements herein. Deductibles must be acceptable to the City of Delray Beach.

The selected Proposer must submit a current Certificate of Insurance, naming the City of Delray Beach, their employees and officers as additional insured and listed as such on the insurance certificate, no later than ten (10) days after award and prior to commencement of any work. New certificates of insurance are to be provided to the City upon expiration. All renewal or replacement certificates of insurance shall be forwarded to the City Purchasing and Contract Administration Division located at 100 NW 1st Ave., Delray Beach, FL 33444.

The selected Proposer shall provide insurance coverage as follows:

2.7.1. **WORKERS COMPENSATION** – With statutory limits, the City reserves the right not to accept exemptions to the Workers Compensation requirements of this Solicitation.

2.7.2. **EMPLOYER'S LIABILITY** – With a limit of not less than One Hundred Thousand Dollars (\$100,000) for each accident, One Hundred Thousand Dollars (\$100,000) for each occurrence, and Five Hundred Thousand Dollars (\$500,000) for the aggregate.

- 2.7.3. **COMPREHENSIVE GENERAL LIABILITY** – With limits of not less than One Million Dollars (\$1,000,000) per occurrence and Two Million Dollars (\$2,000,000) in the aggregate for Bodily Injury and Property Damage.

NOTE – If Comprehensive General Liability limits are less than One Million Dollars (\$1,000,000), the sum of Comprehensive General Liability limits and Excess Liability limits must equal no less than One Million Dollars (\$1,000,000).

The Comprehensive General Liability insurance policy must include coverage that is not more restrictive than the latest edition of the Comprehensive General Liability Policy, without restrictive endorsements, as filed by the Insurance Services Offices, and the policy must include coverage's for premises and/or operations, independent contractors, products and/or completed operations for contracts, contractual liability, broad form contractual coverage, broad form property damage, products, completed operations, and personal injury. Personal injury coverage shall include coverage that has the Employee and Contractual Exclusions removed.

- 2.7.4. **AUTOMOBILE LIABILITY** – Covering all vehicles associated with Proposer's operations to include all owned, non-owned and hired vehicles. The coverage will be written on an occurrence basis with limits of liability not less than One Million Dollars (\$1,000,000) combined single limit per each occurrence.

- 2.7.5. **PROFESSIONAL LIABILITY** – With limits of not less than One Million Dollars (\$1,000,000) per occurrence.

2.8. PERFORMANCE BOND/LETTER OF CREDIT

Intentionally Omitted.

2.9. LICENSES AND CERTIFICATIONS

Any Proposer which submits an offer in response to this Solicitation shall, at the time of such offer, hold all the required licenses, permits, and certifications issued by the State or County Examining Board qualifying the Proposer to perform the services described in this Solicitation.

The City may at its option, and in its best interest, allow the Proposer to supply any missing information on certification and licensing during the Proposal Evaluation period.

Proposer must be licensed by the Florida Department of Business & Professions Regulation as an engineering firm. Provide a screenshot or copy of Proposer's license from the Florida Department of Business & Professions Regulation that confirms Proposer has a current license in the category type of engineering.

2.10. METHOD OF PAYMENT – MONTHLY INVOICES

The selected Proposer shall submit an invoice to the City, each month, after the services have been performed and have been received and accepted by the City. The amount charged shall not be in excess of the rates and fees agreed to in the Agreement.

The date of the invoices shall not exceed thirty (30) calendar days from the performance of the work. Under no circumstances shall the invoice be submitted to the City in advance of the performance of the work.

The invoice shall contain the following basic information: the selected Proposer's name and address, invoice number, date of invoice, description of the service performed, the contract number, purchase order number, and any discounts.

The City prides itself on paying its vendors promptly and efficiently, and as such requires that vendors accept payment via wire transfer, ACH (direct deposit), or an appropriate electronic payment method. The City is averse to issuing paper checks and seeks to discontinue this practice. All payments shall be made in accordance with the Florida Prompt Payment Act, Section 218.74, Florida Statutes, upon presentation of a proper invoice by the awarded Proposer.

2.11. SUBCONTRACTING

As part of its Proposal, the Proposer must identify any and all subcontractors that will be used in the performance of the proposed work, their capabilities and experience, and the portion of the work to be done by the subcontractor. The competency of the subcontractor(s) with respect to experience, skill, responsibility, and business standing shall be considered by the City when making the award in the best interest of the City. If the Proposer fails to identify any and all subcontractors in the Proposal, the Proposer may be allowed to submit this documentation if such action is in the best interest of the City.

2.12. OTHER FORMS OR DOCUMENTS

If the City is required by the selected Proposer to complete and execute any other forms or documents in relation to this Solicitation, the terms, conditions, and requirements in this Solicitation shall take precedence to any and all conflicting or modifying terms, conditions or requirements of the selected Proposer's forms or documents.

2.13. MODIFICATION OF SERVICES

The City reserves the right to delete or modify any portion of the contracted services at any time without cause, and if such right is exercised by the City, the rates and fees shall be reduced at the same ratio as the estimated costs of the services deleted relates to the estimated costs of the service originally contracted. If service has already been provided on the portion of the work to be deleted, the selected Proposer will be paid for the deleted portion based on the estimated percentage of the completion of such portion.

If the selected Proposer and the City agree on modifications or revisions to the service elements, after the City has approved performance of a particular task or project, and a budget has been established for that task or project, the selected Proposer shall submit a revised budget to the City for approval prior to proceeding with the task or project.

SECTION 3: SCOPE OF SERVICES

3.1. PROJECT HISTORY AND BACKGROUND

The current Delray Beach Police Department Headquarters is located at 300 West Atlantic Avenue in the City of Delray Beach Florida 33444. Construction of the facility was completed in 1987 and currently houses most of the police staff and activities. The existing 41,100 square feet facility at 300 West Atlantic Avenue was constructed on approximately 4.1 acres with 187 parking spaces. The City's population was approximately 48,000 when the facility was constructed and today the City's population is approximately 68,000 with 233 police personnel. There is another facility located at 2350 Seacrest Boulevard that is leased from the Palm Beach County School Board and is used for training purposes.

On March 14, 2023, the citizens of the City of Delray Beach approved a \$100 million-dollar bond referendum to build a new state-of-the-art Police Headquarters and multi-level parking structure.

The new Police Department Headquarters should consider a 20-year future needs assessment and is anticipated to be approximately 110,000 square feet in total size, with a multi-level parking structure for approximately 365 vehicles. This new facility will be constructed on the same site as the existing facility and the current police headquarters **must** remain in use throughout construction. Demolition of the current police headquarters is part of this project scope.

The new facility must be CAT 5 hurricane rated and include all features including (but not limited to): dispatch, office space, gun range, interview/polygraph booths, training rooms, community room, property and evidence storage, quartermaster, Real Time Crime Center (RTCC), holding cells equipped with a processing area (including a sally port), administration, gym / physical agility, roll call, full kitchen, conference space, all associated support areas such as IT, Maintenance, etc.; a multi-level parking structure equipped with a high first floor (including electrical power outlets to store and charge larger vehicles), flagpoles, an officer memorial at the front entrance, glass cases to display historical artifacts, fueling station (detached structure), fleet maintenance (detached structure), and a public safety radio tower.

3.2. SUMMARY OF WORK

The selected Proposer (hereinafter in this Scope referred to as Consultant) shall provide civil engineering and architectural design services to design a **New Police Department Headquarters**, including a multi-level parking structure. The Consultant will prepare project implementation documents including plans, specifications, permits, and project cost estimates in accordance with Florida Department of Transportation (FDOT) and Palm Beach County Health Department (PBCHD) requirements and City policies, procedures, standards, and requirements for the construction of a new police department headquarters, including a multi-level parking structure.

The services required may include, but not be limited to, the development of space needs, full construction documents and specifications including a full site development plan, permitting, and demolition of all existing structures (the radio tower may have the possibility of remaining at its present location or need to be redesigned to another area on the site).

A preliminary construction cost for the project is estimated to be between 80 and 85 million dollars (inclusive of furniture, fixtures, and equipment). The final construction cost may differ due to actual program requirements, other project costs and/or circumstances.

3.3. ENGINEERING & ARCHITECTURAL DESIGN SERVICES

The Consultant shall provide engineering and architectural design services including all necessary documents, conferences, presentations and presentation materials required by the City. A detailed scope of work will be developed during negotiation of the professional services agreement between the City and the selected Consultant.

The selected Consultant will be required to inspect the building sites, test for soil bearing capability, and advise the City on the most effective way to implement the overall project in terms of time and budget requirement.

In addition, the Consultant will need to develop a detailed project schedule, detailed cost estimate at each phase of design, and provide value engineering to ensure that the project budget is maintained at each phase.

The City is anticipating that the overall project schedule would not exceed:

- Design Phase – Approximately 15 to 18 months
- Construction Phase – Approximately 24 months

The City intends to utilize Construction Manager at Risk (CMAR) as the delivery method of construction. A CMAR contractor will be engaged for both Pre-Construction Services (Phase 1) and Construction Services (Phase 2). The selected Consultant, working with the CMAR during their Phase 1 (Pre-Construction Services), will also develop work plans, schedules and budgets, coordinate project design, provide value engineering when required, attend and address meetings with city officials, neighborhood groups, and private citizens concerning the project, maintain conventional and electronic files (database) of all documentation and correspondence relating to the project. If required by the project schedule, the selected Consultant as part of this solicitation may be requested to work with the CMAR contractor to develop early construction release packages.

- 3.3.1. Anticipated services may consist of, but are not limited to the following:
- 3.3.1.1. Coordinate the preparation of construction documents, including, but not limited to, spacing needs, engineering calculations, drawings, and plans for mechanical details such as plumbing, ventilation, fire suppression, IT infrastructure, and lighting features.
 - 3.3.1.2. Review of existing Palm Beach County, City of Delray Beach pertinent Codes, Resolutions and Ordinances and State of Florida Building Codes, and incorporating the above data into complete construction documents including final construction plans, technical specifications, construction estimates, and related documents necessary for the construction of the project.
 - 3.3.1.3. Obtaining all Federal, State, and local permits or approvals (including Palm Beach County water, sewer and environmental approvals) and all Building permits necessary for the construction of the project. The Consultant team may also be required to provide consulting services to the City on various matters which do not result in drawings, specifications or construction documents.
 - 3.3.1.4. Prepare and submit signed and sealed construction drawings to the City of Delray Beach Development Services Department, Building Division, and any other applicable agencies for review, and make any revisions required for the issuance of building and/or site development permits.
 - 3.3.1.5. Subconsultants' scopes may include, but are not limited to, Structural Engineering, Civil Engineering, Geotechnical Engineering, Landscape Architecture, Site Lighting and Survey Services, Planning, Plat, MEP Engineering and Low Voltage design including A/V, CCTV, access management, voice/data, emergency and cell phone in building signal boosters.
 - 3.3.1.6. Inspect project site and test for soil bearing capacity.
 - 3.3.1.7. Prepare all design and specifications with sustainability and long-term life cycle analysis practices and guidelines. LEED certification will not be a requirement of the project; however, the city will require that a LEED scorecard at each phase of design be submitted to be used as a guide on implementation of sustainable elements.
 - 3.3.1.8. Provide coordination, oversight and review of CMAR contractor's pre-construction services and subsequent Guaranteed Maximum Price (GMP) for construction.
 - 3.3.1.9. Provide a detailed final cost estimate for the aspects of the project for which the Consultant team is responsible. This will be used to reconcile the design professional cost estimate and the CMAR cost estimate.
 - 3.3.1.10. Provide public outreach including a website and other public information activities.
 - 3.3.1.11. The Consultant team must be able to start this project immediately upon a "Notice

to Proceed” by the City and prioritize this project throughout its entirety.

3.3.1.12. Value engineering shall be performed to ensure that the project budget is maintained at each phase.

3.3.1.13. Develop options for relocation of the radio tower.

3.3.1.14. The Police Headquarters and multi-level parking structure must be CAT 5 Hurricane rated and the level of security must meet Commission for Florida Law Enforcement Accreditation Inc. (CFA), Criminal Justice Information Services (CJIS), and Florida Department of Law Enforcement (FDLE) standards for accreditation.

3.3.1.15. Lead Consultants interested in the Request for Qualifications (RFQ) must indicate any subconsultants which would be part of their team.

3.3.1.16. The selected Consultant team may also need to confer with City staff, during the planning and design phases, in the preparation of structural plans for the building and parking structure, make recommendations and suggestions as to the materials, construction, and necessary adjustments in architectural design to fit structural requirements.

3.3.2. Summary of Professional Services to be Provided by the Consultant Team

3.3.2.7. Furniture, Fixtures, and Equipment (FF&E) Design

3.3.2.8. Interior Complete Design (ready for Staff move in)

3.3.2.9. Security System Engineering

3.3.2.10. Video Conferencing, Telecommunications and Acoustical Design

3.3.2.11. Energy Modeling

3.3.2.12. Development of detailed project schedules and cost estimates

3.3.2.13. Audio, video, communications, telecommunications, high-speed WI-FI hotspots and connections including complete Information Technology Design and fiber optic

3.3.2.14. Construction cost estimating (certified estimator ASCE) for entire project

3.4. PROJECT DESIGN

Consultant shall provide services for the preparation of design and Proposal documents for construction of this project as part of the Capital Improvement Plan (CIP). Design services are for the development of design drawings for redevelopment of the entire site located at 300 West Atlantic Avenue which will include a new Police Department Headquarters and associated parking structure, communication facilities, roadway, utility, ADA accessibility, landscape and lighting improvements.

Professional Services and design drawings shall account for the following, but are not limited to:

- 3.4.1. The City is seeking a Consultant team to undertake the design, engineering, architecture, and coordinate with a CMAR contractor for a new Police Department Headquarters and associated parking structure.
- 3.4.2. **The existing facility must be kept operational throughout construction of the new facility.** The Consultant may need to include design criteria for some off-site rental facilities during redevelopment of the property.
- 3.4.3. The 2018 Needs Assessment study determined that the Police Department requires approximately three times the square footage currently available within the existing building to accommodate everyone at one facility for the next 20 years. One major challenge with the future design includes the accommodation of an existing communications tower and design/development of new communications facilities within the new facility and parking structure.
- 3.4.4. All systems and structures (including any new communications facilities) shall be designed to the Essential Facility Florida Building Code Standards (latest edition) and shall meet or exceed all hurricane hazard safety criteria as set forth by Florida Building Code (Latest Edition).
- 3.4.5. The design must be consistent with the architectural style of the surrounding neighborhood (approved by Planning and Zoning Department) and meet sustainability standards established for LEED certification (Certification NOT Required).
- 3.4.6. This is a unique facility and requires careful design and safety considerations in utilizing the existing spaces during the construction phase of the project as well as the prospect of utilizing temporary parking facilities with Palm Beach County South County Judicial Center (200 West Atlantic Avenue).
- 3.4.7. In the design of a new multi-level parking structure, there shall be a minimum of 365 secure parking spaces. Access controls to the secured parking spaces is a critical site planning consideration. The parking structure design shall consider future shared use with the City's

Fire Department and their large vehicles.

- 3.4.8. Emergency generator and fuel storage shall be incorporated into the design to accommodate a seven-day operation under full load.
- 3.4.9. Consultant shall investigate if the existing utilities need to be upgraded for the new facility: water, sewer, fiber optic communications, solar electric, and reuse for the site. Stormwater management will also be required. The Consultant shall work with South Florida Water Management District to determine the best approach for stormwater management. The cost for all system improvements will be part of the overall project.
- 3.4.10. The Consultant will be continuously responsible for project safety and quality control, as well as other activities necessary to construct the project. The Consultant shall employ an independent Community Engagement Specialist or Firm to assist with communication between the project team, City Staff, City Commission, and the community. Communications shall include coordination and information transfer via public meetings, live surveys, telephone, email, newsprints, and pamphlets. The Consultant shall provide the project with a dedicated telephone number and email address. The Community Engagement Specialist or Firm shall update the City's Website accounts as required and shall coordinate updates with the City's Public Information Office.

3.5. ADDITIONAL GENERAL PROJECT TASKS

- 3.5.1. **Community Outreach** – Throughout the duration of the project, the Consultant shall be responsible for notifying all property owners, schools, tenants, and residents about potential impacts associated with the project.
- 3.5.2. **Notifications** – Consultant shall prepare and mail flyers, and/or letters and door hangers to the residents, tenants, and owners. Information to be provided shall include the proposed project scope, limits, schedule, and the anticipated impacts of the construction to residents (e.g. detours, street closures, utility interruptions, etc.). Contact information shall also be included with the notification. Notifications shall be in accordance with City policies.

6.4 ORAL PRESENTATIONS/INTERVIEWS

Upon initial completion of the criteria evaluation indicated above, rating and ranking, the Evaluation Committee may choose to conduct an oral presentation with the Proposers which the Evaluation Committee deems to warrant further consideration based on, among other considerations, scores in clusters and/or maintaining competition. Upon completion of the oral presentation(s), the Evaluation/ Selection Committee will perform a final evaluation, rating, and ranking of the Proposals.

In such circumstances, the initial ranking of the Proposers shall be considered a preliminary ranking only.

6.5 NEGOTIATIONS

If the City and the Proposer(s) cannot reach an agreement on a contract, the City reserves the right to terminate negotiations and may, at the City Manager's or designee's discretion, begin negotiations with the next highest-ranked Proposer(s). 1. **DEFINITIONS**

a. Proposal: any offer(s) submitted in response to this Request for Qualifications.

b. Proposer: person or firm submitting a response to this Request for Qualifications.

c. Solicitation or Request for Qualifications: this Solicitation documentation, including any and all addenda.

d. Proposal Submittal forms: describes the goods or services to be purchased and must be completed and submitted with the Proposal.

e. City: shall refer to the City of Delray Beach, Florida.

f. Contract or Agreement: Request for Qualifications, all addenda issued thereto, all affidavits, the signed agreement, and all related documents that comprise the totality of the contract or agreement between the City and the Proposer.

g. Contractor: selected Proposer that is awarded a contract to provide the goods or services to the City.

h. Purchasing and Contract Administration Division: Purchasing and Contract Administration Division of the City of Delray Beach, Florida.

i. Responsible Proposer: Proposer that has the capability in all respects to perform in full the contract requirements, as stated in the Request for Qualifications, and the integrity and reliability that will assure good-faith performance.

j. Responsive Proposer: Proposer whose Proposal conforms in all material respects to the terms and conditions included in the Request for Qualifications.
2. **CONE OF SILENCE**

Pursuant to Section 2-355 of the Palm Beach County Ordinance No. 2011-039, and the purchasing policies of the City of Delray Beach, all Solicitations, once advertised and until the appropriate authority has approved an award recommendation, are under the "Cone of Silence". This limits and requires documentation of
- communications between potential Proposers and/or Proposers on City Solicitations, the City's professional staff, and the City Council members.*
3. **ADDENDUM**

The Purchasing and Contract Administration Division may issue an addendum in response to any inquiry received, prior to the due date for Proposals, which changes, adds, or clarifies the terms, provisions, or requirements of the Solicitation. The Proposer should not rely on any representation, statement, or explanation, whether written or verbal, other than those made in the Solicitation document or in the addenda issued. Where there appears to be a conflict between the Solicitation and any addenda, the last addendum issued shall prevail. It is the Proposer's responsibility to ensure receipt of all addenda and any accompanying documentation. The Proposer is required to submit with its Proposal a signed "Acknowledgment of Addenda" form, when any addenda have been issued.
4. **LEGAL REQUIREMENTS**

This Solicitation is subject to all legal requirements contained in the applicable City Ordinances and Resolutions, as well as all applicable City, State, and Federal Statutes. Where conflict exists between this Solicitation and these legal requirements, the authority shall prevail in the following order: Federal, State, and local.
5. **CHANGE OF PROPOSAL**

Prior to the scheduled due date for Proposals, a Proposer may change its Proposal by submitting a new Proposal (as indicated on the cover page) with a letter on the firm's letterhead, signed by an authorized agent stating that the new Proposal replaces the original Proposal. The new submittal shall contain the letter and all information as required for submitting the original Proposal. No changes to a Proposal will be accepted after Proposals have been opened.

6. **WITHDRAWAL OF PROPOSAL**

A Proposal shall be irrevocable unless the Proposal is withdrawn as provided herein. 7. **CONFLICTS WITHIN THE SOLICITATION**

8. **PROMPT PAYMENT TERMS**

10. **PREPARATION OF PROPOSALS**

12. **AWARD OF CONTRACT**

- a. *This contract may be awarded to the responsive and responsible Proposer meeting all requirements as set forth in the Solicitation. The City reserves the right to reject any and all Proposals, to waive irregularities or technicalities, and to re-advertise for all or any part of this Solicitation as deemed in its best interest. The City shall be the sole judge of its best interest.*

15. **ESTIMATED QUANTITIES**

Estimated quantities or dollars are for Proposer's guidance only: (a) estimates are based on the City's anticipated needs and/or usage; and (b) the City may use these estimates to determine the selected Proposer. No guarantee is expressed or implied as to quantities or dollars that will be used during the contract period. The City is not obligated to place any order for the given amount subsequent to the award of this contract.

16. **NON-EXCLUSIVITY**

It is the intent of the City to enter into an agreement with the selected Proposer that will satisfy its needs as described herein. However, the City reserves the right as deemed in its best interest to perform, or cause to be performed, the work and services, or any portion thereof, herein

described in any manner it sees fit, including but not limited to, award of other contracts, use of any contractor, or perform the work with its own employees.

17. CONTINUATION OF WORK

Any work that commences prior to and will extend beyond the expiration date of the current contract period shall, unless terminated by mutual written agreement between the City and the selected Proposer, continue until completion at the same prices, terms, and conditions.

18. PROTEST

a. A recommendation for contract award or rejection of award may be protested by a Proposer. The Proposer may file a written protest with the City Clerk's office. The Proposer shall file its written protest with the City Clerk, Monday through Friday, between the hours of 8:00 a.m. and 5:00 p.m., excluding legal holidays. Protests shall contain the name, address, and phone number of the petitioner, name of the petitioner's representative (if any), and the title and Proposal number of the Solicitation. The protest shall specifically describe the subject matter, facts giving rise to the protest, and the action requested from the City.

b. The written protest must be received within three business days from the time of the initial posting of the intended award. Notice of Intent to Award shall be posted in Bidnet Direct. c. The letter of protest shall be accompanied by a non-refundable protest application fee in an amount equal to one percent (1%) of the

protestor's bid or five thousand dollars (\$5,000.00), whichever is less. The protest application fee must be a cashier's check, a certified check, or an attorney's trust account check made payable to the City of Delray protest application fee must be a cashier's check, a certified check, or an attorney's trust account check made payable to the City of Delray protest. Damages, penalties, and/or fines imposed on the City or a selected Proposer for failure to obtain and maintain required licenses, certifications, permits, and/or inspections shall be borne by the selected Proposer.

21. SUBCONTRACTING

22. **ASSIGNMENT**

The selected Proposer shall not assign, transfer, hypothecate, or otherwise dispose of this contract, including any rights, title, or interest therein, or its power to execute such contract to any person, company, or corporation without the prior written consent of the City. Assignment without the prior consent of the City may result in termination of the contract for default.

23. **SHIPPING TERMS**

Unless otherwise specified in the Solicitation, prices quoted shall be F.O.B. Destination. Freight shall be included in the proposed price.

24. **RESPONSIBILITIES AS EMPLOYER**

The employee(s) of the selected Proposer shall be considered to be at all times its employee(s), and not an employee(s) or agent(s) of the City or any of its departments. The selected Proposer shall provide physically competent employee(s) capable of performing the work as required. The City may require the selected Proposer to remove any employee it deems unacceptable. All employees of the selected Proposer shall wear proper identification.

It is the selected Proposer's responsibility to ensure that all its employees and subcontractors comply with the employment regulations required by the US Department of Homeland Security. The City shall have no responsibility to check or verify the legal immigration status of any employee of the selected Proposer.

25. **INDEMNIFICATION**

The selected Proposer shall indemnify and hold harmless the City and its officers, employees,

agents, and instrumentalities from any and all liability, losses, or damages, including attorney's fees and costs of defense, which the City or its officers, employees, agents, or instrumentalities may incur as a result of claims, demands, suits, causes of actions, or proceedings of any kind or nature arising out of, relating to, or resulting from the performance of the agreement by the selected Proposer or its employees, agents, servants, partners, principals, or subcontractors. The selected Proposer shall pay all claims and losses in connection therewith, and shall investigate and defend all claims, suits, or actions of any kind or nature in the name of the City, where applicable, including appellate proceedings, and shall pay all costs, judgments, and attorney's fees which may be incurred thereon. The selected Proposer expressly understands and agrees that any insurance protection required by this contract agreement or otherwise provided by the selected Proposer shall in no way limit the responsibility to indemnify, keep and save harmless, and defend the City or its officers, employees, agents, and instrumentalities as herein provided.

26. **COLLUSION**

A Proposer recommended for award as the result of a competitive Solicitation for any City purchase of supplies, materials, and services (including professional services, other than professional architectural, engineering, and other services subject to Sec. 287.055 Florida Stats.), purchase, lease, permit, concession, or management agreement shall, within five (5) business days of the filing of such recommendation, submit an affidavit under the penalty of perjury, on a form provided by the City stating either that the contractor is not related to any of the other parties proposing in the competitive Solicitation or identifying all related parties; and attesting that the Proposal is genuine and not a sham or collusive or made in the interest or on behalf of any person not therein named, and that the Proposer has not, directly or indirectly, induced or solicited any other Proposer to put in a sham Proposal, or any other person, firm, or

corporation to refrain from proposing, and that the Proposer has not in any manner sought by collusion to secure to the Proposer an advantage over any other Proposer. In the event a recommended Proposer identifies related parties in the competitive Solicitation, its Proposal shall be presumed to be collusive and the recommended Proposer shall be ineligible for award unless that presumption is rebutted to the satisfaction of the City. Any person or entity that fails to submit the required affidavit shall be ineligible for contract award.

27. **MODIFICATION OF CONTRACT**

The contract may be modified by mutual consent, in writing, through the issuance of a modification to the contract, a supplemental agreement, purchase order, or change order, as appropriate.

28. **TERMINATION FOR CONVENIENCE**

The City, at its sole discretion, reserves the right to terminate any contract entered into pursuant to this Request for Qualifications (RFQ) with or without cause immediately upon providing written notice to the selected Proposer. Upon receipt of such notice, the selected Proposer shall not incur any additional costs under the contract. The City shall be liable only for reasonable costs incurred by the selected Proposer prior to the date of the notice of termination. The City shall be the sole judge of "reasonable costs."

29. **TERMINATION FOR DEFAULT**

The City reserves the right to terminate this contract, in part or in whole, or place the vendor on probation in the event the selected Proposer fails to perform in accordance with the terms and conditions stated herein by providing written notice of such failure or default and by specifying a reasonable time period within which the selected Proposer must cure any such failure to perform or default. If the selected Proposer fails to cure the default within the time specified, the City may then terminate the subject contract by providing written notice to the selected Proposer. The City further reserves the right to suspend or debar the

selected Proposer in accordance with the appropriate City ordinances, resolutions, and/or policies. The vendor will be notified by letter of the City's intent to terminate. In the event of termination for default, the City may procure the required goods and/or services from any source and use any method deemed in its best interest. All re-procurement costs shall be borne by the incumbent Proposer

30. **FRAUD AND MISREPRESENTATION**

Any individual, corporation, or other entity that attempts to meet its contractual obligations with the City through fraud, misrepresentation, or material misstatement, may be debarred for up to five (5) years. The City, as a further sanction, may terminate or cancel any other contracts with such individual, corporation, or entity. Such individual or entity shall be responsible for all direct or indirect costs associated with termination or cancellation, including attorney's fees.

31. **ACCESS AND AUDIT OF RECORDS**

The City reserves the right to require the selected Proposer to submit to an audit by an auditor of the City's choosing at the selected Proposer's expense. The selected Proposer shall provide access to all of its records, which relate directly or indirectly to this contract, at its place of business during regular business hours. The selected Proposer shall retain all records pertaining to this contract, and upon request, make them available to the City for three (3) years following expiration of the contract. The selected Proposer agrees to provide such assistance as may be necessary to facilitate the review or audit by the City to ensure compliance with applicable accounting and financial standards.

32. **OFFICE OF THE INSPECTOR GENERAL**

Palm Beach County has established the Office of the Inspector General, which is authorized and empowered to review past, present, and proposed County programs, contracts, transactions, accounts and records. The Inspector General (IG) has the power to subpoena witnesses, administer

oaths, require the production of records, and monitor existing projects and programs. The Inspector General may, on a random basis, perform audits on all City contracts.

33. **PRE-AWARD INSPECTION**

The City may conduct a pre-award inspection of the Proposer's premises or hold a pre-award qualification hearing to determine if the Proposer is capable of performing the requirements of this Solicitation.

34. **PROPRIETARY/CONFIDENTIAL INFORMATION**

Proposers are hereby notified that all information submitted as part of, or in support of, Proposal submittals will be available for public inspection after the opening of Proposals in compliance with Chapter 119 of the Florida Statutes; popularly known as the "Public Record Law." The Proposer shall not submit any information in response to this Solicitation that Proposer considers a trade secret, proprietary, or confidential. The submission of any information to the City in connection with this Solicitation shall be deemed conclusively to be a waiver of any trade secret or other protection that would otherwise be available to the Proposer. In the event that the Proposer submits information to the City in violation of this restriction, either inadvertently or intentionally, and clearly identifies that information in the Proposal as protected or confidential, the City may, in its sole discretion, either (a) communicate with the Proposer in writing in an effort to obtain the Proposer's withdrawal of the confidentiality restriction, or (b) endeavor to redact and return that information to the Proposer as quickly as possible, and if appropriate, evaluate the balance of the Proposal. The redaction or return of information pursuant to this clause may render a Proposal non-responsive.

35. **HEALTH INSURANCE PORTABILITY AND ACCOUNTABILITY ACT (HIPAA)**

Any person or entity that performs or assists the City of Delray Beach with a function or activity involving the use or disclosure of "individually

identifiable health information (IIHI) and/or Protected Health Information (PHI) shall comply with the Health Insurance Portability and Accountability Act (HIPAA) of 1996. HIPAA mandates for privacy, security, and electronic transfer standards include, but are not limited to:

- a. Use of information only for performing services required by the contract or as required by law;*
- b. Use of appropriate safeguards to prevent non-permitted disclosures;*
- c. Reporting to the City of Delray Beach any non-permitted use or disclosure;*
- d. Assurances that any agents and subcontractors agree to the same restrictions and conditions that apply to the Proposer and reasonable assurances that IIHI/PHI will be held confidential;*
- e. Making Protected Health Information (PHI) available to the customer;*
- f. Making PHI available to the customer for review and amendment, and incorporating any amendments requested by the customer;*
- g. Making PHI available to the City of Delray Beach for an accounting of disclosures; and*
- h. Making internal practices, books, and records related to PHI available to the City of Delray Beach for compliance audits.*

PHI shall maintain its protected status regardless of the form and method of transmission (paper records and/or electronic transfer of data). The selected Proposer must give its customers written notice of its privacy information practices, including specifically, a description of the types of uses and disclosures that would be made with protected health information.

36. **ADDITIONAL FEES AND SURCHARGES**

Unless provided for in the contract/agreement, the City will not make any additional payments such as fuel surcharges, demurrage fees, or delay-in-delivery charges.

37. **COMPLIANCE WITH FEDERAL STANDARDS**

All items to be purchased under this contract shall be in accordance with all governmental standards, to include, but not be limited to, those issued by the Occupational Safety and Health Administration (OSHA), the National Institute of Occupational Safety Hazards (NIOSH), and the National Fire Protection Association (NFPA).

38. **COMPLIANCE WITH FEDERAL REGULATIONS DUE TO USE OF FEDERAL FUNDING**

If the goods or services to be acquired under this Solicitation are to be purchased, in part or in whole, with Federal funding, it is hereby agreed and understood that Section 60-250.4, Section 60-250.5, and Section 60-741.4 of Title 41 of the United States Code, which addresses Affirmative Action requirements for disabled workers, is incorporated into this Solicitation and resultant contract by reference.

39. **BINDING EFFECT**

All of the terms and provisions of this contract/agreement, whether so expressed or not, shall be binding upon, inure to the benefit of, and be enforceable by the parties and their respective legal representatives, successors, and permitted assigns.

40. **SEVERABILITY**

In the event any term or provision of any contract or agreement entered into pursuant to this Solicitation is found by a court of competent jurisdiction to be invalid, the remaining terms and provisions shall continue to be effective and shall be interpreted and given meaning to the greatest possible extent in the absence of any severed terms or provisions.

41. **GOVERNING LAW AND VENUE**

This contract and all transactions contemplated by this agreement shall be governed by and construed and enforced in accordance with the laws of the State of Florida without regard to any contrary conflicts of law principle. Venue of all proceedings in connection herewith shall lie exclusively in Palm Beach County, Florida, and each party hereby waives whatever its respective rights may have been in the selection of venue.

42. **ATTORNEY'S FEES**

It is hereby understood and agreed that in the event any lawsuit in the judicial system, federal or state, is brought to enforce compliance with this contract or interpret same, or if any administrative proceeding is brought for the same purposes, each party shall pay their own attorney's fees and costs, including appellate fees and costs.

43. **EQUAL OPPORTUNITY AND ANTI-DISCRIMINATION**

The City of Delray Beach complies with all laws prohibiting discrimination on the basis of age, race, gender, religion, creed, political affiliation, sexual orientation, physical or mental disability, color or national origin, and therefore is committed to assuring equal opportunity in the award of contracts and encourages small, local, minority, and female-owned businesses to participate.

During the performance of this contract, the selected Proposer agrees it will not discriminate or permit discrimination in its hiring practices or in its performance of the contract. The selected Proposer shall strictly adhere to the equal employment opportunity requirements and any applicable requirements established by the State of Florida, Palm Beach County, and the federal government.

The selected Proposer further acknowledges and agrees to provide the City with all information and documentation that may be requested by the City from time to time regarding the Solicitation,

selection, treatment, and payment of subcontractors, suppliers, and Proposers in connection with this contract.

44. AVAILABILITY OF CONTRACT TO OTHER CITY DEPARTMENTS

It is agreed and understood that any City department or agency may access this contract and purchase the goods or services successful herein. Each City department will issue a separate purchase order to the selected Proposer for the department's specific purchases.

45. CRIMINAL HISTORY BACKGROUND CHECKS

Prior to hiring a contract employee or contracting with a Proposer, the City may conduct a comprehensive criminal background check by accessing any Federal, State, or local law enforcement database available. The contract employee or Proposer will be required to sign an authorization for the City to access criminal background information. The costs for the background checks shall be borne by the City.

46. LABOR, MATERIALS, AND EQUIPMENT

Unless specified elsewhere in the Solicitation or resultant contract, all labor, materials, and equipment required for the performance of the requirements of the contract shall be supplied by the selected Proposer.

47. MINIMUM WAGE REQUIREMENTS

The selected Proposer shall comply with all minimum wage requirements, such as Living Wage requirements, minimum wages based on Federal Law, minimum wages based on the Davis-Bacon Act, and the provisions of any other employment laws, as may be applicable to this contract.

48. PACKING SLIP AND DELIVERY TICKET

A packing slip and/or delivery ticket shall accompany all items delivered to the City. The documents shall include information on the contract number or purchase order, any back-order items, and the number or quantity of items being delivered.

49. PURCHASE OF OTHER ITEMS

The City reserves the right to purchase other related goods or services, not listed in the Solicitation, during the contract term. When such requirements are identified, the City may request a price quote from the selected Proposer on the contract. The City, at its sole discretion, will determine if the prices offered are reasonable, and may choose to purchase the goods or services from the selected Proposer, another contract Proposer, or a non-contract Proposer.

50. PUBLIC RECORDS

Florida law provides that municipal records shall at all times be available to the public for inspection. Chapter 119, Florida Statutes, the Public Records Law, requires that all material submitted in connection with a Proposal response shall be deemed to be public record subject to public inspection upon award, recommendation for award, or thirty (30) days after Proposal opening, whichever occurs first. Certain exemptions to public disclosure are statutorily provided for in Section 119.07, Florida Statutes. If the Proposer believes any of the information contained in his/her/its Proposal is considered confidential and/or proprietary, inclusive of trade secrets as defined in Section 812.081, Florida Statutes, and is exempt from the Public Records Law, then the Proposer must, in its response, specifically identify the material which is deemed to be exempt and state the legal authority for the exemption. All materials that qualify for exemption from Chapter 119, Florida Statutes or other applicable law must be submitted in a separate envelope, clearly identified as "EXEMPT FROM PUBLIC DISCLOSURE" with the firm's name and the Proposal number clearly marked on the outside. The City will not accept Proposals when the entire Proposal is labeled as exempt from disclosure. The City's determination of whether an exemption applies shall be final, and the Proposer agrees to defend, indemnify, and hold harmless the City and the City's officers, employees, and agents against any loss or damages incurred by any person or entity

as a result of the City's treatment of records as public records.

The selected Proposer(s) shall keep and maintain public records and fully comply with the requirements set forth at Section 119.0701, Florida Statutes, as applicable; failure to do so shall constitute a material breach of any and all agreements awarded pursuant to this Solicitation.

51. CONFLICTS OF INTEREST

All Proposers must disclose with their Proposal the name of any officer, director, or agent who is also an employee of the City of Delray Beach. Further, all Proposers must disclose the name of any City employee who has any interest, financial or otherwise, direct or indirect, of five percent (5%) or more in the Proposers' firm or any of its branches. Failure to disclose any such affiliation will result in disqualification of the Proposer from this Solicitation and may be grounds for further disqualification from participating in any future Solicitations with the City.

52. PUBLIC ENTITY CRIMES

As provided in Section 287.133(2) (a), Florida Statutes, a person or affiliate who has been placed on the convicted Proposers list following a conviction for a public entity crime may not submit a Proposal on a contract to provide any goods or services to a public entity; may not submit a Proposal on a contract with a public entity for the construction or repair of a public building or public work; may not submit Proposals on leases of real property to a public entity; may not be successful or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity.

53. OTHER GOVERNMENTAL AGENCIES

If a Proposer is successfully awarded a contract as a result of this Solicitation, the Proposer shall allow other governmental agencies to access this contract and purchase the goods and services under the terms and conditions at the prices awarded.

54. COMPLETION OF WORK AND DELIVERY

All work shall be performed and all deliveries made in accordance with good commercial practice. The work schedule and completion dates shall be adhered to by the selected Proposer, except in such cases where the completion date will be delayed due to acts of nature, force majeure, strikes, or other causes beyond the control of the selected Proposer. In these cases, the selected Proposer shall notify the City of the delays in advance of the original completion so that a revised delivery schedule can be appropriately considered by the City.

55. FAILURE TO DELIVER OR COMPLETE WORK

Should the selected Proposer fail to deliver or complete the work within the time stated in the contract, it is hereby agreed and understood that the City reserves the authority to cancel the contract with the selected Proposer and secure the services of another Proposer to purchase the items or complete the work. If the City exercises this authority, the City shall be responsible for reimbursing the selected Proposer for work that was completed and items delivered and accepted by the City in accordance with the contract specifications. The City may, at its option, demand payment from the selected Proposer, through an invoice or credit memo, for any additional costs over and beyond the original contract price that were incurred by the City as a result of having to secure the services of another Proposer.

56. CORRECTING DEFECTS

The selected Proposer shall be responsible for promptly correcting any deficiency, at no cost to the City, within three (3) calendar days after the City notifies the selected Proposer of such deficiency in writing. If the selected Proposer fails to correct the defect, the City may (a) place the selected Proposer in default of its contract; and/or (b) procure the products or services from another source and charge the selected Proposer for any additional costs that are incurred by the City for this work or items, either through a credit memorandum or through invoicing.

57. **ACCIDENT PREVENTION AND BARRICADES**
Precautions shall be exercised at all times for the protection of persons and property. All selected Proposers performing services or delivering goods under this contract shall conform to all relevant OSHA, State, and County regulations during the course of such effort. Any fines levied by the above-mentioned authorities for failure to comply with these requirements shall be borne solely by the selected Proposer. Barricades shall be provided by the selected Proposer when work is performed in areas traversed by persons, or when deemed necessary by the City.
58. **OMISSIONS IN SPECIFICATIONS**
The scope of services or description of items contained within this Solicitation describes the various functions and classes of work required as necessary for the completion of the project. Any omissions of inherent technical functions or classes of work within the specifications and/or statement of work shall not relieve the Proposer from furnishing, installing, or performing such work where required to the satisfactory completion of the project.
59. **MATERIALS SHALL BE NEW AND WARRANTED AGAINST DEFECTS**
The selected Proposer hereby acknowledges and agrees that all materials, except where recycled content is specifically requested, supplied by the selected Proposer in conjunction with this Solicitation and resultant contract shall be new, warranted for their merchantability, and fit for a particular purpose. In the event any of the materials supplied to the City by the selected Proposer are found to be defective or do not conform to specifications, (1) the materials may be returned to the selected Proposer at the Proposer's expense and the contract cancelled; or (2) the City may require the selected Proposer to replace the materials at the selected Proposer's expense.
60. **TOXIC SUBSTANCES/FEDERAL "RIGHT TO KNOW" REGULATIONS**
The Federal "Right to Know" Regulation implemented by the Occupational Safety and Health Administration (OSHA) requires employers to inform their employees of any toxic substances to which they may be exposed in the workplace, and to provide training in safe handling practices and emergency procedures. It also requires notification to local fire departments of the location and characteristics of all toxic substances regularly present in the workplace.

Accordingly, the selected Proposer performing under this contract is required to provide two (2) complete sets of Material Safety Data Sheets to each City department utilizing any products that are subject to these regulations. This information shall be provided at the time when the initial delivery is made, on a department-by-department basis.
61. **TAXES**
The City of Delray Beach is exempt from Federal and State taxes for tangible personal property.
62. **PROPOSER'S COSTS**
The City shall not be liable for any costs incurred by Proposers in responding to this Request for Qualifications.
63. **SUBSTITUTION OF PERSONNEL**
It is the intention of the City that the selected Proposer's personnel proposed for the contract shall be available for the initial contract term. In the event the selected Proposer wishes to substitute personnel, the selected Proposer shall propose personnel of equal or higher qualifications, and all replacement personnel are subject to the City's approval. In the event the substitute personnel are not satisfactory to the City, and the matter cannot be resolved to the satisfaction of the City, the City reserves the right to cancel the contract for cause.

64. FORCE MAJEURE

The City and the selected Proposer are excused from the performance of their respective obligations under the contract when and to the extent that their performance is delayed or prevented by any circumstances beyond their control, including fire, flood, explosion, strikes or other labor disputes, natural disasters, public emergency, war, riot, civil commotion, malicious damage, act or omission of any governmental authority, delay or failure or shortage of any type of transportation, equipment, or service from a public utility needed for their performance provided that:

- a. The non-performing party gives the other party prompt written notice describing the particulars of the force majeure, including, but not limited to, the nature of the occurrence and its expected duration, and continues to furnish timely reports with respect thereto during the period of the force majeure.*
- b. The excuse of performance is of no greater scope and of no longer duration than is required by the force majeure.*
- c. No obligations of either party that arose before the force majeure causing the excuse of performance are excused as a result of the force majeure.*
- d. The non-performing party uses its best efforts to remedy its inability to perform.*

Notwithstanding the above, performance shall not be excused under this section for a period in excess of two (2) months, provided that in extenuating circumstances, the City may excuse performance for a longer term. Economic hardship of the selected Proposer shall not constitute a force majeure. The term of the contract shall be extended by a period equal to that during which either party's performance is suspended under this section.

65. NOTICES

Notices shall be effective when received at the addresses specified in the contract/agreement. Changes in respective addresses to which such notices are to be directed may be made from time to time by either party by written notice to the other party. Facsimile and email transmissions are acceptable notice effective when received; however, facsimile and email transmissions received after 5:00 p.m. or on weekends or holidays will be deemed received on the next business day. The original of the notice must also be mailed to the receiving party.

Nothing contained in this section shall be construed to restrict the transmission of routine communications between representatives of the selected Proposer and the City of Delray Beach.

66. POOL CONTRACTS

During the term of contracts and agreements that are executed as vendor pools, awarding vendors in prequalified pools of vendors, either as a general pool or by categories, sub-categories, or groups, the City reserves the right to add new vendors to these contracts for goods or services not awarded for the original Solicitation or as part of the general pool category, sub-category or group. To be eligible to be added to these pool contracts, a vendor must meet the same eligibility requirements established in the original Solicitation.

67. FISCAL FUNDING OUT

The City's obligation pursuant to any contract or agreement entered into in accordance with this Solicitation is specifically contingent upon the lawful appropriation of funds. Failure to lawfully appropriate funds for any contract or agreement awarded shall result in automatic termination of the contract or agreement. A non-appropriation event shall not constitute a default or breach of said contract or agreement by the City.

68. *DEBARRED OR SUSPENDED BIDDERS OR PROPOSERS*

The bidder or proposer certifies, by submission of a response to this solicitation, that neither it nor its

principals and subcontractors are presently debarred or suspended by any Federal department or agency.
