A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH ALLIED UNIVERSAL CORP. FOR SODIUM HYPOCHLORITE TO BE USED IN THE CITY'S WATER TREATMENT PLANT UTILIZING THE CITY OF FORT LAUDERDALE INVITATION FOR BID NO. 519-2; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS AND/OR RENEWALS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (the "City") is authorized to enter into agreements to provide products and services in accordance with its Charter; and

WHEREAS, the City requires sodium hypochlorite to be used in the City's Water Treatment Plant; and

WHEREAS, the City of Fort Lauderdale issued Invitation for Bid ("IFB") No. 519-2, to obtain sodium hypochlorite as the lead agency for the Southeast Florida Governmental Cooperative Purchasing Group; and

WHEREAS, in accordance with IFB 519-2, the City of Fort Lauderdale entered into an agreement with Allied Universal Corp. ("Contractor") for the aforementioned products; and

WHEREAS, as a member of the Southeast Florida Governmental Cooperative Purchasing Group, the City desires to obtain the sodium hypochlorite utilizing the terms and conditions of an existing agreement with Contractor pursuant to IFB 519-2; and

WHEREAS, in accordance with Section 46 of the City's Purchasing Policies and Procedures Manual, the City Manager or City Commission shall have the authority to join with other units of government in cooperative purchasing plans, as applicable in accordance with the purchasing criteria set forth herein; and

WHEREAS, the City desires to enter into an agreement with Contractor to obtain the aforementioned products; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:
