## FIRST AMENDMENT TO

Swinton Avenue, Delray Beach, FL 33444 (hereinafter referred to as the "CRA").

## WITNESSETH:

WHEREAS, CRA and CONTRACTOR desire to enter into this First Amendment to the Original Agreement to increase the number of properties to be maintained and to make an adjustment to the Contract Price.

**NOW THEREFORE**, in consideration of the promises, mutual covenants, provisions and undertakings hereinafter contained and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. That the recitals set forth above are true and correct and are incorporated herein by reference.
- 2. That the CRA and the CONTRACTOR agree to amend Exhibit "C" to add two additional properties to be maintained as follows:

106 NW 10th Avenue 12-43-46-17-23-009-0140

- 3. That the CRA and CONTRACTOR agree to amend Article 7 entitled "Contract Price" to include the cost of maintenance of the additional properties for a total contract sum of Ninety Three Thousand Four Hundred Eighty and 00/100 (\$93,480.00).
- 4. That except as amended herein, the CRA and CONTRACTOR ratify, approve and reaffirm the terms of the Original Agreement, and the Original Agreement shall remain in full force and effect, except as amended herein.
- 5. In the event of any conflict or ambiguity by and between the terms and provisions of the Original Agreement and this First Amendment, the terms and provisions of this First Amendment shall control to the extent of any such conflict or ambiguity.
