Hugh Dunkley, the City's Chief Financial Officer, presented an overview of the budgetary performance for the City's major revenue sources and an analysis of each fund and department's year-to-date performance. He stated the total expenditures to date of \$163.8 million for all of the City's

budgeted funds increased by \$23 million from the previous year, due primarily to increases in personal service expenditures as a result of increased salaries and benefits, operating expenditures in the City's Enterprise Fund, purchases of heavy fleet in the City's Central Garage Fund and tax incremental payments to the Community Redevelopment Agency.

The Commission addressed the issue of some water meters still having estimated readings.

Vice Mayor Casale suggested conducting an audit to ensure financial accountability.

There was a consensus to bring this discussion back at the May 21, 2024, Commission Meeting.
