However, the individuals who serve on the boards and committees provide an invaluable service to the city. Their advice and expertise on a wide range of topics assist the City Commission in its decision-making process.

In general, individuals may serve on only one board or committee at a given time, with the exception of ad-hoc committees or task forces. Most advisory groups meet at least once a month, however, there are varying degrees of commitment, depending on the board. Membership requirements vary with each board and committee

Other than my eight-plus years on three advisory boards, my wife and I have restored three historic properties in the Marina Historic District. The city presented us with an award for the restoration work we did at 126-128 SE 7th Ave.

Briefly describe why you wish to serve as a member of a board or committee and how your personal experience and background relate:

I have lived in this town for nearly 40 years and think I would bring a fresh, but seasoned voice to the City Commission. My nearly 25 years of working at The Palm Beach Post -- many of which included supervising coverage of Delray Beach -- taught me to look carefully at both sides of an issue and make decisions untarnished by biases, preconceptions or outside influences. I support reasonable growth as well as working to preserve our dwindling historic resources. My nearly 15 years of historic restoration have made mine a familiar face around city hall and I have a solid understanding of how the city operates.

List any other community/civic involvement which you would like the Commission to consider:

I currently serve as President of the Delray Preservation Trust, a 501(c)(3) non-profit that advocates for the preservation and repurposing of historic places and spaces throughout the city. The Trust has been instrumental in preserving the original campus of the former George Washington Carver High School; preventing a developer from paving a swath of Veterans Park merely to stage his construction and speed up the timetable; saving a threatened Sam Ogren residence and getting it moved to its present site behind the city CRA offices; preserving the threatened iconic Doc's Soft Serve fast-food restaurant in the heart of the city; getting the Old School Square Historic District listed on the National Register of Historic Places; and many others. I am also the Founding Partner of the award-winning The Coastal Star newspaper. The paper won a public service award for exposing the spread of high-priced sober homes along Delray's oceanfront.
