

RESOLUTION NO. 100-25

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN ANNUAL SPECIAL EVENT PERMIT FOR A SERIES OF IMPACT EVENTS KNOWN AS ART & JAZZ ON THE AVENUE 2025 TO BE HELD ON JULY 23, 2025, SEPTEMBER 10, 2025 AND OCTOBER 22, 2025; AUTHORIZING THE CLOSURE OF ATLANTIC AVENUE AND NORTH EAST 2<sup>ND</sup> AVENUE AS MORE PARTICULARLY DESCRIBED HEREIN; AUTHORIZING THE CITY MANAGER TO TAKE ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING FOR AN EFFECTIVE DATE, AND FOR OTHER PURPOSES.

WHEREAS, the City Commission of the City of Delray Beach recognizes the importance of special events and the opportunities they provide to promote community welfare, improve the quality of life of residents and visitors, build a sense of community, provide enriched cultural opportunities, draw visitors to the City and contribute to the local economy; and

WHEREAS, the City of Delray Beach Special Event Policy defines “impact events” as special events that require City Commission approval as a result of certain characteristics such as their potential to significantly disrupt the regular function of the area of the City in which they will be held or their need to close one or more major roadways in the City; and

WHEREAS, the City of Delray Beach, Florida received a Special Event Application (the “Application”) from the Delray Beach Downtown Development Authority seeking approval for an Annual Special Event Permit for the Art & Jazz on the Avenue 2025 Series to be held on July 23, 2025, September 10, 2025, and October 22, 2025 (collectively, the “Event”); and

WHEREAS, the Application requests the closure of portions of Atlantic Avenue and NE 2<sup>nd</sup> Avenue, for the Event; and

WHEREAS, the Application was reviewed and recommended for approval by the City’s Special Event Technical Advisory Committee at their meeting on March 6, 2025; and

WHEREAS, the Application was reviewed and recommended for approval by the City’s Development Services Management Group at their meeting on April 10, 2025; and

WHEREAS, the City Commission has reviewed and considered the impacts to the City of the Event’s requested roadway closures.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The above recitals are incorporated as if fully set forth herein.

Section 2. The City Commission approves an annual permit for the Art & Jazz on the Avenue 2025 Impact Events to be held July 23, 2025, September 10, 2025, and October 22, 2025 finding that the Events provide sufficient public benefits and are consistent with the City's Special Event Policy.

Section 3. The City Commission approves the closure of NE 2<sup>nd</sup> Avenue from East Atlantic Avenue to NE 3<sup>rd</sup> Street on July 23, 2025 for the Art & Jazz on the Avenue event.

Section 4. The City Commission approves the closure of East Atlantic Avenue from Swinton Avenue to NW 5<sup>th</sup> Avenue on September 10, 2025 for the Art & Jazz on the Avenue event.

Section 5. The City Commission approves the closure of East Atlantic Avenue from Seabreeze Avenue to A1A on October 22, 2025 for the Art & Jazz on the Avenue event.

Section 6. The City Commission authorizes the City Manager to take any and all actions necessary to effectuate the intent of this Resolution.

Section 7. This Resolution shall take effect immediately upon its adoption.
