

**SECOND AMENDMENT TO THE INTERLOCAL AGREEMENT BETWEEN  
THE CITY OF DELRAY BEACH AND THE  
DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY  
FOR FUNDING CONSTRUCTION/PROFESSIONAL SERVICES  
FY 2018-2019**

**THIS SECOND AMENDMENT TO THE INTERLOCAL AGREEMENT FOR FUNDING OF CONSTRUCTION/PROFESSIONAL SERVICES ("FIRST AMENDMENT")** is made this \_\_\_\_\_ day of \_\_\_\_\_, 2019, by and between the **CITY OF DELRAY BEACH**, a Florida municipal corporation, (hereinafter referred to as "**CITY**"), and the **DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY**, a public body corporate and politic, duly created and operated pursuant to Chapter 163, Florida Statutes (hereinafter referred to as the "**CRA**").

**W I T N E S S E T H:**

**WHEREAS**, the **CITY** and the **CRA** entered into an Interlocal Agreement for the Funding of Construction/Professional Services for Fiscal Year 2018-2019, on October 16, 2018 (the "Original Agreement"), which provided for funding for construction and professional services for projects within the Community Redevelopment Area; and

**WHEREAS**, on May 7, 2019, the **CITY** and **CRA** entered into the First Amendment to the Original Agreement ("First Amendment") to provide for funding for the S. Swinton Avenue and SW/SE 1<sup>st</sup> Street Mast Arm Traffic Signal Project and the CRA Sidewalk Project; and

**WHEREAS**, the **CRA** and the **CITY** desire to enter into this Second Amendment to the Original Agreement ("Second Amendment") in order to amend **Exhibit "A"** to the Original Agreement to provide for further adjustments to project costs, as well as to eliminate specific projects from the Original Agreement; and

**WHEREAS**, this Second Amendment is consistent with the Community Redevelopment Plan, and serves both a municipal and public purpose.

**NOW, THEREFORE**, in consideration of the mutual covenants and promises herein contained, the parties hereby agree as follows:

1. The recitations set forth above are hereby incorporated herein.
2. The **CRA** and the **CITY** agree to amend **Exhibit "A"** to the Original Agreement to provide for adjustments to project costs, as well as to eliminate projects as provided in **Exhibit "A"** to the Original Agreement, as amended by the First Amendment. The amended **Exhibit "A "** is attached to this Second Amendment, and incorporated herein by reference.

3. All other terms and conditions of the Original Agreement, and the First Amendment, not in conflict with this Second Amendment shall remain in full force and effect.
