

**SECOND AMENDMENT TO THE AGREEMENT FOR PROFESSIONAL ARCHITECTURAL
AND ENGINEERING SERVICES BETWEEN THE DELRAY BEACH COMMUNITY
REDEVELOPMENT AGENCY AND SYNALOVSKI ROMANIK SAYE, LLC
(NW 600 BLOCK-WEST ATLANTIC AVENUE)**

THIS SECOND AMENDMENT TO THE WORK ASSIGNMENT ("Second Amendment") is made and entered into as of the day of 16th of July 2026, by and between the **DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY**, a public agency created pursuant to Section 163, Part III, Florida Statutes, (hereinafter referred to as the "CRA"), and **SYNALOVSKI ROMANIK SAYE, LLC**, a Florida limited liability company (hereinafter referred to as "ARCHITECT").

WITNESSETH:

WHEREAS, the CRA and the ARCHITECT previously entered into an Agreement for Professional Architectural and Engineering Services for a Redevelopment Project for CRA-owned property located at the NW 600 Block - West Atlantic Avenue dated November 30, 2023, (the "Original Agreement"); and

WHEREAS, the CRA and the ARCHITECT previously entered into a First Amendment to the Original Agreement on February 26, 2026, to include additional necessary services related to survey updates and traffic statements and increase the amount of compensation owed; and

WHEREAS, the CRA and the ARCHITECT agree to enter this Second Amendment to amend the Original Agreement to include additional necessary services related to the development of additional plan sheets, and the management of application submittals to the City of Delray Beach for necessary additional work, as more particularly described in Exhibit A; and

WHEREAS, the CRA and the ARCHITECT agree to enter this Second Amendment, to increase the contract amount in an amount not to exceed Twenty-Five Thousand Eight

Hundred Forty Dollars and Zero Cents (\$25,840.00) for a total contract amount not to exceed Six Hundred Seventy-Six Thousand Seven Hundred Ninety Dollars and Zero Cents (\$676,790.00).

NOW THEREFORE, in consideration of the promises, mutual covenants, provisions, and undertakings hereinafter contained, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. That the recitals set forth above are true and correct and are incorporated herein by reference.

2. The CRA and ARCHITECT hereby mutually agree to amend the Original Agreement to include additional necessary services related to the development of additional plan sheets, and the management of application submittals to the City of Delray Beach for necessary additional work, as more particularly described in Exhibit A.

3. The CRA and ARCHITECT hereby mutually agree to amend the Original Agreement to increase the contract amount in an amount not to exceed Twenty-Five Thousand Eight Hundred Forty Dollars and Zero Cents (\$25,840.00) for a total contract amount not to exceed Six Hundred Seventy-Six Thousand Seven Hundred Ninety Dollars and Zero Cents (\$676,790.00).

4. That except as amended herein, the CRA and ARCHITECT ratify, approve, and reaffirm the terms of the Original Agreement, the Work Assignment, and the Work Assignment shall remain in full force and effect, except as amended herein.

5. In the event of any conflict or ambiguity by and between the terms and provisions of the Original Agreement, the First Amendment, and this Second Amendment, this Second Amendment shall control to the extent of any such conflict or ambiguity.
