

RESOLUTION NO. 36-26

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING THE ISSUANCE OF A PURCHASE ORDER TO CMJ EMERGENCY LIGHTING SOUTH LLC; UTILIZING HILLSBOROUGH COUNTY SHERIFF'S OFFICE ITB 2024-025, FOR THE PURCHASE OF EMERGENCY LIGHTS AND ACCESSORIES; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach ("City") is authorized to enter into agreements to provide services, programming and products in accordance with its Charter; and

WHEREAS, the Florida Sheriff's Association ("FSA") administers a cooperative purchasing program wherein it performs the solicitation for a multitude of products and administers the resulting contracts; and

WHEREAS, the Hillsborough County Sheriff's Office has partnered with the FSA to make awarded Contract prices and terms available through the FSA's cooperative purchasing program to any unit of local government and political subdivision or agency of the state of Florida; and

WHEREAS, Hillsborough County Sheriff's Office, issued Invitation to Bid No. 2024-025 for the purchase of emergency lights and accessories; and

WHEREAS, CMJ Enterprises LLC now doing business in the state of Florida as CMJ Emergency Lighting South LLC ("Contractor") as more particularly described in Exhibit A, attached hereto and incorporated herein, was one of the vendors awarded Contract No. FSA-HCS-ESA2.0, pursuant to the solicitation; and

WHEREAS, the City desires to issue a purchase order to Contractor utilizing Hillsborough County Sheriff's Office Contract No. FSA-HCS-ESA2.0, to purchase emergency lighting and accessories to upfit 27 Ford Police Interceptor Units (PIUs) for use by the City of Delray Beach Police Department; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interests of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the foregoing recitals are hereby affirmed and ratified.

Section 2. The City Commission of the City of Delray Beach has reviewed and hereby approves the issuance of a purchase order to Contractor utilizing Hillsborough County Sheriff's Office Contract No. FSA-

HCS-ESA2.0 for the purchase of emergency lighting and accessories to upfit 27 Ford PIUs, as particularly described in Exhibit B, attached hereto and incorporated herein.

Section 3. The City Commission authorizes the City Manager to take any action necessary to effectuate the intent of this Resolution.

Section 4. This Resolution shall become effective immediately upon its passage and adoption.
