She expressed her gratitude to the Commission for contacting her whenever they required assistance. She provided updated Ethics Guides for everyone. The Commission thanked Ms. Giger for her dedicated service to Palm Beach County.

Ms. Smallridge made a presentation highlighting the mission of the Business Development Board of Palm Beach County. She stated that their mission was to recruit, retain, and expand companies in Palm Beach County through roundtable discussions and other forums. She noted that they provide services to all thirty-nine (39) cities within Palm Beach County.

The Commission engaged in a brief discussion on how Delray Beach ranks in the economic development of Palm Beach County.

Ms. Smallridge noted that Downtown Delray Beach plays a critical role in Palm Beach County's economic development. She stated that having A-rated schools would be essential for business relocations.

The Commission thanked Ms. Smallridge for her time.

Kent Edwards, Sustainability Officer, and Christian Chitester, Sustainability Coordinator, presented a preliminary draft of the City's Climate Action Plan. Mr. Edwards stated that a survey conducted a year earlier revealed that 80% of the City's residents supported the implementation of a Citywide Climate Action Plan. He provided examples of how the City and the community could begin implementing this plan across City-sponsored

projects and neighborhoods.

Mr. Edwards noted the Dune Restoration Management Plan and the Tree Planting Program as key improvements to the Climate Action Plan. He emphasized the advantages of having an Arborist on staff and discussed the potential implementation of a city-wide water conservation program. Mr. Edwards acknowledged that any modifications would need approval from the Commission for budgetary considerations.

The Commission thanked Mr. Edwards and Mr. Chitester for their work.

#### **5.A.1. APPROVAL TO INITIATE REQUEST FOR JURISDICTIONAL TRANSFER OF WEST ATLANTIC AVENUE (STATE ROAD 806) FROM NW/SW 12TH AVENUE TO N/S SWINTON AVENUE FROM THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) TO THE CITY OF DELRAY BEACH**

Mr. Moore briefly discussed the item which concerns the City acquiring several segments of Atlantic Avenue from Florida Department of Corrections (FDOT.) He expressed that he believes this is a positive idea.

Missie Barletto, Director of Public Works, stated that on January 30, 2025, and March 7, 2025, the City of Delray Beach Public Works Department and FDOT staff met to discuss the possibility of transferring ownership of several segments of Atlantic Avenue within Delray Beach city limits. Ms. Barletto stated that since then, FDOT has been willing to officially begin negotiations for the transfer of West Atlantic Avenue (State Road 906) from NW/SW 12th Avenue to N/S Swinton Avenue from the FDOT to the City of Delray Beach. She mentioned that the City already performs a great deal of the maintenance. She explained further that approving this item would align with the City's redevelopment plans for projects, including the Set Transformation Plan and the Community Redevelopment Agency's Expansion Plan. Ms. Barletto stated that this evening's presentation was to secure the Commission's permission to move forward with preliminary negotiations and to have the Mayor sign a letter asking FDOT to begin the process formally.

The Commission engaged in a discussion about the costs of assuming the proposed area of land.

Ms. Barletto stated that since there have been no negotiations yet, there were no concrete facts regarding the actual costs involved. The Commission agreed that moving forward with this plan has been overdue.

There was consensus for the Mayor to send a letter granting permission to proceed with the proposed project.

During the discussion of this item, Mr. Moore added the following comments:

- Announced that Delray Beach received the Blue Flag Beach Designation Award for the third consecutive year. He also noted that on Thursday, May 1, 2025, at 10:00 a.m., there would be a waterfront celebration.

- Mentioned there would be a community engagement session on Thursday, April 24, 2025, at 6:00 p.m., which will be held at the Delray Beach Municipal Golf Course Clubhouse.

- Announced that the City of Delray Beach has confirmed its bid for the Davis Cup through the Palm Beach County Sports Commission.
