## RESOLUTION NO. 227-25

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING THE ISSUANCE OF A PURCHASE ORDER TO TRADEWINDS POWER CORP NORTH; UTILIZING FLORIDA SHERIFF'S ASSOCATION CONTRACT NO. FSA23-EQU21.0 FOR THE PURCHASE OF FOUR MOBILE GENERATORS AND TWO LOAD BANK TESTERS; AUTHORIZING THE CITY MANAGER TO TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach ("City") is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the Florida Sheriff's Association (FSA) administers a Cooperative Purchasing Program wherein it performs the solicitation for a multitude of products and administers the resulting contracts; and

WHEREAS, the prices or bids of the awarded vendors are extended and guaranteed to the Florida Sheriff's Association along with any unit of local government, political subdivision, or agency of the State of Florida; and

WHEREAS, the Florida Sheriff's Association issued solicitation FSA23-EQU21.0 to obtain vendors for a variety of all-terrain and utility vehicles, generators, and construction equipment; and

WHEREAS, Tradewinds Power Corp North is one of the vendors that was awarded Contract No. FSA23-EQU21.0; and

WHEREAS, the City desires to issue a purchase order to Tradewinds Power Corp North, utilizing the Florida Sheriff's Association Contract No. FSA23- EQU21.0, in order to purchase four (4) mobile generators and two (2) load bank testers; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

- Section 1. The foregoing recitals are hereby affirmed and ratified.
- Section 2. The City Commission of the City of Delray Beach has reviewed and hereby approves the issuance of purchase orders to Tradewinds Power Corp North for four (4) mobile generators and two (2) load bank testers utilizing the Florida Sheriff's Association Contract No. FSA23-EQU21.0, which is attached to this Resolution as Exhibit "A"
- <u>Section 3</u>. The City Commission authorizes the City Manager to take any and all actions necessary to effectuate the intent of this Resolution.

Section 4. This Resolution shall become effective immediately upon adoption.
