THIS AMENDMENT NO. 1 to Unleaded Gasoline and Diesel Fuel dated October 10, 2022, by and between City of Delray Beach, a municipal corporation of the State of Florida (hereinafter referred to as “City”), and Mansfield Oil Company of Gainesville, Inc. (hereinafter referred to as “Contractor”) a Georgia corporation authorized to do business in the State of Florida, is entered into this ____ day of _____, 2023.

WITNESSETH:

WHEREAS, on October 10, 2022, the City entered into a five (5) year agreement with Contractor for services (hereinafter referred to as the “Agreement”); and

WHEREAS, the City and Contractor desire to revise the Agreement to amend the Pricing Schedule to add a location; and

WHEREAS, the City has reviewed and agrees with such revisions; and

WHEREAS, Contractor agrees to continue to provide services to City in accordance with the terms and conditions of the Agreement.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.
2. The Agreement is hereby amended to include the attached Composite Exhibit “A” as a new Exhibit “C” to the Agreement.
3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby ratified and confirmed. The Agreement, Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.

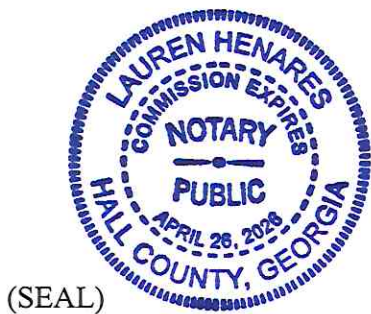
