QUESTIONS AND RESPONSES:

Q1. Bid Sheet sample in spec package does not provide items for the wood alternate or the fiber reinforcing alternate, are they deleted?

R1. No, the referenced items are not deleted. Alternate Item Nos. 13 and 14 are added per this Addendum No. 1.

Q2. The note on Sheet No. S1.0 calls for all rebar galvanized. Sheet S4.0 specifies only the epoxied U bar galvanized. Please clarify which is correct.

R2. All rebar is to be galvanized for the base bid, and FRP alternate includes the U bars to be steel and to be galvanized. The FRP option has the FRP bars straight and the galvanized U bars combined.

Q3. What concrete mix design is required for the ramp concrete?

R3. The same concrete used for the cap should be used for the ramp.

Q4. Clarify the wall thickness for the 12" Super Pile.

R4. The wall thickness is ½ inch.

Q5. Clarify what type of resin (Isophthalic Polyester, or Isophthalic Polyester FR, or Vinylester FR) is to be used for the FRP Wide Flange Beams and Channels.

R5. Resin is to be Isophthalic Polyester.

Q6. Sheet No. S4.2 states the following: Proposed 12" diameter X 30 ft long Fiber Reinforced Polymer Piling. What is the specified wall thickness of the 12" Super Pile?

R6. Refer to the response for Question 4.

Q7. Sheet No. S4.2 states the following: Proposed (3) 8" by 8" by ½" Wide Flange Polymer Beams by Fibergrate or Engineer approved equal.

A. What resin is required for this product? The manufacturer has multiple resins available with different characteristics for each.

B. Is there a specified color of these structural members? (Note: We have been advised by Creative Pultrusions that they usually make the Wide Flange beams for Fibergrate)

R7. A. Resin is to be Isophthalic Polyester.

B. Yes, there will be a specified color. The City will notify the Successful Contractor of the specified color.

Q8. Sheet No. S4.2 states the following: Proposed 8" by 2 3/16" by 3/8" FRP Channel (1) each side by Fibergrate or Engineer approved equal.

A. What resin is required for this product? The manufacturer has multiple resins available with different characteristics for each.

B. Is there a specified color of these structural members?

R8. A. Resin is to be Isophthalic Polyester.

B. Yes, there will be a specified color. The City will notify the Successful Contractor of the specified color.

Q9. Sheet No. S4.2 states the following: Proposed 2 X 6 FRP Deck Boards. What is the desired color of the deck?

R9. The City will notify the Successful Contractor of the specified color.
