Municipality Comparison

Broward County

F-121.2.7 Residential occupancy:

- a) All hotels and motels.
- b) Multi-story residential buildings with five (5) floors or more. Residential elevators supplying services to an independent dwelling unit only shall be exempt from this requirement.

F-121.2.7.1 Multi-story residential occupancies listed above shall place an AED and BCK at every building entrance lobby no further than 15 feet from any elevator. The AHJ can modify the requirements of F-121.2.7 requirements based on the footprint of the residential building.

Coral Springs

Sec 7-201 (4) *Automated external defibrillator and bleeding control kits required.*

(A) Automated external defibrillators and regular bleeding control kits shall be installed as described in Broward County Local Amendments to the Florida Fire Prevention Code, Section F-121, as amended from time to time, and at all city-owned pools.



Municipality Comparison

Parkland

Section 14-3 (4) Automated external defibrillator devices and bleeding control kits required.

7. Multi-story occupancies listed in subsections 1. through 6. and/or multi-story office buildings shall place an AED on every other floor beginning on the first floor. The AED shall be placed near the elevator(s) beginning in the first floor lobby (first floor, third floor, etc.).

Sunrise

Sec 6-98 (a) Automated external defibrillator devices and bleeding control kits shall be installed in the following buildings located within the geographical boundaries of the city:
(3) All hotels and motels.

Sec 6-99 (5) Placed near the elevator(s) in the first floor lobby, if the building contains an elevator.



Municipality Comparison

Miramar

- Placed near the elevator(s) on every floor of the building, if the building contains an elevator. If the building does not have an elevator, the automated external defibrillator shall be placed in the area of the main entrance;
- AEDs shall be located **on each floor** such that the maximum length of travel measured from the most remote point on a floor to any automated external defibrillator, shall not exceed 250 feet;
- AEDs shall be located on each floor such that the maximum length of travel between any two automated external defibrillators shall not exceed 500 feet;

Davie

- *[Multi story occupancies:]* Multi story occupancies listed above shall place an AED and SBK on every other floor beginning on the first floor. The AED and SBK shall be placed near the elevator(s) beginning in the first floor lobby. (first floor, third floor, fifth floor, etc.).
- Residential/dorm buildings if 7 stories or above



Which occupancies will be required to comply?

- (1) Fitness centers, gymnasiums, and indoor recreational centers in excess of one thousand five hundred (1,500) square feet.
- (2) Theaters, restaurants, drinking establishments, with a capacity of one hundred (100) or greater.
- (3) Places of worship with a capacity of one hundred (100) or greater.
- (4) Commercial, Retail, Office buildings and any business occupancies with a square footage greater than twenty thousand (20,000) square feet.
- (5) All Dental offices in accordance with Florida Administrative Code 64B5-17.015.
- (6) All adult day care facilities
- (7) All charter and private schools.
- (8) Assisted living facilities as defined by section 429.021(5) Florida Statute as amended from time to time



Which occupancies will be required to comply?

- (9) Ambulatory surgical centers as defined by F.S. § 395.002(3) as amended from time to time;
- (10) Walk in medical care facilities;
- (11) Hospitals providing emergency services, including freestanding facilities, shall be excluded;
- (12) All hotels and motels; and
- (13) Multi-story residential/dormitory buildings five (5) floors or more.



How will we confirm
compliance?

Delray Beach Fire Rescue Fire and Life Safety Division will confirm compliance during the occupant's annual fire inspection.

We allowed an 18-month grace period to comply with this ordinance. During that time-frame we educated the affected occupancies of the ordinance addition.

January 1, 2026 we have begun enforcement.

There will be no additional fee for us to check for compliance



Business Impact Estimate

This ordinance will impact approximately 700 occupancies in our city.

Each AED and Bleeding control kit should cost about \$1,500.

DBFR will provide training for anyone upon request.
