Hugh Dunkley, Finance Director, provided the Quarterly Financial Review through June 30, 2023, and a Flash Report through August 31, 2023, reporting the Total Citywide Budget by Fund Type was \$398,892,51.He stated the total expenditures to date (\$266,326,888) for all the City's budgeted funds increased by \$14.2 million from the previous year, due primarily to increases in ad valorem tax revenue, increased water and sewer utility, and sanitation revenue due to rate adjustments; as well as increased user charges to participating departments by the internal service funds (Insurance and Central Garage).
