I was a CPA for 30 years and Florida licensure for circa 20+ (1982-2004).

**Briefly describe why you wish to serve as a member of a board or committee and how your personal experience and background relate:**

---

For the past 15+ years, I have been an outspoken advocate for the best interests of Delray citizens and taxpayers. (1)- I spearheaded the overturning of the No Bid WM contract which the OIG stated saved trash customers \$9M, (2)- I blew up the attempted Auburn Trace debacle on 3/18/14 which could have cost taxpayers a \$4M rip off concocted by former Commissioners Jacquet, Frankel, and Gray, (3)- I filed the Otto Trash cart complaint with the OIG on 1/22/14 which resulted in former CM Louie Chapman perjuring himself 8 times to which he readily admitted to 4, (4)- I exposed the No Bid lifeguard tower contract that cost \$150K per tower. Two years later, the contractor bid and won the Hollywood contract for \$90K per tower, and (5)- I exposed the 4 open and unresolved Whistle Blower complaints against new Fire Chief Martin that your HR Dept. never uncovered or disclosed to the Commission. Also, he resigned with -0- notice to his 30 year employer. As recently as this past week, I exposed Cmmr. Long's attempt to return to a Super Majority vote to remove the CM with the historical details why it was removed.

**List any other community/civic involvement which you would like the Commission to consider:**

I was a Time Share owner of 50 year old run down property (1625 S. Ocean). I got on the Board in 2019 and orchestrated an owner vote of 498-156 to sell it. Mayor Carney represented the buyer. Twice I had to correct pro ration errors on his pro forma HUD-1s. But here is what I initiated for DB taxpayers. The PAPA taxable value as a Timeshare was a paltry \$1.5M. When Carney's client bought the land fro \$12.3M, the Taxable Value was increased to \$10M, a 600% increase. Carney's buyer constructed and sold 14 condos that have a Taxable Value greater than \$70M- a 4600% increase. Unit owners received \$16,000 for each week owned which I was told was a state record. So, I spearheaded big wins for the unit owners AND Delray taxpayers!
