RESOLUTION NO. 84 -24

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, PARTIALLY REPEALING RESOLUTION 26-24 REVOKING APPROVED PURCHASE ORDERS TO ALAN JAY FORD LINCOLN MERCURY, INC., TO ACQUIRE FIVE 2024 TOYOTA HIGHLANDER VEHICLES AND TO AMERI-RECREATIONAL SPORTS, LLC, TO ACQUIRE FOUR 2024 POLARIS SPORTSMAN 850S AND APPROVING PURCHASE ORDERS TO ALAN JAY CHEVROLET CADILLAC UTILIZING SOURCEWELL CONTRACTS NO. 091521-NAF TO ACQUIRE FIVE 2024 CHEVY TRAVERSE VEHICLES AND TO AMERI-RECREATIONAL SPORTS, LLC, UTILIZING FLORIDA SHERIFF'S ASSOCIATION CONTRACTS NO. FSA23-EQU21.0 TO ACQUIRE FOUR 2024 YAMAHA KODIAKS; AUTHORIZING THE CITY MANAGER TO TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (the "City") is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, Sourcewell and the Florida Sheriff's Association ("FSA") administer cooperative purchasing programs for a multitude of products; and

WHEREAS, contracts solicited by Sourcewell are accessible to municipal government entities; and

WHEREAS, Sourcewell issued RFP No. 031121-DAC to obtain vendors for grounds maintenance equipment and RFP No. 091521-NAF for cars, trucks, vans, SUVs, cab chassis, and other vehicles; and

WHEREAS, Alan Jay Ford Lincoln Mercury, Inc., and Alan Jay Chevrolet Cadillac are two of the vendors awarded a contract under Sourcewell RFP No. 091521-NAF; and

WHEREAS, the prices and bids awarded by FSA are extended and guaranteed to any unit of local government; and

WHEREAS, FSA issued solicitation FSA23-EQU21.0 to obtain vendors for equipment and FSA23-VEL31.0 for pursuit, administrative, and other vehicles; and

WHEREAS, Ameri-Recreational Sports, LLC, is a vendor awarded a contract under FSA23-EQU21.0; and

WHEREAS, at the January 4, 2024, meeting, City Commission approved Resolution No. 26-24, approving the issuance of multiple purchase orders to acquire vehicles and pieces of equipment utilizing Sourcewell Contracts 091521-NAF and 031121-DAC and FSA Contracts FSA23-VEL31.0 and FSA23-EQU31.0; and

WHEREAS, the approved purchase orders included the acquisition of five 2024 Toyota Highlander

vehicles from Alan Jay Ford Lincoln Mercury, Inc., utilizing Sourcewell Contract 091521-NAF, and four Polaris Sportsman 850s from Ameri-Recreational Sports, LLC, utilizing FSA Contract FSA23-EQU21.0; and

WHEREAS, Alan Jay Ford Lincoln Mercury does not have any 2024 Toyota Highlander vehicles in its existing inventory, and Ameri-Recreational Sports, LLC, is not authorized to sell Polaris Sportsman 850s in the geographical area encompassing the City; and

WHEREAS, the City desires to repeal the purchase orders to Alan Jay Ford Lincoln Mercury to acquire the Toyota Highlander vehicles and Ameri-Recreational Sports, LLC, to acquire the Polaris Sportsman 850s approved by Resolution No. 26-24, and approve new purchase orders to Alan Jay Chevrolet Cadillac utilizing Sourcewell Contact No. 091521-NAF to purchase five 2024 Chevy Traverse vehicles and to Ameri-Recreational Sports, LLC, utilizing FSA23-EQU21.0 to purchase four Yamaha Kodiaks; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interests of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> That the foregoing recitals are hereby affirmed and ratified.

<u>Section 2.</u> The City Commission hereby partially repeals Resolution No. 26-24, revoking the approved purchase orders to Alan Jay Ford Lincoln Mercury to acquire five 2024 Toyota Highlander vehicles and to Ameri-Recreational Sports, LLC, to acquire four Polaris Sportsman 850s.

<u>Section 3.</u> The City Commission of the City of Delray Beach has reviewed and hereby approves the issuance of a purchase order to Alan Jay Chevrolet Cadillac utilizing Sourcewell Contact No. 091521-NAF to purchase five 2024 Chevy Traverse vehicles and to Ameri-Recreational Sports, LLC, utilizing FSA23-EQU21.0 to purchase four Yamaha Kodiaks.

<u>Section 4.</u> The City Commission authorizes the City Manager to take any action necessary to effectuate this Resolution.

<u>Section 5.</u> This Resolution shall become effective immediately upon its passage and adoption.
