7.A. Atlantic Avenue, Pineapple Grove, W. Atlantic Avenue and beach side neighborhoods.

Mr. Skeberis confirmed that the upcoming Martin Luther King march will continue as previously approved with rolling road closures.

Ms. Behrman explained that SETAC approves City Events.

Mr. Metott stated all events are different and rolling road closures is a good option for walks and marches but no event is 100% safe.

Ms. Barletto mentioned the recent tragedy at an event in New Orleans and noted that they have hydraulic bollards, but they weren't working that day, underlying the necessary maintenance with such safety mechanisms.

Ms. Gianniotis noted that Atlantic can't be closed as it's the main connection to the Barrier Island.

Mr. Tobias recommended the City's First Responders make suggestions to the Development Services Management Group for future discussion.

Mr. Metott offered that First Responders haven't received much feedback from DSMG because safety has been on target.

Mr. Oris noted that when SETAC can't approve administratively, events are presented to the Development Services Management Group.

Ms. Barletto added that the Public Safety department has final say.

Ms. Simon stated the Downtown Development Authority worked with the Development Services Management Group to establish the Special Events Policy in 2013.

The Board Discussed the City required FEMA training.
