If any clause, section, or other part of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered as eliminated and shall in no way affect the validity of the remaining portions of this Resolution.
- 4. All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.
- 5. This Resolution shall become effective immediately upon its passage and adoption.
