A RESOLUTION OF THE DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY ADOPTING AMENDMENT NUMBER TWO TO THE BUDGET FOR THE FISCAL YEAR OCTOBER 1, 2022 TO SEPTEMBER 30, 2023; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING FOR AN EFFECTIVE DATE

W I T N E S S E T H:

WHEREAS, on September 29, 2022, the Delray Beach Community Redevelopment Agency Board of Commissioners (“Board”) adopted the Budget for the Fiscal Year 2022-2023;

WHEREAS, on June 1, 2023, the Board adopted Budget Amendment No. 1 to the Budget for the Fiscal Year 2022-2023;

WHEREAS, the Board desires to amend the Budget for the Fiscal Year 2022-2023 to reflect appropriations to be made during the Fiscal Year 2022-2023, which amended budget is attached hereto as **Exhibit “1”**, and incorporated herein by reference (“Budget Amendment No. 2”);

WHEREAS, the Delray Beach Community Redevelopment Agency Board of Commissioners finds that Budget Amendment No. 2 is in the public’s interest and it is necessary to implement its goals and objectives.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY THAT:

1. Each "WHEREAS" clause set forth above is true and correct and herein incorporated by this reference.

2. The Budget Amendment No. 2 to the 2022-2023 Fiscal Year Budget, which is attached hereto as **Exhibit “1”**, and incorporated herein by reference is hereby adopted.

3. If any clause, section, or other part of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered as eliminated and shall in no way affect the validity of the remaining portions of this Resolution.

4. All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

5. This Resolution shall become effective immediately upon its passage and adoption.
