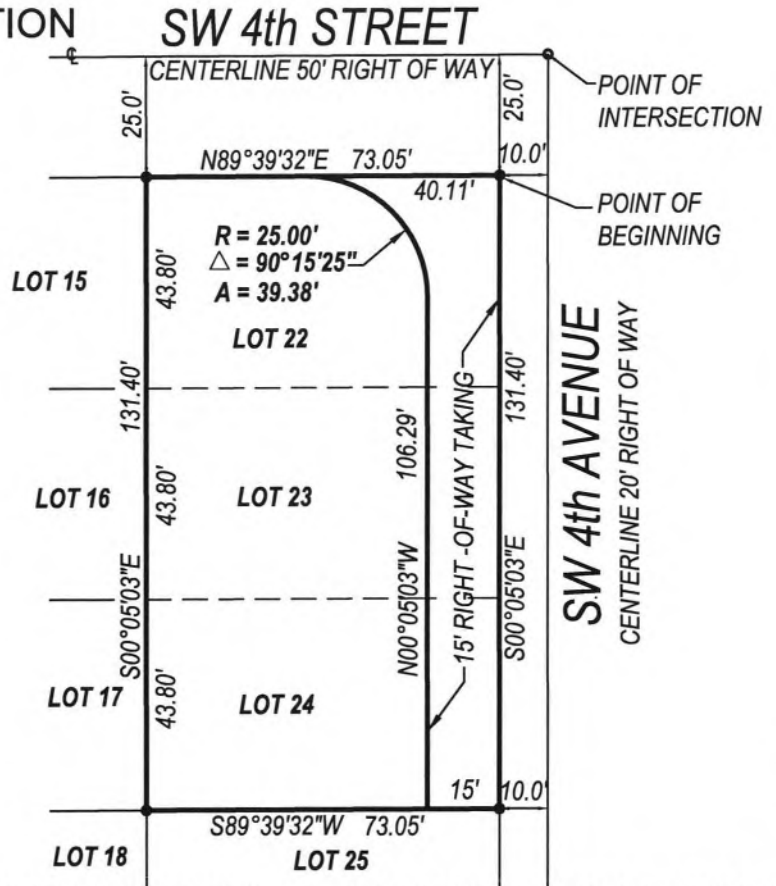

DESCRIPTION :

A PORTION OF LOTS 22, 23 AND 24, SUNDY AND TENBROOK ADDITION, ACCORDING TO THE MAP OR PLAT THEREOF AS RECORDED IN PLAT BOOK 12, PAGE 32, PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA. BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHEAST CORNER OF SAID LOT 22; THENCE PROCEED S00°05'03\"E ALONG THE EAST LINE OF SAID LOTS 22, 23 AND 24 FOR 131.40 FEET TO THE SOUTHEAST CORNER OF SAID LOT 24; THENCE PROCEED S89°39'32\"W ALONG THE SOUTH LINE OF SAID LOT 24 FOR 15.00 FEET; THENCE PROCEED N00°05'03\"W FOR 106.29 FEET TO A POINT OF CURVATURE OF A CURVE CONCAVE TO THE SOUTHWEST, HAVING A RADIUS OF 25.00 FEET; THENCE PROCEED THROUGH SAID CURVE TO THE LEFT THROUGH A CENTRAL ANGLE OF 90°15'25\" FOR 39.38 FEET TO A POINT ON THE NORTH LINE OF SAID LOT 22 SAID POINT BEING TANGENT TO THE FOLLOWING DESCRIBED COURSE; THENCE PROCEED N89°39'32\"E FOR 40.11 FEET TO THE POINT OF BEGINNING.
