The October 28, 2024, Joint Workshop With the Delray Beach Downtown Development Authority and the City Commission was called to order at 4:00 p.m. Interim City Clerk, Alexis Givings called the role, and the following were present:

Mr. Moore opened the Workshop Meeting by recognizing members of the Delray Beach Downtown Development Authority (DDA) and Gina Carter, the Director of Communications, who were present to share their ideas for rebranding opportunities for the Old School Square Campus.

Laura Simon, DDA Executive Director, called the role of the DDA members, and the following were present:

Gina Carter provided a presentation on her branding guide for the Crest Theatre's Creative Art School. She emphasized that the brand messaging aims to communicate a story to the customers that the Creative Art School is open to everyone and encourages their creativity to flourish.

Laura Simon stated based on the direction given at the August 19, 2024, Commission Meeting, the DDA was there to present their ideas for rebranding the entire Old School Square (OSS) campus. She introduced Maureen Olm, design and marketing expert with Olm Design, who provided her firm's transition design for the entire OSS campus, as commissioned

by the Delray Beach Downtown Development Authority.

Ms. Olm stated that as long as the City continues with the OSS Center for the Arts website, there would be an ongoing challenge to attract people to the OSS campus since the website does not adequately tell visitors about current programs taking place at the entire campus.

Suzanne Boyd, Director of Marketing for the Delray Beach Downtown Development Authority, discussed the primary goals of rebranding the OSS campus, which focused on re-attracting both residents and visitors while rebuilding trust and relationships. She also shared the statistics related to their marketing efforts and the positive economic impact these initiatives have had on the City. Ms. Boyd concluded her presentation by recommending the development and execution of a single cohesive rebrand logo for the entire campus, which includes the Creative Arts School and the Crest Theatre.

The Board of Directors from the DDA shared their insights on how to move forward. They recognized consistency as crucial since all venues were located on one campus.

The Commission agreed to implement a familiar themed logo while maintaining distinct identities for each campus entity, utilizing the City's agreement with the DDA. They thanked everyone for their hard work.

There being no further business to discuss, Mayor Carney adjourned the meeting at 5:35 p.m.
