

NOTICE OF CHANGE IN PERMITTED AND CONDITIONAL USE

AMENDMENT TO THE LAND DEVELOPMENT REGULATIONS CITY OF DELRAY BEACH

The City Commission of the City of Delray Beach ("City Commission") will conduct a Public Hearing on **TUESDAY, APRIL 21, 2026, at 5:00 PM** (or as soon thereafter as may be heard), in the Commission Chambers at City Hall, 100 N.W. 1st Avenue, Delray Beach, Florida 33444. At this meeting the City Commission will consider an amendment to the Land Development Regulations through the adoption of Ordinance No. 21-26 as set forth below.

The title of the enacting Ordinance is as follows:

ORDINANCE NO. 21-26

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AMENDING THE LAND DEVELOPMENT REGULATIONS OF THE CITY OF DELRAY BEACH CODE OF ORDINANCES, CHAPTER 4, "ZONING REGULATIONS," ARTICLE 4.3, "DISTRICT REGULATIONS, GENERAL PROVISIONS," SECTION 4.3.3, "SPECIFIC REQUIREMENTS FOR SPECIFIC USES," SUBSECTION (ZZZ), "TRANSIENT RESIDENTIAL USES," TO ELIMINATE PROVISIONS PREEMPTED BY THE STATE OF FLORIDA; AMENDING ARTICLE 4.4, "BASE ZONING DISTRICT," SECTION 4.4.6, "MEDIUM DENSITY RESIDENTIAL (RM) DISTRICT," SUBSECTION (B), "PRINCIPAL USES AND STRUCTURES PERMITTED," TO ALLOW TRANSIENT RESIDENTIAL USE SUBJECT TO THE PROVISIONS OF SECTION 4.3.3(ZZZ); AND AMENDING APPENDIX A, "DEFINITIONS," TO AMEND THE DEFINITION FOR "TRANSIENT RESIDENTIAL USES" TO ELIMINATE INCONSISTENCIES WITH STATE STATUTES; PROVIDING A CONFLICTS CLAUSE; A SEVERABILITY CLAUSE; AUTHORITY TO CODIFY; PROVIDING AN EFFECTIVE DATE, AND FOR OTHER PURPOSES.

THE CITY DOES NOT PROVIDE OR PREPARE SUCH RECORD PURSUANT TO F.S. 286.0105.
