Vaughn Dugan (Partner) - 6366 Pineapple Road, Boca Raton, FL. Vaughn gave a brief presentation of the mural for their new location at Subculture Coffee Restaurant. He stated that Art in all its forms is at the core of what they do. He stated not only do they want to make a diverse impact from an art and cultural standpoint, but also an economic impact for having a mural such as this in our city and he highlighted key points to what this means for our city:

- Diversity
- Tourism attraction
- Community Landmark
- Community Engagement
- Urban regeneration
- Artist support

Jen Buce (City Planner) gave a brief presentation on agenda item no. 7a - 302 NE 6<sup>th</sup> Avenue. She stated this is a consideration of murals on the Southern and Eastern facades of the Coffee Shop. She explained that each of the murals required a permit and stated that there are four separate permits even though it is a continuous mural for the proposed coffee shop. She stated Preservation and Maintenance plans have been provided, the mural does not cause any concerns for public safety and complies with the LDR laws.
