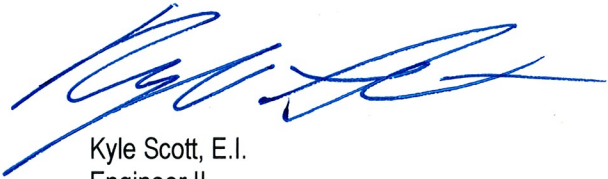
Mathews Consulting's review of the bid proposals only considered the technical evaluation of the Proposal and Bid Forms.
