

RESOLUTION NO. 127-25

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH TEN-8 FIRE & SAFETY LLC, AS AN APPROVED SOLE SOURCE, TO PURCHASE PIERCE ORIGINAL EQUIPMENT MANUFACTURER PARTS, SERVICES AND VEHICLES; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (the “City”) is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the City desires to procure Pierce Original Equipment Manufacture (“OEM”) parts, services and vehicles; and

WHEREAS, Pierce Manufacturing Inc. (“Pierce”) qualifies and designates specific dealers within different regions throughout the United States for the sale of factory-authorized parts, services and the purchase of Pierce vehicles; and

WHEREAS, in order to preserve any warranties on the construction equipment, the City must use Pierce original equipment manufacturer (“OEM”) parts, services and vehicles to maintain and service its equipment; and

WHEREAS, Pierce OEM parts, services and vehicles are provided exclusively in Florida through Ten-8 Fire & Safety, LLC (“Contractor”); and

WHEREAS, on June 10, 2025, in accordance with Section 38 of the City’s Purchasing Policies and Procedures Manual the Contractor was approved as a Sole Source pursuant to the Memorandum attached hereto and incorporated herein as Exhibit “A”; and

WHEREAS, the City desires to enter into an agreement with the Contractor, as a Sole Source, to obtain Pierce OEM parts, services and vehicles (the “Agreement”); and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are hereby affirmed and ratified.

Section 2. The City Commission of the City of Delray Beach has reviewed and hereby approves the Agreement between the City and Contractor, attached hereto and incorporated herein as Exhibit “B”.

Section 3. The City Commission authorizes the City Manager to execute any amendments thereto and take any and all actions necessary to effectuate the intent of this Resolution.

Section 4. This Resolution shall become effective immediately upon adoption.
