

RESOLUTION NO. 165-25

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH STRYKER SALES, LLC. FOR MEDICAL EQUIPMENT AND SERVICES UTILIZING EAGLE COUNTY PARAMEDIC SERVICES AND PUBLIC SAFETY ASSOCIATION, INC. REQUEST FOR BIDS NO. 2024-06; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS AND/OR RENEWALS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (the “City”) is authorized to enter into agreements to provide services and products in accordance with its Charter; and

WHEREAS, the City requires medical equipment and services for its Fire Rescue Department; and

WHEREAS, Eagle County Health Service District d/b/a Eagle County Paramedic Services administers a Cooperative Purchasing Program wherein it performs solicitations for a multitude of products and administers the resulting contracts; and

WHEREAS, contracts solicited by Eagle County Paramedic Services are accessible to state government entities and other public entities located in the United States and Canada; and

WHEREAS, Eagle County Paramedic Services issued Request for Bids No. 2024-06, on behalf of itself and the Public Safety Association, Inc. to obtain medical equipment and services; and

WHEREAS, in accordance with Request for Bids No. 2024-06, Stryker Sales, LLC (“Contractor”) was awarded a contract under said request for bids; and

WHEREAS, the City desires to obtain these medical products from Contractor utilizing existing contract prices, in accordance with Request for Bids No. 2024-06; and

WHEREAS, in accordance with Section 36 of the City’s Purchasing Policies and Procedures Manual, the City shall have the authority to join with other units of government in cooperative purchasing plans when the best interest of the City would be served; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are hereby affirmed and ratified.

Section 2. The City Commission of the City of Delray Beach has reviewed and hereby approves the Agreement between the City and Contractor, attached hereto and incorporated herein as Exhibit "A".

Section 3. The City Commission authorizes the City Manager to execute any amendments and take any actions necessary to effectuate the intent of this Resolution.

Section 4. This Resolution shall become effective immediately upon adoption.
