A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING THE ISSUANCE OF PURCHASE ORDERS TO THE PETERBILT STORE SOUTH FLORIDA, LLC; SBL FREIGHTLINER, LLC; DELAND TRUCK CENTER, INC; GLADE & GROVE OF IMMOKALEE, LLC; BOZARD FORD CO.; AMERI-RECREATIONAL SPORTS, LLC; ALAN JAY IMPORT CENTER, INC; ALAN JAY CHEVROLET-CADILLAC INC; ALAN JAY FORD LINCOLN MERCURY INC; BRIGGS INDUSTRIAL SOLUTIONS, INC: AND ENTERPRISES, LLC DBA ALTA CONSTRUCTION EQUIPMENT FLORIDA, LLC UTILIZING FLORIDA SHERIFF'S ASSOCIATION CONTRACTS NO. FSA25-VEH23.0, FSA25-VEL33.0, AND FSA23-EQU21.1, AND SOURCEWELL CONTRACTS NO. 082923-CNH, 091521-NAF, 091024-WVE, AND 011723-VCE FOR PURCHASE OF NEW VEHICLES; AUTHORIZING THE CITY MANAGER TO ISSUE THE PURCHASE ORDERS AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach ("City") is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the Florida Sheriff's Association (FSA) and Sourcewell administer cooperative purchasing programs wherein solicitations are issued for a multitude of products, and the resulting contracts are managed by FSA and Sourcewell; and

WHEREAS, the terms and conditions of the contracts awarded by FSA are extended and guaranteed to FSA members along with any unit of local government, political subdivision, or agency of the State of Florida; and

WHEREAS, contracts solicited by Sourcewell are accessible to federal, state, and municipal government entities along with other non-profit and educational entities; and

WHEREAS, the FSA issued Solicitation FSA25-VEH23.0 to obtain vendors for Heavy Trucks and Buses, FSA25-VEL33.0 for Pursuit, Administrative, & Other Vehicles; and FSA23-EQU21.1 for Equipment; and

WHEREAS, the Peterbilt Store South Florida LLC (The Pete Store), SBL Freightliner, LLC; and Deland Truck Center, Inc. are three of the vendors awarded contracts under FSA25-VEH23.0; and

WHEREAS, Bozard Ford Co. is one of the vendors awarded contracts under FSA25-VEL33.0; and

WHEREAS, Ameri-Recreational Sports, LLC is one of the vendors awarded a contract under FSA23-EQU21.1; and

WHEREAS, Sourcewell issued RFP No. 082923 to obtain vendors for AG Tractors with Related Attachments, Accessories, and Supplies; RFP No. 091521 for Automobiles, SUVs, Vans, and Light Trucks with Related Equipment and Accessories; RFP No. 091024 for Utility, Transport, Golf, and Recreation Vehicles with Related Accessories, Equipment, and Services; and RFP No. 011723 for Heavy Construction Equipment with Related Attachments and Technology; and

WHEREAS, CNH Industrial America LLC (CNH Industrial) was awarded Sourcewell Contract No. 082923-CNH under RFP No. 0832923, and Glade & Grove Supply of Immokalee, LLC is an authorized dealer of CNH Industrial; and

WHEREAS, 72 Hour LLC dba National Auto Fleet Group (NAFG) was awarded Sourcewell Contract No. 091521-NAF under RFP No. 091521 and Alan Jay Import Center Inc., Alan Jay Chevrolet-Cadillac Inc., and Alan Jay Ford Lincoln Mercury Inc. are authorized dealers of the NAFG; and

WHEREAS, Waev Inc. was awarded Sourcewell Contract No. 091024-WVE under RFP No. 091024 and Briggs Industrial Solutions, Inc. is an authorized dealer for Waev, Inc.; and

WHEREAS, Volvo Construction Equipment North America, LLC (Volvo Construction) was awarded Sourcewell Contract No. 011723-VCE under RFP No. 011723 and Alta Enterprises LLC dba Alta Construction Equipment Florida, LLC (Alta Construction) is an authorized dealer for Volvo Construction; and

WHEREAS, the City desires to issue purchase orders to The Pete Store, SBL Freightliner, and Deland Truck Center Inc. utilizing FSA25-VEH23.0 to purchase one 2026 Peterbilt Medium Duty Dump Truck, one 2026 Freightliner Medium Duty Dump Truck, one 2026 Isuzu Rear Load Compactor Refuse Truck, respectively; and

WHEREAS, the City desires to issue purchase orders to Bozard Ford Co. utilizing FSA25-VEL33.0 to purchase twenty-seven (27) 2025 Ford Police Interceptor Unit SUVs, two 2026 Ford Police Interceptor Unit SUVs, four 2026 Ford F-150 Crew Cab Pick Up Trucks, one 2026 Ford Passenger Van, two 2026 Ford Explorers, and three 2026 Ford F-150 Reg Cab Pick Up Trucks; and

WHEREAS, the City desires to issue a purchase order to Ameri-Recreational Sports, LLC utilizing FSA-23 EQU21.1 to purchase four 2026 Can Am Outlanders; and

WHEREAS, the City desires to issue a purchase order to Glade & Grove Supply of Immokalee, LLC utilizing Sourcewell Contract No. 082923-CNH to purchase one 2025 Case IH Farmhall Tractor; and

WHEREAS, the City desires to issue a purchase order to Alan Jay Import Center, Inc., Alan Jay Chevrolet-Cadillac Inc., and Alan Jay Ford Lincoln Mercury Inc. utilizing Sourcewell contract 091521-NAF for the purchase of one 2026 Toyota Camry, two 2026 Chevy Traverse SUVs, one Chevy Equinox SUV, three 2026 Chevy Trax SUVs, one 2026 Ford F-350 Reg Cab, two 2026 Ford T-250 Work Vans,

one 2026 Ford F-350 Crew Cab, one 2026 Ford F-250 Crew Cab 4WD, one 2026 Ford F-250 Reg Cab, one 2026 Ford F-250 Crew Cab 2WD, one 2026 Ford Explorer, and two Ford F-150 Reg Cab Pick Up Trucks, respectively; and

WHEREAS, the City desires to issue a purchase order to Briggs Industrial Solutions, Inc. utilizing Sourcewell Contract No. 091024-WVE to purchase one 2025 Fusion Passenger Cart and three 2025 Fusion Short Bed Carts; and

WHEREAS, the City desires to issue a purchase order to Alta Construction utilizing Sourcewell Contract No. 011723-VCE to purchase one 2026 Volvo Wheeled Excavator; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interests of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

<u>Section 1</u>. The foregoing recitals are hereby affirmed and ratified.

Section 2. The City Commission of the City of Delray Beach has reviewed and hereby approves the issuance of purchase orders to The Pete Store; SBL Freightliner, LLC; Deland Truck Center, Inc; Bozard Ford Co.; Ameri-Recreational Sports, LLC; Glade & Grove Supply of Immokalee, LLC; Alan Jay Import Center, Inc.; Alan Jay Chevrolet-Cadillac, Inc.; Alan Jay Ford Lincoln Mercury, Inc; Briggs Industrial Solutions, Inc.; and Alta Construction utilizing Florida Sheriff's Association Contracts No. FSA25-VEH23.0, FSA25-VEL33.0, and FSA23-EQU21.1 and Sourcewell Contracts No. 082923-CNH, 091521-NAF, 091024-WVE, and 011723-VCE for the purchase of 57 replacement vehicles as described in the vehicle replacements list attached hereto as Exhibit "A", and 12 new additional vehicles as provided in the new additional vehicles list attached hereto as Exhibit "B".

<u>Section 3</u>. The City Commission authorizes the City Manager to issue the purchase orders and take any and all actions necessary to effectuate the intent of this Resolution.
