AMENDMENT NO. 2 TO THE STORMWATER  
UTILITY RATE STUDY AGREEMENT

THIS AMENDMENT NO. 2 to the Stormwater Utility Rate Study Agreement dated December 14, 2021, by and between the City of Delray Beach, a municipal corporation of the State of Florida (the "City"), whose address is 100 NW 1st Avenue, Delray Beach, Florida 33444 and Black & Veatch Management Consulting, LLC, a Kansas corporation authorized to do business in the State of Florida (the "Contractor"), whose address is 11401 Lamar Avenue, Overland Park, Kansas 66211 is entered into this \_\_\_\_ day of \_\_\_\_\_, 20\_\_.

WITNESSETH:

**WHEREAS**, on December 14, 2021, the City entered into an agreement with Contractor for stormwater utility rate study services (the "Agreement"); and

**WHEREAS**, on June 19, 2023, the City and Contractor entered into Amendment No. 1 to the Agreement to include additional services and fees associated with the stormwater utility rate study as Phase 2; and

**WHEREAS**, the Contractor submitted a fee proposal for the continuation of Phase 2 services for data cleanup, updates to City policies and ordinances, and support services; and

**WHEREAS**, the parties seek to amend the Agreement to include the new scope of services and fee proposal attached hereto and incorporated herein as Exhibit "A"; and

**WHEREAS**, Contractor agrees to continue to provide services to the City in accordance with the terms and conditions of the Agreement.

**NOW, THEREFORE**, in consideration of the mutual covenants, promises, and considerations set forth in this Amendment, the receipt and sufficiency which are hereby acknowledged, the parties agree as follows:

1. The above recitals are true and correct and are incorporated herein.
2. The Agreement is hereby amended to add the new scope of services and fees in Exhibit "A", attached hereto and incorporated herein.
3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement, Amendment No. 1, and this Amendment No. 2 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.


