RESOLUTION NO. 23-16

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING THE UPGRADE OF THE INDOOR SHOOTING RANGE FROM MEGGITT TRAINING SYSTEMS, INC. FOR THE POLICE DEPARTMENT, DECLARING BY A FOUR-FIFTHS AFFIRMATIVE VOTE THAT THE CITY'S SEALED COMPETITIVE METHOD IS NOT IN THE BEST INTEREST OF THE CITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS the Police Department has an indoor range system that is utilized for officer training and qualifications; and

WHEREAS the Police Department's indoor range system consists of several components: computer with software, carrier (Target retrieval) system, track, bullet trap, and ballistic steel; and

WHEREAS the existing target retrieval system and track are more than twenty-five years old and are not rifle rated;

WHEREAS the software allows the target carriers to move, turn, and operate by commands given for qualification courses and training scenarios; and

WHEREAS, the rifle rated range is needed to efficiently run the training and qualifications of the officers; and

WHEREAS, the Police Department is looking to upgrade the existing range and not replace the entire indoor range system; and

WHEREAS, the current vendor, Meggitt Training Systems, Inc. provided a quote for the upgrade of the carrier system and track in the amount of \$85,419.27; and

WHEREAS, by upgrading the carrier system and track through the current vendor, the Police Department will be able to continue utilizing the existing software to control the carrier system; and

WHEREAS, it is more time and cost-efficient to upgrade the range instead of replacing it; and

WHEREAS, Section 36.02(c)(11) of the City's Code of Ordinances provides that the City may acquire or contract for non-real property, goods or services without utilizing a Sealed Competitive Method or the Written Quotation Method where the City Commission declares by at least a four-fifth (4/5) affirmative vote that the Sealed Competitive or the Written Quotation Method is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

- <u>Section 1</u>. That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct factual findings and are made a specific part of this Resolution.
- <u>Section 2</u>. The City Commission of the City of Delray Beach hereby declares, by a minimum four-fifths affirmative vote, that the City's Sealed Competitive Method or Written Quotations Procurement Method is not in the best interest of the City. The City Commission declares that the UPGRADE OF EXISTING INDOOR SHOOTING RANGE FROM MEGGITT TRAINING SYSTEMS, INC. FOR THE POLICE DEPARTMENT, is in the best interest of the City.
- **Section 3.** The City Manager is authorized to do all things necessary and expedient to carry out the aims of this Resolution.
 - <u>Section 4</u>: This Resolution shall take effect immediately upon adoption.
