Rafael/Mary,

Good morning. Attached is a marked-up site plan with our latest proposal.

The dumpsters and recycling bins would be rolled out to the alley by a maintenance company for pickup. There will be a slab provided (within our property boundary) for the dumpsters and recycling bins. The distance from the trash/recycling rooms to the pad in the alley is 100' feet or less. The trash compactor is connected directly to the dumpster.

To answer your question about overhead obstructions, yes, the building cantilevers over the east side of the parking area. The building area above is noted/clouded in the attachment. There will be approximately 12' of clearance to the underside of the building structure, this is why we are proposing rolling out the dumpsters/bins directly to the alley.

Our updated plan (attached) proposes a trash chute into a trash compacter for the residential units, a separate 4-yard dumpster for the commercial space, and recycling rooms for both paper and glass/plastics. The dumpsters and recycling bins would be rolled out to the alley by a maintenance company.

Good afternoon,

Some of the questions we have are:

Where/how will the garbage/recycle bins/totters be placed for collection? Will they be placed in the alley? If using recycle bins with 8 units, that would be 16 bins and 8 totters out for collection on the street.

Will the dumpsters also be rolled into the alley by the management company?

The yardage, number of dumpsters, and frequency of pickup would vary based on who occupies the space. A cafe would produce more MSW than say a bookstore or clothing store. To be safe I would say 2-4yd dumpsters going 3 times per week. Frequency/size can always be adjusted.

Hi Dominic,

There is no set calculation for trash containers. A single family residence typically uses a 96g toter. Commercial space is variable. It depends what type of businesses occupy the space so I really can't give you an exact # on what you need. WM works with businesses to determine how big of a container they need and the frequency of pickups once they are ready to open an account.

WM – do you have any suggestions on what size/how many they should start with.

As for rolling the dumpster or totes out to the alley – we allow that in certain areas. Rafael/Carlos- is that possible in this alley?

Good morning Dominic,

I'm including WM in this email so I can let you know of their concerns also.

As for the commercial space and residential sharing dumpsters, this is not done in the City because residential units are typically billed through their city water utilities bill. Businesses are billed directly by WM. They would not be able to split the bills for a shared dumpster between the commercial space and residential units.

Other concerns from WM:

- layout of the enclosures on the site plan provided - the southern one lines up to the last parking spot so the truck would have to potentially maneuver around cars
- It looks like there is covered parking before the dumpsters – what is the clearance? The trucks need to be able to get through that

WM said they can do a site visit tomorrow.

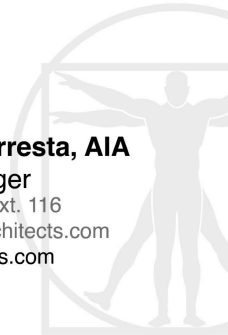

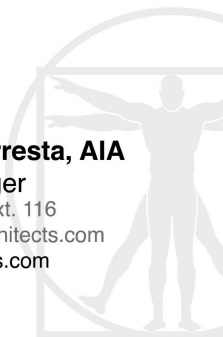
