A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH EMBARK SAFETY, LLC, FOR WEB-BASED INDIVIDUAL DRIVER RECORD CHECK SERVICES UTILIZING THE ORANGE COUNTY, FLORIDA, AGREEMENT ENTERED INTO PURSUANT TO INVITATION TO BID Y24-105; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach ("City") is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the City requires web-based individual driver record check services; and

WHEREAS, Orange County, Florida, issued Invitation to Bid ("ITB") Y24-105 to obtain web-based individual driver record check services; and

WHEREAS, in accordance with ITB Y24-105, Orange County, Florida, entered into an agreement with Embark Safety, LLC ("Contractor"); and

WHEREAS, the City desires to obtain the aforementioned services by utilizing an existing agreement with Contractor pursuant to Orange County, Florida, ITB Y24-105; and

WHEREAS, in accordance with Section 25 of the City's Purchasing Policies and Procedures Manual, Piggybacking on State, County, other municipalities, and other government entity bids is permitted within the approval thresholds of the City Manager or City Commission, as applicable in accordance with the purchasing criteria set forth herein; and

WHEREAS, the City desires to enter into an agreement with Contractor, as a Piggyback, to obtain web based individual driver record check services; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are hereby affirmed and ratified.

<u>Section 2.</u> The City Commission of the City of Delray Beach has reviewed and hereby approves the Agreement between the City and the Contractor, attached hereto and incorporated herein as Exhibit "A".
