## 6. PRESENTATIONS

### Children Services Council Introduction - Katherine Diaz, Children Services Council of Palm Beach County

**Katherine Diaz** introduced the Children Services Council of Palm Beach County (CSCPBC) resources available in Delray Beach. She indicated CSC supports Back to School PBS at Village Academy, outreach initiatives at the Spady Museum and the EJS Project in Delray Beach.

**Katherine** provided an overview of CSCPBC, including that there are thirteen Children Services Councils in Florida. CSCPBC plans, funds, evaluates, and promotes public policy for Palm Beach children and families with a focus on prevention and early intervention services. CSCPBC is a part of the Healthy start Coalition and has developed a system that provides services to families in need through two entry agencies: Healthy Mothers, Healthy Babies and Home Safe. The CSCPBC has four goals: all children are born healthy, safe from neglect, ready to start Kindergarten, and have access to quality after school and childcare.

The CSC is funded through ad valorem and property taxes. 88% of funding supports programming aligned to the goals. including 736 local organizations. This includes summer camps, afterschool programs, early childcare programs, and S.T.E.A.M. programming. Funds are awarded through a competitive bidding process.

**Katherine** discussed past and present funding opportunities including Healthy Safe and Strong funds and Community Driven Initiatives funds. The Healthy Safe and Strong funds are intended for promotional and outreach events for nonprofits while the Community Driven Initiatives funds are allocated to organizations that demonstrate innovation in the areas of family health and wellness. CSCPBC funds organizations committed to reducing rates of infant mortality, low birth weight, preterm birth, maternal morbidity and addressing health disparities. Katherine indicated that funding opportunities are advertised on the main website at cscpbc.org.

**Katherine** provided 2023 Delray Beach data and spend footprint for CSCPBC. CSCPBC has spent 2.8 million and served 1,772 families in Delray Beach through various family, afterschool, and early education initiatives. She also indicated over 3,000 scholarships are available for summer camp scholarships through the County Parks and Recreation division.

**The Board** discussed future opportunities for CSCPBC to collaborate with the City of Delray Beach for additional family resources, services, and funding.
