FIRST AMENDMENT TO THE FUNDING AGREEMENT FOR THE FISCAL YEAR 2019-2020 BETWEEN

THIS FIRST AMENDMENT TO THE FUNDING AGREEMENT FOR THE F	ISCAL
YEAR 2019-2020 ("FIRST AMENDMENT") is made this	day of
, 2020, by and between the DELRAY BEACH HISTORICAL SOCIETY, I	NC., a
Florida not for profit corporation, (hereinafter referred to as the "Historical Society	′"), and
the DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY, a public	body
corporate and politic, duly created and operated pursuant to Chapter 163, Florida S	tatutes
(hereinafter referred to as the "CRA").	

WITNESSETH:

WHEREAS, the CRA and the Historical Society entered into a Funding Agreement for the Fiscal Year 2019-2020, on October 1, 2019 (the "Original Agreement"); and

WHEREAS, the CRA and the Historical Society desire to amend the funding amount provided in Section 3 of the Original Agreement; and

WHEREAS, the CRA finds that this First Amendment serves a municipal and public purpose, is consistent with the CRA's Redevelopment Plan, and conforms with the requirements of Florida law; and

NOW, THEREFORE, in consideration of the mutual covenants and promises herein contained, the parties hereby agree as follows:

- 1. The recitations set forth above are hereby incorporated herein.
- 2. The **CRA** and the **Historical Society** agree to amend Section 3 of the Original Agreement as follows:
 - (3) The **CRA** is providing total funding to the **HISTORICAL SOCIETY** for fiscal year 2019-20 in an amount not to exceed One Hundred Twenty-Five Thousand and 00/100 Dollars (\$125,000.00) (the "Funding Amount"). The funds are to be used by the **HISTORICAL SOCIETY** to support its organizational operations, and for the purpose of providing community and cultural programs in conformance with the programs/projects within the CRA district specified in the A-GUIDE documents. Quarterly payments in an amount not to exceed Thirty One Thousand Two Hundred Fifty and 00/100 Dollars (\$31,250.00) shall be made by the **CRA** to the **HISTORICAL SOCIETY**. Two payments of Eighteen Thousand Seven Hundred Fifty and 00/100 Dollars (\$18,750.00) have been made by the **CRA** to the **Historical Society** for quarters 1 & 2. Upon execution of this First Amendment, the **CRA** shall pay to the **HISTORICAL SOCIETY** the sum of Twenty Five Thousand and 00/100 Dollars (\$25,000.00) for the complete payment of quarters

- 1 & 2. For each of quarters 3 & 4, the **CRA** shall pay the **HISTORICAL SOCIETY** an amount not to exceed Thirty One Thousand Two Hundred Fifty and 00/100 Dollars (\$31,250.00). The **CRA** has the right to withhold the quarterly payment until receipt of all documentation and additional information from the **HISTORICAL SOCIETY** that the **CRA** deems necessary to analyze the **HISTORICAL SOCIETY's** financial position.
- 3. All other terms and conditions of the Original Agreement not in conflict with this First Amendment shall remain in full force and effect.
